THE following Inventories, for the Hundred of Binfield, are taken from the returns of the Commissioners appointed for that purpose 6 Ed. VI. among the Miscellanea Exchequer Q.R.

CAVERSHAM.

Inprimis one chalys of sylver and gylt w^t a patyn ; Item a pyx of brasse ; Item one crosse of copper and gylt ; Item one vestment of red velvat ; Item one cope of crymson velvat ; Item one vestment of whyt sylke ; Item one vestment of grene sattyn ; Item one cope of grene caddys* ; Item another old one of whyt and redd sylke, with vestments belonging unto them ; Item iiij alter clothes ; Item iiij towells ; Item one hangyng for thalter ; Item ij surplysys ; Item ij great candylstycks of brasse ; Item one canstyck of pueter ; Item ij holy water pottes ; Item iiij belles [Item Nycholas Whyt dyd owe unto the church of Cavesham xv^t iiij^d. ye w^{ch} we have not receyved as yet]. †

ROTHERFIELD PEPPARD.

Inprimis a chalice of sylver parcell gilt ; Itm thre belles in the steple ; Itm ij smalle candylsticks of laten ‡ ; Itm ij vestments thone of whyt damaske and another of rede damaske ; Itm ij corse awter clothes.

A remembrans yt my lady Stonor sins ye deathe of S^r Walter Stonor hyr husbond, toke away another great chalyce, about ye value of ten poundes, into her own keaping and hath not delyvered it again.

ffirst in the vestry ij chalycys with patentes of sylver, one of them duple gylte, conteynyng in wayght xxxij ounces ; Item a cope of cloth of gold grounded w^t grene ; Item a sute of vestment of black velvat braynshyd with goold ; Item iij copes of cloth of gold ; Itm a cope of crymson velvat and a vestment of the same ; Item a cope of whyte damaske, prist and deacon of the same ; Itm a vestment of blew velvatt ; Itm a vestment of purple velvatt ; Itm a sute of vestments of black damaske ; Item a common* cupp new bought of sylver, double gilt, weying Lj ounces bought wth part of the church goods of the old Inventory that is sold ; Item iij other vestments for the weke days, one whyte, another red, the thyrd grene ; Itm a cope of blew and grene bawdkyn† ; Itm xij albes good and badd ; Itm in the steple, ffyve great belles and a sanctus bell.

A remembrans that the residue of the old Inventory is sold and bestowed in Reparation of the Church and the bridge there, as it is aunswered by the othes of the parties above written.
