# Manor of Estoverton and Fyfield

# By Dr. Chris Grocock

Judicial inquiry held in the same place on Wednesday 23rd April in the ninth year of the reign of Elizabeth queen of England, France and Scotland, Defender of the Faith, etc., in the presence of Charles Vaughan & Robert Grove, gentlemen, aforewritten commissioners to inspect the copies of written indentures and to examine the customary tenants who have sworn title and who have said and made recognition on oath as is set out below, viz.:

## Freehold tenants in Fyfield

The Heirs of Christopher Dysmers, gentleman, have the freehold after the death of Jane Dysmers of certain lands and tenements in Fyfield in the aforesaid free soccage, together with 12 shillings a year for pannage, that is their principal messuage and three copses of land with associated properties, of which 44 acres in Northfield, five acres in Southfield, six acres in Roylands, three enclosures containing five acres held in severalty, up to 300 sheep in common rights with their tenants, and also a smithy with one paddock attached; total per year twenty shillings

### **Customary Tenants in Fyfield**

John Bushell holds according to the copy made on the last day of April of the 30th year of Henry VIII against the amount of £4 one messuage and one and a half virgates of land with associated properties of which four enclosures containing two and a half acres are held in severalty, and of arable land 30 acres in Northfield, six acres in Southfield, one acre in Ryland, and common rights for up to 150 sheep and numerous cattle; he is to perform three boon-works at harvest for the lord of Overton and he will heriot his best beast and fifteen pence, and pay rent per year 19s 4d

**Matthew Studley** and his brother John hold according to the copy made in the fourth and fifth years of Philip and Mary on May 2nd against the amount of £30 one messuage and one and a half virgates of land and certain lands of Bourdland with associated properties, of which one paddock containing one rood is held in severalty, and of arable land twenty-nine acres, one acre in Southfield, two acres in Ryeland, common rights for up to 150 sheep and cattle without limit and he shall perform three boon-works at harvest as before, and they will heriot their best beast and fifteen pence for half a virgate

**John Bond** and Richard his son hold according to the copy made on 14th October in the 34th year of the reign of King Henry VIII against the amount of 14s 4d a messuage and a virgate of land and a cottage with associated properties, of which 2 enclosures containing one rood are held in severalty, and of arable land 15 acres in Northfield, five acres in Southfield, one acre in Ryelands, common rights land for up to one hundred sheep and cattle without limit, and they will heriot their best animal and pay rent of 12s.

Alice Dymer, widow, holds so long as she is a widow and with reversion at such time granted to John the Elder and John the Younger, her sons, against the amount of £30, one messuage and two virgates of land and four acres of land of Bourdland with associated properties, of which one acre of meadow lies along the Waylands called Stanley, two paddocks containing one rood and of arable land 34 acres in Northfield, eight acres in Southfield, one acre in Ryelands, common rights for up to two hundred sheep and cattle without limit, and she shall perform three boon-works as harvest-rent of Estoverton, and will heriot her two best animals and pay rent of

Andrew Dymer and John Lovelow hold according to the copy made on 17th June in the first year of the reign of Queen Elizabeth against the amount of £33 one messuage, one and a half virgates of land with associated properties, of which one enclosure called Mylhayes containing one rood is held in severalty, and two paddocks are held in common rights, and of arable land 27½ acres in Northfield, seven acres in Southfield, one acre in Ryeland, common rights for up to 150 sheep and cattle without limit, and he shall make no customary payments as rent, he will heriot his best animal and pay fifteen pence, and rent per year 16s.

Elizabeth Streche, widow, with reversion granted to Richard and Mary her children on 17th June in the first year of Queen Elizabeth against the amount of £15 one messuage and one-and-a-half virgates of land called Temple Hays, of her native land a toft (house-site) of one messuage and half a virgate of land called Puthay and a cottage with curtilage containing three roods of land called Paynters Croft, and ten acres of Bourdeland with associated properties, of which 32 acres in Northfield, one and -a-half acres in Southfield, four acres in Ryeland, one sheep enclosure adjacent to the house and another enclosure called Templehays containing half an acre, common rights for up to 100 sheep and she shall perform two boon-works at harvest and will heriot 2s 6d and rent

John Dymer holds according to the copy made 16th October in the 22nd year of Henry VIII against the value of 20s one messuage and one virgate of land with associated properties, of which there are 17½ acres and one rood in Northfield, five acres in Southfield, two acres in Ryeland and half an acre of meadow in Clyffield, two enclosures containing half an acre of meadow held in severalty, common rights for up to 100 sheep and cattle without limit and

he shall perform three boon-works and will heriot his best animal and rent per year 10s.

# **Customary tenants in Estoverton**

John Benger by right of Joanna his recent wife, daughter of Andrew Pears, holds according to the copy made 19th October in the first and second years of Philip and Mary against the amount of £22 two messuages, one virgate and two half-virgates of land and ten acres of land with associated properties, of which arable lands are 27½ acres in Southfield, 29 acres in Eastfield, 13 acres and one rood in Northfield, one enclosure called Uphouseclose containing half an acre, one enclosure called Overhouseclose containing one rood, two other enclosures containing half an acre, and half an acre of meadow; common rights for up to 200 sheep, eleven draught animals and six pack animals and he shall perform six boon-works at harvest, and heriot his best animal and 2s 6d and rent of

William Godwyn and John son of Philip Godwyn hold according to the copy made 14th April in the 3rd year of Queen Elizabeth against the value of £14 6s 8d one messuage and one virgate of land and two half-virgates of land of which 18½ acres are in Southfield, 14 acres in Eastfield, ten acres and one rood in Northfield, one acre of meadow in two parcels, an enclosure called Cokkes Close containing one rood, an enclosure called The Lane Close containing one rood, pasture for 160 sheep, nine draught animals and 6 pack-animals and they will perform as rent three boon-works, will heriot their best animal and money-rent for the aforesaid two half-virgates of land 2s 6d, and rent 20s

Robert Popejoye holds for his lifetime according to the copy made 20th October in the 28th year of the reign of King Henry VIII against the value of 53s 4d, with reversion thence to Thomas and Robert his sons according to the copy made 14th April in the third year of Queen Elizabeth against the amount of £34, one messuage and one virgate of land and the toft of one messuage and half a virgate of land, and a messuage and half a virgate of land with associated properties of which 12½ acres are in Southfield, 5 acres in Baresfield, 18 acres in Eastfield, 19 acres in Northfield, an enclosure called Deansclose containing three acres, an enclosure called Willsclose containing one rood, half an acre in Broodemead, common rights for up to 160 sheep, 9 draught animals and 6 pack-animals, and he will only one boon-work, because his greatest custom-rest is at harvest, will heriot his best animal and 2s 6d in money, and rent of

Thomas Webbe and Katherine his daughter hold according to the copy made 21st March in the second year of Queen Elizabeth against the amount of £20 one messuage and one and a half virgates of land with associated properties, of which 12 acres are in Southfield, 18½ acres in Eastfield, 8 acres in Northfield, 2½ acres in Broodmead, two plots containing one rood, one 'pleck' of meadow lying in Horsemead containing half an acre, one enclosure held in severalty called Laneclose containing one rood, another enclosure containing half an acre and an enclosure adjacent to the Tenement containing one rood, common rights for up to 120 sheep, seven draught animals and five pack animals and he will heriot his best animal and 15d in money, and rent of 18s

**Edith wife** of Andrew Flynte holds according to the record made 24th September in the 38th year of the reign of King Henry VIII against the amount of 6s 8d, with reversion then granted to Andrew Flynte and Thomas Newman on the 30th March in the fifth year of Queen Elizabeth against the amount of 100s, one messuage and half a virgate of land with associated properties of which 2 acres are in Southfield, 4 acres in Eastfield, 6½ acres in Northfield, common rights for up to 40 sheep, 3 draught animals, 2 pack animals, and he shall perform one boon-work and a heriot of 15d and rent 5s

**Alice wife** of Bartholomew Malome holds according to the copy made on the last day of April in the thirtieth year of the reign of King Henry VIII against the

amount of 40s and reversion thence granted to John and Roger sons of the said Bartholomew on 30th March in the fifth year of our Queen Elizabeth against the amount of £43 6s 8d, one messuage, one virgate of land and the toft of one messuage and half a virgate of land with associated properties, of arable land 15 acres in Eastfield, 12½ acres in Southfield, 8 acres in Northfield and 3 roods of meadow held in common and 1 plot in the Broodemead, one enclosure held in severalty adjacent to the house containing 3 roods, common rights for up to 120 sheep, 8 draught animals and 5 pack animals, and she shall perform 3 boon-works for rent and heriot her best animal and 15d in money, and rent of 15s

William Smith holds according to the copy made 21st April in the 27th year of the reign of King Henry VIII with reversion then to Richard Smith according to the copy made 14th April in the third year of Queen Elizabeth against the amount of £10 one messuage and half a virgate of land and the toft of one messuage and half a virgate of land with associated properties of which 4 acres are in Southfield, 18 acres and 1 rood in Eastfield, in severalty in the eastern part of the said farm one rood and one rood of meadow lying in Lockridge, and in the commons 3½ acres, half an acre in Broodemead, common rights for up to 80 sheep, 5 draught-animals and 4 pack-animals and he shall perform one boon-work at harvest and will heriot 2s 6d and rent of 10s

Thomas Andrews and John his son hold according to the copy made 17th June in the first year of Queen Elizabeth against the amount of 53s 4d one cottage with associated properties of which 3½ acres are in Southfield, 3½ acres in Northfield, common rights for one draught-animal and will pay rent of 4s 6d

**William Bromesdon** and Thomas his son hold according to the copy made 25th March in the second and third years of Philip and Mary against the amount of 41s one cottage with associated properties with no rights, and pay rent of 2s

William Smith and Thomas his brother hold according to the copy made 21st March in the fifth year of Queen Elizabeth against the amount of 20s one messuage, one and a half virgates of land with associated properties called Lilornes, of which 17½ acres are in Southfield, 11 acres 3 roods in Eastfield, 7 acres in Northfield, and one acre of meadow lying at Sheldford, one acre of

meadow in Broodemead, an enclosure called Lylbornes containing one rood and in severalty one rood, common rights for up to 120 sheep 7 draught and 4 pack animals, and will perform 3 boon-works at harvest, and will heriot their best animal and for the aforesaid half virgate of land 15d in money, and rent of 18s 6d

**Thomas Gooderde** and Walter his brother hold according to the copy made 5th April in the 36th year of the reign of King Henry VIII against the amount of 6s 8d one messuage and one cottage called Mawdyes with associated properties, of which 5 acres in Eastfield, 7 acres and half an acre held in severalty in Northfield, common rights of up to 3 draught animals, 2 pack animals and 40 sheep, and rent of

The same Thomas and Walter hold according to the copy made the same day and year one cottage with associated properties of which there are 2 curtilages, 3 roods held in severalty, and in the northern part 2 acres of arable, common rights for 2 draught animals, and rent of 3s

# **Conventionary tenants in East Overton**

Richard Kingsmill, squire, holds according to the indenture made 14th February in the sixth year of the reign of King Edward VI the whole site of the manor of Estoverton in the County of Wilts, and all structures and houses now standing and existing in and upon the said site, together with all demesne lands, meadows, grazing-lands, pastures and common pastures, hay meadows, roads and ditches belonging to the manor of standing on or appertaining to the lands of the said manor with each and every item belonging to them, late in the tenure and occupation of **Thomas Wroughton**, gentleman, and all the dues of all the customary tenants not let beforehand And also the benefice of Rector of the aforesaid Estoverton with all its glebe lands, fruits, oblations, emoluments and benefits belonging to or appertaining to that rectorship in as great a state and form as Thomas Godard previously held and occupied on the same condition, Save that the right of patronage and of advowson of the vicar of the aforementioned Estoverton be in all ways reserved to the Lord, his heirs and assignees, likewise the appointment to that position as often as it shall fall vacant during the present time. And the Lord grants, allows and hands over without let by these present three acres of meadow which lie and exist in Pateney in the County of Wiltes in the aforementioned meadow there called Broodemead and four acres of meadow in the aforesaid Pateney, in a certain meadow there called Westmead, the aforementioned site of the Manor of Estoverton and the aforementioned demesne lands and the rectory, glebe lands and other premises with each and every property appertaining to them to be held and kept by Alice his wife, late wife of Thomas Wroughton, deceased, from the last feast of St Michael the Archangel before the data of the said indenture until the completion and fulfilment of seventy years, if the same Alice and the eldest

son legitimately born to the said Thomas Wroughton and the said Alice or another of them shall live this long, At a rent thenceforth every year to be paid to the Lord and his heirs for as long as the agreement is in force of £33 14s 11d, in good legal English tender, payable twice in the year, that is at the feast of the Annunciation of the blessed Virgin Mary and St Michael the Archangel equally: and the Lord grants through the aforesaid indenture that the said Alice and her assignees shall have for the duration of their lives a sufficiency of timber for building, for hedging, for fire, and for ploughs in the wood belonging to the Lord and also in the view and free gift of the officers and heirs of the Lord or his assignees, 25s 8d shall be granted annually in money on their behalf for the election. . . of them for as long as the agreement shall be in force with divers other clauses, conventions, conditions and articles set out in the said indenture as may be clearly seen verbatim in the Register. And are apportioned to them of arable land viz. in the Forehill fourscore and 18 acres and in Whithill 30 acres, and of sheeppasture viz. in Lyphams 120 acres, one pasture called Dyllinge 31 acres, an enclosure called Roddons close containing 25 acres, an enclosure called Pickedean, 12 acres, a meadow called Northmead, 5 acres, a pasture called. .. with its tenants and in Broodemead 5 acres, and in Pittneymead seven acres, in the fields of Fyfield 108 acres and a meadow called ....mead containing 3 acres .... croft on the above 600 ewes and 800 wethers, and also belong to the aforesaid rectory all tithes of corn of Estoverton and Westoverton Shaw and Fyfield ... demesne land of Westoverton and has the sure name of . . . and not . . . £33 14s 11d

The same Richard Kingsmill, squire, holds by the indenture made 12th August in the 31st year of the reign of King Henry VIII a messuage and a virgate of land once belonging to Ralph Smith, and the toft of a messuage and a virgate of land called 'by Dean' (or 'by the Dean') and a messuage and a virgate of land called Hillhouse, with all associated properties, in such full form and manner as Robert Stevens lately held it or any other held it or occupied it before, save that the following are reserved for the Lord and his heirs: waivery<sup>3</sup>, the taking of animals from stock, the goods and chattels of felonious persons and other benefits and suits pertaining to the decision of courts regarding franc-pledge, viz. in money, pannage and fixed rents, to have and to hold from the feast of Saint Michael the Archangel next after the date of this indenture until the end and completion of 65 years next following from this, at a rent then payable annually to the Lord and to his heirs in two instalments per year, viz. at the feast of Easter and St Michael the Archangel equally, the rent also to be rendered and paid up on the death or departure of any tenant which may happen during the stated time of 26s 8d in fixed rents and 20s as heriot, with various other clauses, conventions, conditions, and

articles in the said indenture as may be clearly seen verbatim in the Register. **And are apportioned to them** three virgates of land, or arable land 13 acres in Southfield, 33 acres in Eastfield, 3 acres in Northfield, 11½ acres in Conyesfield, an acre of meadow in Wayland, 3 roods in Horsemead, an enclosure held in severalty called Deans Close containing 2 acres, an enclosure called Westclose containing one acre, an enclosure called Houseclose containing one acre, an enclosure called Hillclose containing half an acre, common rights for up to 240 sheep, 12 draught animals and a bull, and 6 pack-animals<sup>4</sup>, and a rent per year

#### **Fixed rents**

The tenants of Estoverton pay an annual rent by common agreement, viz. at Easter 4s, and at Michaelmas 4s, for collection of the tithe 8s

The tenants of Fyfield similarly pay an annual rent by common agreement, at Easter 2s and at Michaelmas 2s, for collection of the tithe there 4s

# Pannage and tallage

**The tenants** of Estoverton pay an annual rent for pannage and tallage at Michaelmas only,

# Payment of church-scot

**William Streche** pays an annual rent for his church0scot, viz. 3 bushels of corn at a general price of 22d, and a cock and a hen, whose price is 2d each 2s 2d

**William Stephens** pays an annual rent for his church-scot of 3 bushels of wheat which has such value as it can fetch in the market in any year 3 bushels wheat of value 3s

**Thomas Apjean** alias Johnson, clerk, aged 70 years, present vicar of the benefice of Overton holds his benefice by the patronage of the Lord, and is worth per year £18 in a year of full value<sup>6</sup>, and the following belong to the aforesaid benefice: 3 virgates of land, of which ten acres lie in Southfield, 13½ acres in Eastfield, 17 acres and a plot in Northfield, and other lands in the fields of Fyfield, viz. 15 acres in Northfield, and 3 acres in Ryelands, and he shall have grazing with fixed rents for 100 sheep at Hackpen, and common

rights for up to 12 draught animals, one bull and 2 pack animals with the cattle of the tenants in Estoverton, and shall receive every year as a pension from the Lord from the revenues of his Rectory 38s 9d, and shall have no tithes from the fixed revenues of the Lord for wool, hay, lambs or any other thing, and shall pay rent to the Lord every year nothing

There is also relative to the tithe of Estoverton in the northern part a common hill called Hackpen Down, which hill is reckoned at a fixed rent, the tenants holding it for their draught animals from the feast of the Annunciation of the Blessed Virgin Mary until the feast of the Apostle Thomas, and then shall remain for the farmer until the next feast of the Annunciation; however the farmer shall make use of it at the Martinmas with 106 sheep and it contains, at an estimate, four score acres

There is there another hill called Rodden Cowdown which the fixed-rent renter and the tenants hold from Hockday<sup>7</sup> to Michaelmas with their draught animals, and on the said Michaelmas day it shall revert to the fixed rent renter; additionally, as soon as the wheat of one part in the northern field is removed at harvest, the said tenants will enter it with their cattle and draught animals, and will graze down both meadow and stubble until the feast of St Denis. They will then transfer them to Hackpen Hill and the field will revert to the fixed renter; and the said hill of Rodden contains, at an estimate, 60 acres.

**There is also there** a common pasture called Priors Ball, Full Ridge and Hurseley, which is available to the tenants all year round and contains at an estimate 100 acres

**And a hill** called Brode Down containing at an estimate 34 acres, and a hill called Little Down containing at an estimate 8 acres, which pertains to the tenants for their sheep and contains in total 42 acres

And a small area of land called Stonydean containing 2 acres and a small area of land containing two acres called Horsemead and the whole droveroad leading to Westclose pertain to the tenants and contain at an estimate 3 acres

**And it should be noted** what the said tenants shall share common pasture in the western part of Baresfield and from Old Berye as far as Stony Dean and in Connyfield.

**And the said tenants** shall present that which is listed under 'Estoverton', and use two common springs called Common Wells which are for the use of the inhabitants.

And there is situate in Estoverton a coppice called Little Wood, planted with

small oaks and hazel, aged 12 years, and it contains at an estimate acres

And a coppice called Wolles Grove, similarly planted with small oaks and hazel, aged 6 years, and it contains at an estimate 40 acres

**And it should be known** that it is the custom that any tenant who does boonwork at harvest as part of his fixed dues should provide his own breakfast, and afterwards shall have drink at the farmer's expense, a penny loaf, and as much food as can be bought for a penny.

# **Fyfield**

**There is also** a Sheepdown on Hackpen called North Down, beginning at Monkton's Down beside<sup>8</sup> the peak of Balmere, proceeding to Lollingthorne, thence to Rudge Bank, and then descending to Bury Way via Mapple Dyrley, and from there as far as Stanchslede by established paths between Clatford and Fyfield. It contains at an estimate

130 acres

**The bounds** in the North-East part of the said hill begin at Balmere Pyke, then to Balmers Pond at Temple Hookes, and then along the ditch at Clatfords Down, then beside the corner of Roddon Cowslease, then through (*or* by) Roddon Coppice gate (?) and hedge by Cattborough, by Roddon Somerdown to Stachslade, by established paths between Clatford and Fyfield.

**Afterwards** we enter the north field from the said hill, and thus between Fyfield and Clatford by established tracks to London Way opposite Myles Close, and Master Kingsmill, now farmer of Overton, has 108 acres there and the vicar has 15 acres, for mowing only, and the said field contains at an estimate 364 acres

The bounds to the south-eastern part of the said hill and its fields, viz. Rowdon, Dyllinge, Lockridge Down, and thus by the Corner of Cleve End to a piece of land belonging to Estoverton farm, the pasturage of which is a parcel of land of the northern field of the tenants, and then are well known between Lockridge and Fyfield along London Way, and so to the croft of Jane Dysmers, gentlewoman and freehold tenant.

**There is also** a meadow called Berrymead, from which the first cut<sup>9</sup> belongs to the farm of Estoverton, and reverts to the tenants after the feast of St Peter in Chains, and it contains

There is also a hill called Atlee's Down, containing at an estimate fourscore acres, and an area called Sheeproode containing at an estimate 14 acres. Between this area and the said hill is an enclosure called Atlee's close, belonging to the farm of Estoverton, containing one acre, surrounded by a hedge. **The bounds** and meres<sup>10</sup> between Clatford and Fyfield, that is in the eastern part from Nayle gate at Clatford by Ryell Hedge, and from the corner of Ryell to a stone under the hedge, descending to beside the bottom where there is another stone, by a bank and then by the yew-tree<sup>11</sup> pastures along the side of the hill as far as the ditch below Clatford Wood, and from there as far as Sadell Stone between Fyfield Wood and Clatford.

**The bounds and meres** between Fyfield and Lockridge, that is from Rayland hedge by an enclosure called Goores, presently held by Henry Rainger, Lockridge Breach and Housestead, belonging to the tithe of Lockridge in the western part

The Drove-Roads between Clatford Wood and Fyfield Wood for the cattle of the tenants run from Saddlestone as far as Haywards Thorn at Oxehams Ley and then beyond Wansdyke beside Heath; their routes from there are not known

The Drove-Roads for the tenants of Fyfield for their sheep in the western part of Fyfield Wood runs from Sheeproode by Atleys Close, mentioned above, as far as the side of Great Sherd Wood of Fyfield at the back of Atley, and then over Holowey by Priest's Green as far as the well-known Mere Oak between Fyfield and Fortesbury, Bariscourt, Groves and Hardings once called Bengers, and then from the aforesaid Mere Oak over Hendley up to the Wansdyke, and so on to beside the said Heath.

**Note** that there is there a small grove containing one acre called Priest's Grove which belongs to the vicar of Overton

It should be noted that there is there a hill lying in the northern part of the stream called Westoverton Cowdown, abutting on Kennett on one side, and the meadow and field of Overeton and next to Hackpen Down on the other side, containing at an estimate 100 acres, of which half is allocated as follows: that part which is called Goores lies fallow from the feast of the Annunciation of Mary until the feast of Pentecost; the part between the road which leads to Deviez as far as London Way lies fallow between the feasts of Easter and Pentecost, while the other part of the said hill lies fallow from Hockday until the said feast of Pentecost, and at the said feast the Lord's farmer and his tenants shall enter it with their plough-animals and will have common rights on it until Martinmas, and it shall then be reserved for the farmer for his sheep until the feast of the Annunciation of Mary.
