The publication of this volume has necessarily entailed on the executive a considerable amount of labour, and whilst the thanks of the Council are due to the several contributors of papers, they must not omit to mention J. J. Howard, Esq., LL.D., and the Honorary Secretary, on whom the task of collecting and arranging the materials has principally devolved, and to whose assiduity the early appearance of the volume may be attributed.

The financial position of the Society is also in a satisfactory state, and although the number of members has slightly decreased, it is explained by the fact that the list has been most rigorously examined, and the names of many expunged who have failed to pay their subscriptions for several years.

The Council also gratefully acknowledge the liberality of Granville Leveson-Gower, Esq., M.P., A. Heales, Esq., and J. R. Daniel-Tyssen, Esq., in defraying the expense of the illustrations at their own cost; whilst the private contributions of other members of the Society have nearly accomplished the rest without intrenching upon the funds of the Society.
