THIS CONVEYANCE AND DEED OF GRANT is made the Sixth  
day of June One thousand nine hundred and  
eighty eight BETWEEN ROBERT DEMPSTER PRETTY of Portmore  
Farm Jordans, ~~lane~~ Boldre Lymington in the County of  
Hampshire and LT. DAVID PRETTY R.N. c/o Portmore Farm  
aforesaid (hereinafter called "the Grantors") of the one  
part and THE SUTTON HOO RESEARCH TRUST whose registered  
office is at The Society of Antiquaries Piccadilly  
London (hereinafter called "the Trust") of the other part  
WHEREAS this deed is supplemental to a Deed of Retirement  
and Appointment dated the 19th day of January 1987 and  
made between Sir Walter Robert Dempster Perkins of the one  
part and the Grantors of the other part and to the  
Conveyance therein referred to and dated the 22nd day of  
December 1950 and hereinafter called "the Conveyance" ----  
NOW THIS DEED WITNESSETH as follows:-

1. THE Grantors hereby grant and conveys to the trust  
ALL THAT the exclusive right to search and excavate the  
site of the Tumuli at Sutton Hoo in the County of Suffolk  
within the area shown coloured red on the plan attached to  
the Conveyance and to remove and retain such articles (if  
any) as may be discovered and for such purpose a right of  
way between the points marked "C" and "D" on the said plan  
attached to the Conveyance and thereon coloured blue TO  
HOLD such rights unto the Trust in fee simple -----
2. THE Trust hereby covenants with the Grantors that it  
will as soon as in the particular circumstances may be  
practicable deliver up to appropriate officers of the  
British Museum as the absolute property of the British
