## Deeds relating to Potterspury

Michael Tony gives to John son of John Geoffrey a moiety of Potterspury except the enclosed park, that is, the great assart enclosed within the hedge below the park containing 66 acres of arable, and all his meadow in *le Holm* and at *Dowestokyng* (or *Ramies stockyng*) containing 11 acres of meadow, and all his garden with the fishpond in it below the cemetery of the vill of Potterspury, and all his foreign wood outside the park. He also grants to John son of John the rents and services of his free and villein tenants: Ivo Gobion 1s 8d; Geoffrey de Blacwell 2s; John le Taylor 3s; William Molendinar 3s; Robert Alderman 11d; the heir of William Lambart 2d; Walter de Forho 2 capons or 4d; his villeins Reginald son of Anselm, William del Stockyng, Roger le Sureys, William Hicheman, Sarah de la More and Thomas de Horewell. John paid 200 marks.

Michael Tony gives to John son of John Geoffrey 2 virgates of land and 1 acre of meadow of demesne in Potterspury, of which a piece containing 14 acres 1 rood lies on Gobiuneshull' between the land of Ivo Gobyun on one side and the land of Richard Doget on the other; another piece containing 131/2 acres lies on Cattesbrayn between the land of Ivo and the said John; a third piece containing 20 acres 1 rood lies in Parva Stockyng beside the moor between the way which extends to Yardley towards the wood of the said John on one side and Michael's land on the other; the acre of meadow lies in le Holm between Michael's meadow and the meadow of the said John, and abuts at one end on the old fishpond towards Hanslope and at the other end on John's meadow. He also grants to John the rents of free and villein tenants: from the heirs of James de Widevile £1 annual rent for the hundred of Cleley which he held of him; from the heirs of Henry de Bervile 18s annual rent and 6 poultry for the tenement held of him; from the heirs of the same Henry 6d for the same tenement; from John de Mers 15s and 1 lb. pepper; from Peter de Cheyne 15s, Roger de la More 2s, Thomas Illing 16s, Walter Aunsell 11s 6d, the heirs of John Strody 8s 91/2d, the heirs of Elias Wlfrich 7s, Agnes Bunchetot 16d, Alan le Em 3s, the heirs of Robert Faber 16d, John Haite nvit 4s 4d; and his villeins, Richard del Stokyng, Geoffrey son of Robert, Agnes de Horwell'. Robert son of Godwin. Robert de Horwell'. Hugh son of Richard. John son of Hugh. Ernesin le Vine and William son of Roger. Rent: a rose. Price: £100. Witd: William de Bello Campo earl of Warwick, Elias de Tyngewyk.

John Cissor of Potterspury gives to Richard son of John son of Geoffrey 57½ acres 1 rood of arable in the vill of Potterspury and all his pasture in *Coppedemor* towards Furtho, of which 30 acres lie in *Rouwestockyng*; 1 acre lies in *le Hay*; 1 acre 1 rood lie in *Wyndolfueshegg*; 1½ acres lie at *Lousiplot*; 1 acre lies above *Cleilewell*'; 1 acre lies beside *Cleylewell*'; 2 headlands containing ½ acre lie in *le Malmes*; 1½ acres lie in *Tocheholes*; 1 acre lies in *Goforcho*; 5 acre lie in *Leffeld*'; 2 acres lie in *Wrotecost*; 4 acres lie in *Hardele*; 2 acres lie beside *Parchurs*; 2½ acres lie in *Hardele*; 1 acre lies in *Ghothemalmes*; 3 acres lie in the croft. He also quitclaims to Richard the rents and services of Richard son of John, the heir of John de Preston, Geoffrey Boueton, John le Lord, Richard Illing, Richard Randolf, Simon Alderman, Ranulf Textor, Robert son of Robert, John Cissor, Simon son of William, William Couerith', William Carnific', John le Lou and Roger Levesone, for all the lands which they held of him in Potterspury. He also quitclaims to Richard his villeins Hugh Wyte and Richard Doget, and 3 cottages which Joan Benge, Leite and Agnes Page held at will. Richard paid 90 marks.

Richard son of John, lord of Potterspury, grants to John son of Elias de Tyngewyk a portion of land in the manor of Potterspury lying on the furlong called *Overthewode weyfurlong*, 42 perches long and 1 perch wide, which land John exchanged by Richard's licence for land on the same furlong with villeins of the manor. He also grants to John all the land which he has within the boundary of a furlong called *Lamberdismor* with all the adjoining meadow between the close of John's buildings and a furlong called *Hyndleye*, which is not yet enclosed, to ditch and enclose at his will, saving to Richard and his tenants common pasture on the said land and meadow when it is open with free entry and egress in two places, from Michaelmas to Martinmas, and after Martinmas it will be lawful for John to shut the opening.

To hold of John and Isabella, paying 3*d*. a year at 3 terms. If the agreement fails, John and Isabella will give them a tenement in Cosgrove. Richard Adyngton' of Potterspury gives to Alice Adyngton' his mother for her life as dower, in Potterspury and Cosgrove, a messuage with adjoining garden and close in Potterspury between land of the lord of Moor End on one side and Watling Street on the other side; a moiety of another tenement with garden in Potterspury beside the tenement of the earl of Warwick and extending to the king's highway there; in the field called Hardlyfeld' 1 acre lying in Wrotecroft between his land on one side and land of Matilda Porter on the other side; 1 acre lying below Temple Lane between land of the earl of Warwick on one side and Temple Lane on the other side; 2½ acres in Hardly abutting Temple Lane and lying between land of John Foscote on one side and le Wrotecroft on the other side; 3 half-acres lying in le Malums between land of the earl of Warwick on one side and his land on the other side; 1 acre lying in the same furlong between land of the earl of Warwick on one side and land of John Foscote on the other side; 1 butt lying there between him on one side and land of John Foscote on the other side; in le Wynmyllfeld 1 acre lying at Lansers between land of the earl of Warwick on both sides; ½ acre lying there between land of the said earl on one side and le Moreendeweye on the other side; ½ acre lying on the other side of the said way called Moreendweye between the same way on one side and land of the said earl on the other side; ½ acre extending to le Chircheweye lying between land of the said earl on one side and land of John Sharp on the other side: ½ acre lying in Smaledoles between land of the said earl on both sides: 3 half-acres abutting on the other side of *Moreendeweve* lying between land of John Foscote on one side and his land on the other side; 2½ acres lying in Borough'well'feld' there; in le Astwell'feld' 1 acre lying in le Overinlond between land of Thomas Maudeleyn on one side and land of Philip Chese on the other side; ½ acre lying in le Nether inlond between land of the lord of Moor End on one side and land of Robert Smyth on the other side; 1/2 acre lying in the same furlong between land of Thomas Maudeleyn on one side and land of John Illyng on the other side; ½ acre lying in *Sladfurlong*' and abutting on the other side of *Fortho* wey, ½ acre abutting on Goselondys lying between land of the lord of Moor End on one side and land of Thomas Hendys on the other side; 1 acre abutting into Cleylewell' lying between land of the earl of Warwick on one side and land of the lord of Moor End on the other side; 1 rood lying in les Holes between land of the said earl on both sides; 1 acre lying at Biryebussh' beside land of John Foscote; ½ acre and 1 rood lying in the same furlong between land of the said earl on one side and his land on the other side; in Pokesleyfeld' 2 acres lying on le Grindill' between land of John Foscote on one side and land of John Bayworth on the other side; ½ acre on the same furlong between land of Geoffrey Sergeaunt on both sides. Henry VIII leases to Henry Addington for 21 years, parcel of the manor of Potterspury which is parcel of the honour of Grafton, 1 messuage with buildings in the tenure of William Atkyns in Potterspury with 2 closes of pasture lying beside the messuage; 14½ acres of arable in the field called *Wyndmyll felde*, 15 acres of arable in *Beryefeld*, 15 acres of arable in *Herdeleyfeld*, and 2 acres meadow in *King Holme* in Potterspury. Rent: £2 3s 4d a year.

John Arden of Somerton (Oxon) gentleman lets to Thomas Skott of Yardley Gobion husbandman a messuage in Yardley and land in the fields of Cosgrove, Furtho and Potterspury and in the town and fields of Yardley, for 21 years, paying £1 6s 8d a year.

Thomas Furthoo of Furtho esquire enters into an exchange with John Arden of Potterspury gentleman: ½ acre of arable in Potterspury for John in *Dunfeilde* upon the furlong called *Longe Loc*, Thomas Dorne on the east side, butting north and south into a way called *Mynge waie*; also 1 rood lying on *Lyttle Hall* furlong, the queen on the west now in the tenure of John Warrington and the lord of Furtho on the east, butting upon *Shorte Meade* brook on the north; 3 roods of arable in Furtho for Thomas, 2 roods lying together in new pasture upon the furlong called the *Netherstreete*, the furlong butting north-east on the queen's highway leading to Northampton, the lord of Furtho lying east and west with his lands which he has exchanged with others; the other rood on the same furlong butting on the highway, the lord of Furtho on both sides with his lands which he has exchanged with others.
