The Will of JOHN CHANDLER.—24 May, 1456, at London. Lands, &c., in New Wyndesor. To Richard Morden, Simon Reyham and Lucie my wife sundry bequests, joint executors.

The Will of JAMES CHAPMAN, of Grewell, co. Southt'., clothier.— 16 August, 1557, "in the iiijth and fyft yeres of the reignes of our soveraine lorde and ladye Philipp and Mary by the grace of god King and Ouene of England, Spayne, both Siciles, ffraunce, Hierusalem and Ireland, defenders of the faithe, Archedukes of Austria, Dukes of Burgundy, Millayn and Brabaunt, Counties of Habspurge, fflaunders and Tiroll." I geve to Stephen Tirry, of Sutton, and Edward Feelder, of North Warnborow all my lands, &c., in Odvam. North Warnborow and Grewell, co. Southt'., to the use of the children of my brother Thomas (James Chapman only excepted) Thomas and Robert, with remainder to the heirs male of my brother Robert and Joane his wife. I geve to John Canner, of Odyam, and Robert Hethe, of Stapely, my lands, &c., in Natley Skewers and in Upnatley to the use of seven of the children of the said Robert Chepman, James and Agnes only excepted, remr. to Christopher and Robert, sons of the said Robert. I give to Alice my wife my lands, &c., in Okingham, co. Barks, whiche I bought of John Martyn, with remainder to James Chapman, son of my brother Robert. I geve to Robert Richards my kinsman a tenement in Okinghm whiche I bought of Arthur Kirkebye and another which I bought of Willim Playner. To James Stocker, son of James Stocker, of Basingstoke, £10. To Thomas Alexander, John Clerk, Thomas Cranley, of Grewell, John Kent, William Alexander, Thomas Butt, of Grewell, Richard Freeborne, John Reding, Richard Tailor, John Hownsham, John Quyck, John Tomes, John Style eldest son of Edmonde Style, Robert May, clerke, Alice Dudman, wedowe, Alice Bukley, Emme Robbery, Richarde Wither, of Northe Warnborowe, Owen Gosten, of the same, Willm. Serle, Richard Cawle, Tristram Wattes, of Dogmersfield, my workeman, Willm. Hoker, of Rithewike, my workeman, John Gosden, of Grewell, Joane Nasshe, widow of Robert, sundry bequests. To the poor householders of Okingham £3 to be delivered to my trustic freendes John Crotall and Thomas Martyn. To Agnes Dypnall, Willm. Higett, Margaret Higett, sundry bequests. My wife Alice and brother Thomas Chapman to find at scole James Chapman and James Chapman, sons of Robert Chapman, my brother, and Thomas Chapman, my brother. kinsman, John Martyn, at London, grocer, and to his wife, to my suster Clemence, my suster Anne Curley. My wife Alice and my brother Thomas Chepman, executors. John Canner, of Odiham, Robert Hethe, of Stapeley, Edward Feelder, of Northe Warnborowe, and Stephen Turree, of Sutton, my overseers.

Witnesses, Sr. Hugh Laver, preest and curate of Odiham, Thomas Chapman, John Raiger the yonger, John Hamon thelder, John Reding thelder, of Grewell, and William Hoker, of Rotherwick.

The Will of John Chapman, of Chepyngfaryngdon.—22 June, 1501. To be buried in the chapel of St. Trinity in the parish church of All Saints. My wife Rose, Robert Muschet. To Elizabeth, daughter of my wife Rose, Sir William Bonar, Amsie, wife of Master John Rawlyns, Margery, wife of Thomas Spicer, John Rawlyns, junr., and Thomas his brother, Johan Spicer, daughter of Thomas Spicer, John Wityng, Robert Wright my son, Margery my servant, and to Johan Harward my servant, sundry bequests. To Richard Wicke after the decease of my wife Rose a messuage etc., in Westbroke called Buchers and my inn called Anketillis. To the said Rose my wife all my houses and lands in the counties of Berks and Wilts. The residue to the said Rose, Margery Parker, Sir William Bonar and Richard Wicke, executors.

To William Child my doughter's sonne, and to my doughter Jane that now is married to Henry Knollys, of Stainys, sundry bequests. The residue to Thomas Cheslacke my sonne, sole executor. My friends William Grynder, Thomas Brescowe, of Frynley, and Androwe Durdant, of Stanys, overseers.

13 April, 1557. To be buried in the chauncell of the pysh of Hannye. Debts paid I bequeth all the residue to Martha my wife whom I make my soole executrix. Willm. —— the elder, Esquyer, my overseer. Witnesses, John Ashcum, gent., John Hawsse.

The Will of Sir Robert Cheyny, knight.—13 Augnst, 1503.—To be buried in the church of the Friars Minors in New Sarum. I give to John Cheyny, son of Roger Cheyny, my heir, my lands, &c., in the counties of Kent and Berks. To Henry Cheyney, son and heir of John Cheyney, knight, lands, &c., in Hants, Wilts and Berks. Wife Margaret executrix.
