Rental revised and made by Roger Amyce surveyor of the Kings lands the 14th day of November in the 3rd year of our King Edward vi by the grace of God King of England France and Ireland, Defender of the Faith and Supreme Head on earth of the Church of England and Ireland.

Richard Ayleworth is a free holder of a messuage and garden and 2 small crofts behind containing 2 acres, a moor next the gatehouse containing 1 acre of pasture, a meadow called Gybes mede of 1 acre, another meadow called Home mede of 3 acres, half a close called Crout containing  $1\frac{1}{2}$  acres, one other moor called Chauldwell of 1 acre of pasture. Also in the Common Fields 5 acres of ploughland namely in Wydenershe Field 3 acres, in Church Field 2 acres. Annual rent beyond 7d. paid to John Ayleworthe 1s. 6d.

John Godinge is a free holder of one messuage and a virgate of land called the Gronehouse, a close of 4 acres of pasture called the Groneclose a close of 5 acres of pasture called Le Forde. Five acres in the Common Fields namely  $2\frac{1}{2}$  in Wydenershe Field and  $2\frac{1}{2}$  in Home Field, a meadow called Broadmede of  $2\frac{1}{2}$  acres, a rood of meadow in Wildmede and a meadow of half an acre next Staury Lane. William Atrithe is a free holder of a messuage called Netters with a quarter of a rood of garden, a grove called Grene Lande of 1 acre. Annual rent for the house 6d. and grove 1s. 6d.

William Westall is a free holder of a messuage and barn called Le Overhillhouse to which belong 2 closes lying on the east of the said messuage called Le Home Close containing 4 acres of pasture, a marsh on the west containing.....one other Close called Harecrofte containing 4 acres of pasture, a close containing 3 acres of wood, a close with 2 acres of wood and 2 acres of meadow called Westmore Mead and 2 acres of arable in the Common Field called Home Field. Yearly rent 2s. 4d.

Edmund Slithurst is a freeholder of a messuage called Alysaunderes to which belongs a Close behind of 2 acres of pasture and wood, a Close of meadow of 2 acres called Were Mede, and also a tenement called Stipsells with an Orchard and a Close of 1 acre, a Close of 1 acre called Stipsells Mead, a Close of 2 acres called Ryperkes, a Close of 3 acres called Honeride. In Asshecrofte  $1\frac{1}{2}$  acres, in Churchfield  $3\frac{1}{2}$  acres and in Wynershefelde  $2\frac{1}{2}$  acres. Yearly rent 4s. 2d.

Thomas Bukeler is a freeholder of a Capital messuage with a Close and garden behind of  $1\frac{1}{2}$  acres, another close called Ayleworthes of 1 acre, another close of 8 acres of pasture called Segwoerthe, a close of 6 acres called Le Fryssen, a close called Le Pondclose containing  $1\frac{1}{2}$  acres of pasture, a close of  $1\frac{1}{2}$  acres called Le Close before the gate, a close of 2 acres of pasture called Comdellclose. In Homefeld 2 acres, in Wynershefeld 2 acres, one other close called Chapmans more containing 2 acres of wood, another moor called Adhams moor of half an acre, a marsh called Long moor of 1 acre, 7 acres of meadow in Wydemore and 5 in Ayleworthe mede. Yearly rent 12s. 0d.

The same holds in right of Isabella his wife a messuage and garden and a small close adjacent of 1 acre, one containing 4 acres of pasture called

Est close, another close of 2 acres called Le Butt, in Churchfeld half an acre, one other close lying between the said messuage and the mill containing 3 acres of meadow, another meadow of 2 acres on the west of the said close, a marsh abutting on the mill pond of 1 acre one other close of 8 acres called Le Forde. Yearly rent 13d.

The said Thomas holds a moor called Strete moor containing 4 acres of wood and pasture and a meadow of 4 acres called Stretemedes in the occupation of Nicholas Gele.

The aforesaid Thomas Bukeler is a freeholder of a marsh called Harremore containing 1 acre of pasture occupied by William Wastell.

.....Brabourne is a free holder of a messuage, a barn, a garden and a small close of 1 acre and a close lying at Morelane end containing 1 acre. Rent.....nil because it is held under Sonning manor.

The wardens of the parish church are freeholders of 2 closes, one of  $3\frac{1}{2}$  acres of pasture called Kikers Halle, and another called Waterland of 2 acres, and in Asshecroft  $1\frac{1}{2}$  acres of pasture all in occupation of John Attrythe and the rent 4/- paid to the parish church of Sandhurst and 4/- to the chapel of Yateley. Yearly rent 11s. od.

Lord Sandes is a freeholder of a messuage called Crestelles in the occupation of Christopher Hanmere gent. Yearly rent 6s. od.

John George is a freeholder of a messuage, a garden, and a small close of 1 acre, 4 acres of land in Churchefeld, 3 acres and a rood in Wynershefeld and a close of 6 acres of meadow called Rider's Mead. Annual rent 3s. od.

Alexander Cheselake is a freeholder. Yearly rent 2s. 4d.

William Godfrey is a freeholder. Yearly rent  
1s. 10½d.

Alicia Atrithe widow has a copyhold of a cottage called the Littel House with a garden and close of 1 acre, and another close of 1 acre next the gate. Yearly rent 10s od.

Thomas Cox holds at will the site of the manor with a stable and other houses, a garden and pidell of 1 acre, a close with 2 barns called the Barn close containing 4 acres of pasture, 2 acres of pasture called Wadelandes a close of 4 acres called The Close at the house ende being pasture, one other pasture of 4 acres called Le Hawley, another close called Coxe's grene containing 2 acres of pasture, a close of 3 acres of pasture called Whelers, a close of 1 acre called Aple close, a close containing 6 acres of pasture called Beeche Hill, a close of 10 acres of pasture called Feld Rede, a close called Black Croft of 6 acres, Chapmans containing 2 acres of pasture, Little Chapmans containing 1 rood. In the common fields 24 acres of land namely in Churchefelde 3 acres, in Wynershefeld 10 acres, and in Homefield 11 acres of arable land. Also a close of pasture called Collyns of 1½ acres, another called Collyn's mead 3 acres, Downes Mede 2 acres, Stausewe mede 4 acres, and in Wilde mede an acre called le Lotte acre. Rent £4 os. od.

Richard Ayleworthe holds at the will of the lord a field called Gosholde containing 3 acres, a grove called Gosholde grove containing 2 acres of pasture and wood and one other close called le lyne croft containing 4 acres of pasture and wood, and the yearly rents are 14s. 8d.

Alicia Atrithe holds at the will of the lord a close there called Crutt containing 2 acres and the yearly rents are 8d.

Henry Hinde holds at the will of the lord one grove called le Hall grove containing 9 acres of wood full of oaks, one pasture called le breche containing 7 acres, one other close called littell castle containing 6 acres of pasture and a field called depemede containing 10 acres and the yearly rents are £4

William Wastell holds at the will of the lord a grove called le piremore containing 4 acres of pasture and wood, one close called pirclose containing 2 acres of pasture and wood, a field called Dorney mead containing 2 acres and one other field called Ladymede containing 2 acres, and the yearly rents therefrom are 40s.

John Alysaunder holds at the will of the lord a field lying next the road leading towards the mill containing 2 acres of pasture, and the rent therefrom is 6/8d.

John Clerk holds a close called le myllmede containing 2 acres and a half, and the rents therefrom are 6/8d.

Nicholas Geyle holds at the will of the lord a close called Harry's mede containing 4 acres of pasture and wood, and the yearly rent is 8/8d.

Joanna Atrith holds at the will of the lord a close of pasture called Hally containing 5 acres, 2 closes called le lane acre containing 5 acres and a half of pasture and half an acre of wood and 2 acres of land lying outside Aylewards, and the rents are 16/-

Total of the rents of the lords land £12 13s. 4d.

**MEMORANDUM.** The said manor with all its rights, members, and appurtenances, with all plough lands, meadows, pastures, fields, underwood, rents, services, courts, heriots, reliefs, and amercements, with its belongings (all great trees reputed timber only being reserved to the King) is leased to farm to one William Braconbury gent. for a term of 21 years to have and to hold for

himself and his assignees from the termination of a certain indenture made by the late abbot of Chertsey and dated Dec. 5, in the second year of King Henry viii with one William Rogers for a term of 40 years. And the aforesaid William Braconbury and his assignees will exonerate the lord King and his successors from all rents and other burdens whatsoever issuing from the premises from time to time during the said term of years. And he will sustain and maintain all and every kind of repairs (gross timber alone excepted). And also he is to bear the expenses of the seneschal and surveyor with his servants and horses, i.e. for the space of 2 days and 2 nights as often as they come there for court, leet, or survey during the said term of years. Further the said William shall have sufficient hedgebote, fyrebote, ploughbote, and cartebote at the assignment of the seneschal of the manor in and on the premises for his use and not elsewhere. Rendering and paying annually during the said period at the feast of the Blessed Virgin's Annunciation and of S. Michael the Archangel or within one month next after the aforesaid £8 in equal portions or pay the penalty. Letters Patent granted Aug. 22, 35 Hen. viii.

Item. All the tenants of this lordship may enjoy common for their sheep and cattle in and through the whole of Windsor Forest.

The said tenants must pay double rents at the death of every tenant or in case of alienation [of their holding] for any other cause.
