By his wife Ann (d. 1674, aged 69) he had issue Henry (d. 1670, High Sheriff), Sarah (d. 1709) and Hannah (d. 1691). In 1647 he held the lease of the estate of Lowbrook in Bray from William Englefield and in 1656 he bought the estate from the latter's trustees; it remained in the family till the end of the 19th century when it was sold to Mr. Lewis Rose. The name of Henry Partridge appears in the list of those summoned to the Visitation of 1665-6 as "citizen of London"; he made no appearance. [V.C.H. Sir John Werden (1683–1758) was the only son of Sir John Werden (d. 1716, cr. a baronet 1672 and commissioner of the Navy) by his second wife Mary (d. 1683), daughter of William Osbourne of Kenniford, Devon. He married firstly in 1704 Elizabeth, daughter of Robert Breton, Esquire of Norton, Co. Northants. He married secondly Judith (d.s.p. 1726), daughter of John Eyre, Esquire of Maidford, Co. Northants. He married thirdly Elienor Verney (d.s.p.) and fourthly Susanna, daughter and coheir of John Staveley

Esquire, by whom he had an only daughter Susanna. The arms of Verney were Azure on a cross gold five molets pierced gules; Kerry, p. 53, quoting Sir Thomas Reeve's Collections gives Gules a cross moline gold here. A John Whitfield was steward of the manor of Bray in 1654. The reputed manor of Ives in Bray was bought in 1649 from the Garway family by John Whitfield. A John Whitfield gave a silver plate to the chapel of Maidenhead in 1727 and in 1720 a John Whitfield endowed the chapelry with £240 and Richard Whitfield (see No. 17 below) by will proved in 1730 gave to the same chapelry £250 and charged his estate at Wheatley, Oxon., with an annuity of £6 10s. for money and clothing for four poor men and two poor women of the borough of Maidenhead. The name of John Whitfield appears in the list of those summoned to appear at the Visitation of 1665-6 thus: "Maydenhead in Bray p'ish. John Whitfield Esqr. adjournd till Easter Tearme 1665. > Thomas Little married Elizabeth, second daughter and coheir of Sir Robert Litton, son of William Litton, Governor of Boulogne Castle, and Audry, daughter and heir of Sir Philip Booth, Kt., of Shrubland Hall, Co. Suffolk. His only daughter and heir married Edward Bacon; the latter sold the estates of the Little family in Bray to Dr. Robert Challoner for £2,000. In 1530 Robert Little purchased Masts with other lands in Bray, Fifield and Winkfield from John March (alias Dony) and Margaret his wife; this Robert Little conveyed the same lands in 127 to Robert wife; this Robert Little conveyed the same lands in 1537 to Robert Little, Gent., and Joan his wife, and to their son Robert and his heirs. > Sir John de Foxley was the son of Sir Thomas de Foxley (d. 1360), constable of Windsor Castle, from whom he inherited the lands in Bray known as Foxleys. His mother was Katherine daughter of Sir John de Ifield. He married in about 1333 Maud daughter of Sir John Brocas of Beaurepaire, Co. Hants., by whom he had William (d.s.p.v.p. 1376), Katherine (who married John de Wableton) and Margaret (who married Robert Bullock); he also had a son Thomas (d. 1436) by Joan Martin whom he married after Maud, his first wife, had died; Thomas succeeded to the manor of Foxleys and left as his heir his daughter Elizabeth (wife of Thomas Uvedale) by his wife Margery Lytton. In 1377 Sir John had a grant of the custody of the castle of Southampton, the park at Lyndhurst and the New Forest for life at the annual rent of £130. Extracts from his will are given in Kerry, p. 105. Sir John was M.P. for Hampshire, 1364-5 and for Berkshire 1369-70. In connection with No. 42, it is to be noted that two bars was also the coat of Martin, but nevertheless it is not for Martin here in No. 42 because Sir John de Foxley's will especially excludes that coat. He was the elder son of William Paule (d. 1665), Bishop of Oxford, 1663-5, and was knighted at Windsor on 6 July 1671. By his will he left an annual rent charge of £5 on his estate of Woodward's (alias Kember's) in Oakley "lately purchased of Thomas Page, Gent." to be paid to the minister and schoolmaster of Bray for the poor of the parish being of the church of England. In 1675 he built Braywick Grove and erected a seat in the north aisle of Bray church in 1679 for his own use and for "his new erected house at Braywick for ever." Catherine his sole daughter and heir brought the Braywick estate by marriage to Sir William Stapleton of Westminster. See also Hatford No. 2 (Berks. Arch. Jnl., 36 (1932), 45).

John Hanger (d. 1733, aged 77). of Trinity Minories, merchant of London, and of Bray, was Governor of the Bank of England 1719–21; he married Mary Coles. His daughter Ann (dowry £100,000) married in 1718 Henry Hare, 3rd Baron Coleraine (d. 1749) from whom she separated within three years of her marriage and did not return to him; on Lord Coleraine's death "she inherited most of his property, which she left, together with Cannon End Place, her seat in Berks, to her cousin, Gabriel Hanger, the 1st Lord of the next creation. She presented the parish of Bray with a fire engine." On the death of John Hanger's second daughter Mary in 1739 "her fortune of £13,000 went to her two sisters Lady Coleraine and Elizabeth." [Compl. He was the son of John Norreys (fl. 1576), Gentleman Usher of the Black Rod to Queen Elizabeth, by his wife Mary, daughter and coheir of Henry Staverton, Esquire of Bray. He was Usher of the "parliament house," a K.G., Comptroller of Windsor Castle and Keeper of Folijohn Park. By his wife Mary, daughter of Sir Adrian Fortescue Kt., whom he married in 1548, he had issue six sons and six daughters. His father settled the manor of Bullocks in Cookham on him in 1548 and he duly succeeded in 1577; his son Sir John Norreys (d. 1612) settled this manor on himself in 1606 for life with remainder to his (Sir John's) sister-in-law Elizabeth and her husband Thomas Lord Erskine in tail. The arms of Erneys, Molyneux, Harrington and Fowler can be accounted for on reference to the pedigree in MS. Ashmole, 852, pp. 130-1, printed in Harl. Soc., Ivii, 184-5. [V.C.H. Charles Pascoe Grenfell (d. 1867) was the eldest son of Pascoe Grenfell (d. 1838) and he married in 1819 Lady Georgiana Isabella Frances Molyneux, eldest daughter of William, 2nd Earl of Sefton (d. 1831) by his wife Maria Margaretta, sister of William, 1st Earl of Craven. Charles William, their eldest son, was M.P. for Sandwich 1847–52 and of Windsor; he married in 1852 Georgiana Caroline (d. 1911) eldest daughter of the Rt. Hon. William Sebright Lascelles, and died v.p. leaving issue four sons (the eldest of whom was created Viscount Desborough in 1905) and two daughters. Charles Pascoe Grenfell of Taplow Court bought the manor of Philberds in 1860 from the dean and chapter of Windsor; he also bought in 1861 the estate of Lowbrook in Bray and the reputed manor of Ockholt. He also repaired the roof of the north chapel in c. 1860 and set up two new corbels with his arms (see Nos. 84-5 below) and those of his parents (see No. 91 below). The arms (Nos. 82-95) shew that the chapel of St. Nicholas was built at the cost of John Norreys, Esquire (d. 1466) of Ockwells and repaired by Charles Pascoe Grenfell (d. 1867: see Nos. 76 and 112) in c. 1860 when two corbels carrying the wall posts of the middle tie beam were renewed and carved with the arms of Charles Pascoe Grenfell and those of his parents. John Norreys (d. 1466) was the son of William Norreys (of Ockwells, Kt. of the Shire temp. Hen. VI) by his first wife Christina, daughter and heir of William Streche of Ruscombe, Co. Berks. He married firstly Alice Merbrooke, heiress of Yattendon, Co. Berks. and secondly Eleanor, daughter and heir of Roger Cliderow (No. 93) of Ash, Co. Kent (whose mother was Catherine, daughter and coheir of Sir John Oldcastle), and thirdly Margaret (d. 1495) daughter of Sir John Chedworth (No. 88) and afterwards the wife of John, Duke of Suffolk (d. 1486). The issue was Sir William Norreys (d. 1507), Kt. of Ockwells, John (High Sheriff of Berks. & Oxon, 1479-80) and Ada (who married John (d.s.p.), son and heir of Sir Robert Harcourt of Stanton Harcourt, Oxon. For his will see Kerry, pp. 116-120. The arms Nos. 93 and 94 are found in glass in Ockwells Manor House. The arms, No. 80, Ravenscroft, were adopted by Norreys when Sir John Norreys' great-grandfather, John of Ockwells (fl. 1437) married Milicent, daughter and heir of Ravenscroft of Cotton and Hardingstone, Co. He was M.P. of Marlow and subsequently of Penrhyn and married firstly in 1786 his cousin Charlotte Grenfell by whom he had issue two sons and one daughter, the second son being Charles Pascoe (d. 1867: see No. 112 below). He married secondly in 1798 the Hon. Georgiana St. Leger, youngest daughter of 1st Viscount Doneraile, by whom he had issue two sons and ten daughters. He bought the manor of Bray from the Crown in 1818 and the so-called manor of Shoppenhanger in 1801 from Sir Adam Gordon. [Burke, Peer.; V.C.H. Humphrey Staverton, who was in possession of the manor of Strode in Bray, died in 1524 leaving two daughters, Anne, wife of Thomas More, and Eleanor, who married Robert Loggins and eventually became heir of Strode. A second donation of £1,000 was given by J. Hibbert, Esquire, in 1860 for the benefit of the 34 parishionary almsmen. He was born in 1811, the son of John Hibbert (d. 1855, aged 87) and married in 1836, Charlotte Elizabeth, daughter of Lieut.-Gen. Charles Turner, Colonel of the 19th Rgt. [V.C.H. He was the son of Josse Alexandre Van de Weyer by his wife Martine Gouban and was born in London in 1802. He was a member of the Provisional Government and Congress of Belgium, 1830; Minister of Foreign Affairs 1831, and a Deputy to offer the crown of Belgium to H.R.H. Prince Leopold of Saxe-Coburg Gotha, 1831; Minister of Home Department, 1845-6; Envoy Extraordinary and Minister Plenipotentiary at the Court of St. James, 1831-71; Minister of State, 1871-4; Member of the Royal Academy of Science and Literature, Belgium. In 1839 he married Elizabeth Anne (d. 1878), only child of Joshua Bates, Esquire of Sheen House, Surrey, and Winkfield Place, Berks., by his wife Lucretia Augusta, daughter of Samuel Sturgis, Esquire of Boston, U.S.A., and had, with other issue, a son Victor William Bates (1839-1915). He married in 1767 Sarah (d. 1819) daughter of Rev. Sir James Stonehouse, Bt. by Ann, daughter and coheir of John Neale of Allesley, by whom he had issue five sons and three daughters. The following note appears in A history of Maidenhead (1919) by J. W. Walker, on p. 72 "George Vansittart, sixth son of Arthur Vansittart of Shottesbrook, was born 15th September 1745. His earlier life was spent in India in the service of the East India Company, being employed partly in administration and partly in commerce. He is said to have been a good man of business and an accomplished linguist. He became a member of the Supreme Council of Bengal and was a friend and supporter of Warren Hastings. Returning to England, he purchased the Bisham Abbey estate in 1780, and for twenty-eight years represented Berkshire in Parliament. He died 24th January 1825 and an entry in the Corporation Minutes testifies to the great respect in which he was held locally. . . " For other biographical notes see: O'Byrne, R. Mr. Frederick Turner, of Mortimer, Berks., has kindly supplied the following note:—"Robert Bever was baptised at Stratfield Mortimer, 14 August, 1660. In the Vicar General's Allegations for Marriage Licences in 1692 we have 'Robert Bever of Maidenhead, Berks. & Mrs. Mary Tristram of New Windsor, spinster, about 16, at her own disposal, parent dead, no guardian, attested by Thomas Bever of St. Dunstan's in the West, stationer.' The marriage took place at St. Giles' in the fields. Mary seems to have had property in Windsor. The Thomas of the marriage licence was Robert's brother. Robert seems to have been a bit of a spendthrift in early years. He was the eldest son, and borrowed money on Bever House, Mortimer, of Richard Warman of Barnet, and borrowed money from his brother Thomas, until the total amounted to £800. In 1703 Thomas paid off the mortgage and gave Robert a further £500 and took over Bever House. According to the agreement which preceded the conveyance, Robert retained the great copper in the brewhouse and other 'standards' which he might sell or remove at pleasure. Robert died in 1723 and was buried at Stratfield Mortimer, August 3rd. in that year. Query was he buried at

Maidenhead and afterwards removed to Stratfield Mortimer? Robert and Mary had a numerous family." [Burke, Gen. Arm.; Papw., Ord., 1121].
