- 7. FINANCIAL POSITION.

During the year our income from Subscriptions has fallen by £27 and our expenses have been considerable, mainly owing to increased printing costs, so that it was not found possible to pay off all outstanding bills on the Journal account out of income before the close of the year. It is pleasing to note, however, that the amount given in Donations exceeds the sum contributed during the previous year, and these generous gifts have been of the very greatest assistance. It is again hoped that members will pay their subscriptions early in the year, so that all commitments may be met out of income.

### 8. Summer Meeting.

Again owing to the War, the usual programme of Excursions (in normal times six or seven) could not be carried through, but on July 24th, a summer meeting was arranged, when about 40 members and friends travelled to Goring and Streatley by river on the Oxford & Kingston Steam Boat.

Miss Ethel Carleton-Williams, M.A., had arranged a very interesting itinerary. Proceeding to Goring Church (dedicated to St. Thomas of Canterbury) the Rev. R. Sherwood, gave the party a most cordial welcome, and Miss Carleton-Williams explained the many architectural changes which had taken place during the centuries from Norman times, and pointed out many interesting items, including the Brasses, 1401–1617 and one in Norman French 1375, and also some old encaustic tiles.

Walking over the Thames into Berkshire a visit was paid to St. Mary's Church at Streatley, where the Rev. J. Hughes gave a history of the Church and Village.
