Martin de Garscherche leaves to his eldest son a capital messuage in the the parish of St Botolph Billingsgate and various rents, charged with payments (*inter alia*) to the canons of St Mary of Southwark and the monks of Bermondsey. nd. Proved 18 November 1274 (Roll 7/20)

- Arnald Thedmar leaves to Stephen Eswy his kinsman shops in the parish of All Hallows at the Hay, rendering annually to the monks of Bermondsey 3s. nd. Proved 11 March 1275 (7/35)
- Mr John Busshe leaves to be sold property in the parish of Fenchurch to be sold, saving to the monks of Bermondsey 32 pence annual rent. Dated 6 June 1333. Proved 6 December 1333 (61/123)
- Roger de Eure, ironmonger, leaves to his son Sir John de Eure, a monk of Bermondsey, an annuity of 6 marks for celebrating to the good of his soul and souls of his wife Christina and others. To his daughters Alice, Agnes, Johanna and Johanna [sic] all this tenements in the City of London in tail, with cross remainders; remainder to the prior and convent of St Saviour Bermondsey for pious uses. Dated 16 December 1333. Proved 1 February 1334 (62/14)
- John de Oxenford, vintner: bequest of measures of red wine and money to numerous religious houses including Bermondsey in return for their prayers. Dated 1 May 1340; proved July 1342 (69/93)
- Thomas de Sewell, bureller: his tenement in the parish of St Swithun to be sold, saving to Master and brethren of St James Westminster and the prior and convent of St Saviour Bermondseye certain annual quitrents. Dated 25 March 1349; proved May 1349 (76/180)
- Matilda de Myms: her apprentice William to be delivered over to the care and teaching of Friar Thomas de Alshom of the priory and convent of Bermondeseye for a term of three years. Dated 10 April 1349; proved May 1349 (76/313)

vol ii (1890)

- Henry Hale, fishmonger: bequest to the prior of Bermondsey etc. Dated 26 March 1375; proved March 1376 (104/15)
- Margaret Tonk: to the monks of Bermundeseye 13s 4d. Dated 21 October 1378; proved May 1380 (108/129)

Of these nine Husting items, four are not bequests at all but incidental references to existing quitrents payable to the abbey from properties bequeathed to third parties. A fifth concerns the committing of an apprentice to the abbey for his care and education. Only the remaining four involve actual benefactions, one where the testator's son was a monk, and another where Bermondsey was one of numerous other local houses bequeathed a gift of wine. None is later than 1380.
