Bermondsey material on pp 67–93; translated 95–125

- 95 Explained as Bibl Cotton Claudius A8, f 110: ‘From the book of the charters and muniments of all the liberties, manors, churches, rents, possessions, portions and of all other possessions to the house of Saint Saviour of Bermondsey near London pertaining, by Brother William de Preston edited and ordered in the year of our Lord 1363 in the time of ... John de Caroloco then prior of the said house.

f. 2 King William to W the bishop and R the chaplain [no contents], witnessed Robert bp of Lincoln, R earl of Meulan, William Bainard... at London.

f. 3 William earl of Chichester, Richard de Lucy, William Martel, Richard de Canvil, witnesses in the charter of King Stephen in Newebia.

- 96 f. 4 Richard king [no content], 2 November, year 10 [1198]

ff. 4–5 King Henry I grants and confirms to the church of SSB and the monks three mansiones of land which Hubert son of Dodeman gave them of the land which he bought of William son of Hugh de Bokelonde. And this I grant to them to buy wine for masses. And I give the church of St George Southwark.

- 97 Henry king of the English to William bishop of Winchester and Gilbert the sheriff; has given to SSB his manor of Waddon. Witnessed: Rannulf the chancellor and Nigel de Albini at Waltham.

 Henry king the English to William bishop of Winchester and Roger the sheriff: has given Rederheia and elewys and a hide of Southwark. Witnessed: Waldric the chancellor, William de Werelwast, Eudo dapifer and Hamo dapifer... at Winchester at Easter.

f. 18 [sic] William bishop of W on the day of the decollation of St John Baptist, 1247

- 98 f. 21 Ralph fitz Thomas fitz Ralph de Ardene gave and confirmed the church of St George in Southwark and the tithe of his demesne in corn in...

f. 29 Final concord at Westminster, Monday before St Nicholas 34 Henry II [5 December 1188]... between the prior and convent of SSB and Salamon fitz Roger [no content]

- f. 35 Justices and barons of the Exchequer, 15 December 1320
- f. 41 Henry to W bishop of Winchester and Gilbert sheriff of Surrey; has given Waddon. At Norwich.
- 99 f. 45 William de Watevil confirms the gift of William his father

- f. 47 Richard earl of Clare confirms the gift of William de Watevile and Robert his son of the manor of Warlingham. Witnesses: William de Einesford, William his son, Ingelram de Abernun.
- 100 f. 48 Sybil sister of William de Watevile, 13 kal May 18 year of consecration of John bishop of Winchester [J. de Pontoise, 1282–1304, making this item c.1300].

- f. 135 Walchelin Maminot gives a half part of all Greenwich with the consent of his wife countess Juliana etc (dated in margin ‘1145, 11 Stephen’). Countess Juliana declares herself to have been present at the death of her husband Walchelin at the church of SBB.
- 103 f. 136 Charter (of Juliana or Maminot?) granting to SSB 10s in the mill of Greenwich near *Depeford*. Witnesses include Rannulf the sheriff.

Geoffrey de Say confirms the gift which the father of Walkelin Maminot gave to SSB of 10s pa from the mill of Greenwich.
- 104 Brother Imbertus prior of SSB: remits to William de Say son of Geoffrey de Say all arrears owed from the mill of Greenwich up to Michaelmas 1239.

- f. 140 Will of Agnes sister of St Thomas the martyr (p 105): to the hospital of SSB 10s rent in London and 13s rent in All Saints Blankesapelton, and the 3s remaining shall remain to Theobald, my heir.
- f. 168 Henry of Newmarket grants to B half of Upton, two hides in Brudeston, 3½ virgates in Wiedon, 6 virgates in Hardwick and the church of St James in the same town, a tithe of the demesne of Estenton and 10s of the mill of Sutton. Witness: Earl Patrick.
- 106 f. 179 Charter of Winebald de Baalun: land in Upton.)Continues through to p 108 and f. 180)
- 108 f. 181 Eustace count of Blois for the soul of Countess Mary his wife grants to the church of SSB, where she lies buried, the manor of Kinewardeston,
- 109 which she dying gave to the above.
- Stephen count of Blois and Mortain and his wife Matilda grant to SSB where the lady Countess Mary, mother of my wife, is buried, for the souls of Eustace the earl and Mary his wife, the manor of Kinewardiston co Somerset. Witness: Henry abbot of Glastonbury.
- Goscelin bishop of Bath, 6 Ides October in 18th year of his pontificate.
- 110 f. 184 Roger de Baalun and the church of Inglescumbe.
- Robert de Gurnai son and heir of Eva de Gurnai and grandson of Hawis de Gurnai, grants and confirms to Hugh prior of B the advowson and church of Ingelescumbe. Anno 11 Henry III [1226–7]
- 111 f. 185 Joscelin bishop of Bath: 15 kal April 1239
- 117 f. 270 Final concord, octave of St H 14 Henry III [1230] between Hugh prior plaintiff and Geoffrey de Say defendant, apparently re the church of Berlinges.
- 122 f. 202 Dispute re SSB and St Evroul re the church of St John Wideford.
- 124 f. 205 Henry prior of B in 21 Edward I [1292–3]
