- 45 (MSS of Rt Hon Lord Calthorpe, Grosvenor Square) vol CLXII includes *Annales Cambricae* ending 1286; extracts from Chronicle of W. Thorne, f 45 – from book of the priory of Bermondsey near London, f 57.

- 125 (House of Lords MSS) Dr Paske as rector of SMMB 1634

- 183 (Westminster Abbey) Press 6 Box 4 Parcel 33 no 21

Permission by papal authority for a monk of B to enter the order of St Benedict. 17 January 1399

- 336 (Lord Bagot MSS) No year: letter dated 16 January [1593] from Warwick Inn, the day of the funeral at Bermondsey of Henry earl of Sussex, when my lord of Essex will be a mourner.

- 370 (Lt Col Carew MSS) Copies of documents *ex rotulis cartarum tempore Regis Edward II & III de diversis libertatibus et privilegiis commissis* (printed): - followed by extracts from the Register of Bermondsey abbey (which have been printed in the new edition of Dugdale's *Monasticon*) beginning in 1082 and ending in 1502 (folio, 17th century).

London and Southwark. Including royal grant of 12 Edward IV [1472–3] of licence to Bishop Waynflete to make a bridge in Bermondsey-street.

47b (St Paul's D&C MSS) A Box 66 Wills, no 43. Thomas Leggy skinner dated 1357: 60s to SBB

66a (WD4, Liber L) f 45: copy of a grant by Ralph dean of St Paul's to Christiana and successors at Markyate, 1145: witnessed by Thomas monk of B.

110b (D&C Canterbury)

Register S: 1391 *Composicio inter Dm Archiepm Cant et priorem de Burmundeseye de escambio advocacionis ecclesie de Croydon pro manerio de Waddon*

120b Register T: 1523 Indenture made between the archbishop on one part and the abbot of B on the other for the yearly keeping of mass and Dirige to be sung within the monastery of B. The archbishop, lord of the manor of Croydon, had long been at variance on account of differences of opinion as to the payment of tithes from the archbishop's manor. In the interests of peace the archbishop yielded much, so much that the abbot felt constrained to make him a recompense. With this in view he bound himself and his successors to sing Dirige and requiem mass by rote on the archbishop's anniversary forever.

- 254 Accounts of John Bagott servant to Sir William and Sir Henry Sydney, 1557–58, include ‘necessaria for Derby the Irisshe boy’ 17s 7d; ‘necessaries laid into the place at Barmesey, 28s; carriage of stuff from Westminster to other places and Barmeseye, 7s 6d’.

- 30 (St George’s Chapel, Windsor XI.g.17): grant by Jobert, prior of B to the monks of St Mary Bec of tithes at Pouinton, Lutela and Blakemanneston for rent of 8s pa [1227: date given by Luard in *Annales Monastici*, iii.456]
- 155 (Duke of Norfolk MSS) 10. 27 April 1331: mandate by Edward III, dated at Bermondsey.
