Peter (Petreius), 1089; d 1119

Walter d. 1134

Clarembald, 1134; promoted abbot of Faversham 1147

Roger, promoted abbot of St Ouen 1157

Adam, promoted abbot of Evesham 1160

Roger, promoted abbot of Abingdon 1175

Robert of Belesme, 1175

Guerric, promoted abbot of Faversham 1178

[Bertram 1178–1184 (*Annals*); prior April 1182 (*Westminster Ch* 287)]

Constantine, occurs 'after 1178' and before 1189

Henry de Sully, [prior in 1186x89 (*Westminster Ch* 368)]; promoted abbot of Glastonbury 1189

Hugh, occurs [1201–2 (*Surrey Feet of Fines*)], 1202–3 and between 1222–3 and 1234–5

[Peter, 1234–1240 (*Annals*); admitted by 16 November 1235 (*Close Rolls* 1234-37, 209)]

Guichard, nominated 1238; occurs 1240

Imbert, occurs [1241-2 (*Surrey Feet of Fines*)]; c.1242–50

Aymo de Montibus, seisin of temporalities 1252; occurs 1259; promoted prior of Wenlock 1261

Gilbert de Bussa, nominated by La Charité, 1261

John of Chartres, nominated by La Charité, 1266; occurs 1271, promoted prior of Wenlock 1272

Henry de Monte Mauri, nominated by La Charité, 1272; [occurs 1274 (*CAD*, i.A767); 9 January 1275 (*Close Rolls* 1272-79, 226)]

Peter de Mont St Vincent, nominated by La Charité, 1279

Henry de Bonville, nominated by La Charité, 1 May 1285; promoted prior of Wenlock 10 September 1285

Henry 'Northam', nominated by La Charité, 1286 [d. 27 Aug 1293 (*Cal Misc Inq* i.no 1633)]

William de la Charité, nominated by La Charité, 5 October 1293

Peter de St Saphorin, nominated by La Charité, 1297; d 1298

Henry, nominated by La Charité; [occurs November 1298 (*Cal Pat Roll* 1292-1301, 386); October 1311 (*Cal Close Rolls* 1307-13, 441) dead by 23 August 1312 (*ibid*, 548)]

Peter de Sancto Laurencio, nominated by La Charité, [elected by October 1312 (*Cal Pat Rolls* 1301-1313, 505); occurs 1 October 1321 (*Cal Close Rolls*, 1318-23, 403)]

Walter de Diluiz [occurs July 1322 (*Cal Pat Rolls* 1321-1324, 143); imprisoned January 1324 (*ibid*, 361)] leaves country 1324

John de Cusancia, nominated by La Charité, 1324; [prior by 18 April 1324 (*Cal Pat Roll* 1321-1324, 407)]; resigned 8 October 1360

John de Caroloco, nominated by vicar general, 1360; promoted prior of Lewes 1364

Peter de Tevolio, nominated by vicar general, 1364; dead by 18 January 1374

Richard of Dunton, nominated by La Charité, 1374; resigned 1390

John Attilburgh, nominated 1390

Henry Tompston, elected 1400; d 1413

Thomas Thetford, elected 1413; d 1432

Ordinations at Southwark include subdeacon: John de Newport, monk of B (*Reg William Edington*, 1346–1366, i. 43).

10 June 1346

Orders conferred at St Mary Southwark: acolyte: William Pack' monk of Bermondsey; Deacon: John de Tudenham, dioc Norwich, at tit. prior of B; Priest: Fr John de Burgoyne, monk of Bermondsey (*Reg William Edington*, 1346–1366, ii. 703–11).

17 March 1347: subdeacon: John de Rendelsham dioc Norwich ad tit pr. B; Deacon: William Pack, monk of Bermondsey; Priest: William de Neuport, monk of Bermondsey (*Reg William Edington*, 1346–1366, ii. 726–8).

26 May 1347

Deacons: Peter de Secthille, Roger de Dunham, monks of Bermondsey (*Reg William Edington*, 1346–1366, ii. 734).

22 January 1349

Adm William de Ware clerk to SMM Bermondsey, presented by prior and convent of Bermondsey, Esher (*Reg William Edington*, 1346–1366, i. 331).

19 December 1349

acolyte: William de Preston, monk of Bermondsey (*Reg William Edington*, 1346–1366, ii. 791).

20 February 1350

acolytes: William de Preston, Henry de Kynewardiston, Thomas Honyng, monks of Bermondsey; Subdeacon: Germanus de Jernemuta, monk of Bermondsey (*Reg William Edington*, 1346–1366, ii. 796–7).

22 May 1350

deacon: Peter de Alta Petra, monk of Bermondsey; Priests: Thomas Onyng', Henry Martyn, monks of Bermondsey (*Reg William Edington*, 1346–1366, ii. 810–11)

18 December 1350

priests: William de Preston, monk of Bermondsey (*Reg William Edington*, 1346–1366, ii. 821)

19 March 1356

subdeacon: Geoffrey, monk of Bermondsey (*Reg William Edington*, 1346–1366, ii.868)

23 December 1357

acolyte: Fr Otho de Sancto Meremo, monk of Bermondsey; Deacons: Ralph Humptyng of Weldon, dioc Lincoln, ad tit. domus SSB (*Reg William Edington*, 1346–1366, ii.888, 895)

22 December 1358

deacon: Ottominus de Sancto Martino, monk of Bermondsey; Priests: John de Farnham, Geoffrey de B, monks of Bermondsey (*Reg William Edington*, 1346–1366, ii. 900–01).

23 September 1363

priest: John Ben, monk of Bermondsey (*Reg William Edington*, 1346–1366, ii. 935).
