# CATALOGUE OF ANCIENT DEEDS

- A767 Certificate of Henry prior & convent SSB to their tenants of the manors of Wydeford, Richmond, Cowick and Hallingbury that they have appointed their fellow monks, John de Kent and Ralph de Derby, their attorneys to put Sir Adam de Stratton in possession of the aforesaid manors, which they have granted to Adam, to whom tenants are to be respondent. Bermondsey, Thursday after St Martin [15 November] 1274.
- A816 Grant by Adam de Stratton clerk to Simon Gubiun of land in Stapelford which he held by grant of the prior and convent of B, who held it before of the fee of Simon; at a yearly rent of 8s 3d. Feast of St Gregory [12 March], 1274.
- A817 Grant by John le Moyne of Stapelford for 8m to the prior & convent of B of land in Stapleford for 15 years from Michaelmas 51 Henry III [1267], they paying to the end of the term a rent of 40s if they continue to hold the land. [50 Henry III [1265–66]]
- A1008 Grant by Adam de Sratton, clerk, to Oxbert de Watreford, of land of the fee of Richmond in Benegho, which Adam had by gift of the prior & convent of B at 9s 9d pa rent. Richmond, Annunciation [25 March] 1275.
- A1139 Agreement whereby Adam de Stratton clerk grants to John son of John de Savekaump, vicar of All Saints Hertford, land and rents in ...<'very much injured'>. which he had of the fee of the prior and convent of B. Annunciation [25 March] 1275.
- A1612 Grant by Mr William de Paris, surgeon, to Nuto Fouberto and Burgensius his brother, citizens and merchants of Florence, of 40m of his land in Bread Street, St Olave's parish, situated as described, paying to him ½ lb of pepper pa, and to SSB 2s [5 Edward I (1276–7)].
- B509 Demise by Ralph, abbot of Battle and convent of that place to Henry Ruffus baker of Southwark, of land in B. [nd] <much damaged>.

- A1983 Grant by Peter called Chauuag, baker, to Robert de Aldenham buckle-maker of London of a messuage within Aldersgate in the p of St Agnes, held of the fee of the canons of St Bart's, paying to the monks of B 12d [49 Henry III (1264–5)].
- A2002 Grant by William son of Roger for 12m to John prior and canons of Holy Trinity Aldgate of annual rents of 24s from houses in pp St Martin [Orgar] and St Martin Outwich, Holy Trinity paying 10s to the monks of B [44 Henry III (1259–60)].
- A2142 Grant by Gerard Beivin of London and his wife Alice called *la Blunde* for the souls of Thomas de Basing her late husband and Peter de Basing deceased their son, to the prior and canons of Holy Trinity of land with houses in All Hallows Colemanchurch, paying yearly 12d to the monks of B. 3 Edward I [1274–5].
- A2416 Grant by Robert de Diva prior of the Hospital of Jerusalem to Robert de Danemarche of a tenement in the fee of Roger son of Alan in p St Mary Axe, paying therefore 28s pa, and the Hospital acquitting the tenement of 13s pa payable to the monks of B. [nd]
- A2215 Prior & convent of Holy Trinity grant to John son of Daniel a dwelling house in All Hallows Gracechurch between the land of the monks of SSB and the land of the nuns of St Helen's, paying 8s pa [John].
- B3123–25 All relate to land adjoining the land, cottage and garden in Rotherhithe adjoining land of the monks of B; 20 February 1423 to 23 October 1448. Deeds 2124–5 name the garden as *Gerardishawe*.
- C3146 Robert and Margaret Chircheman grant to stockfishmongers of London property including a messuage with two shops and gardens in p St Olave Southwark by the land called *Westwalleslane*, extending from the causeway between Bataillebrigg' and 'Bermondsey' on the east and the land of Sir William de Burcestre on the west. 22 May 1386.

#### vol iii

- A3998 Demise by Sir John, earl of Warenne, to Thomas de Watton for life of a messuage in Southwark and garden and curtilages paying 1m pa to the prior of B. Wednesday, All Hallows eve [31 October], 1274.
- A4048 Grant by Lawrence faber of B to William de Rokesle, citizen of London, and his wife Sarah of land in SMMB adjoining lands called *le Wylde* of the priory of B [Henry III].
- A4078 Demise by Adrian Aswy to Henry Garlaund and his wife Joan of a capital messuage in p St Olave Southwark for 12 years from midsummer paying a yearly rent to Earl Warenne, the monks of B and others. 39 Henry III [1254–5].

- A5451 Grant by Adam de Stratton clerk to Edmund de Watervord of land in the fee of Richmond in Benegho and elsewhere, which Adam had of the gift of the prior & convent of B. Annunciation [25 March] 1275.
- A5693 Grant by Adrian le Poleter and his wife Emma, sister of the late Henry Allegande, to Elias Russel citizen of London and his wife Juliana, of land in p SMMB adjoining the land of the prior of B called *Reyneresfeld* and abutting on the street called *le Gorestrete* [nd].
- Writ to the wardens of the temporalities of the bishopric of Winchester, in the king's hands, for the payment of an annual rent of 12m to the prior of B from the bishop of Winchester's manor of Southwark. 16 May 17 Edward II [1324].

Also: acquittance of the prior of B to the wardens for £4, part of the yearly rent of £8 due from the bishops of Winchester for certain mills etc in Southwark. Monday before St Barnabas, 17 Edward [II] (4 June 1324).

*Also*: a grant by Richard bishop of Winchester acknowledging that he has paid to the monks of B £8 pa for houses in the monastery of SBB, lying in the parish of St Margaret Southwark, and which he has given to his church of Winchester and his successors forever.

*Also*: acknowledgment by Henry bishop of Winchester that he holds lands from the monks of B at a rent of 40s.

Release by John Perioth of the parish of Cleve to Richard Tumbyrwode of the parish of Chalke, of all his rights in land in the said p, near a place called *Gaveland* adjoining the land of the prior of B and the land of the heir of Sir John de Cobham. 14 March 12 Henry IV [1411].

#### vol iv

- A7979 Feoffment by John le Cyrger citizen of London to Elyas Russel, citizen, of a garden in the town of B which has by gift of John Cole between the curtilage of Bermondsey Hospital on the east, the *commune iter* called *Shiteburland* on the west and the garden called *Beaurepeyr* on the north [after 1292].
- A7947 Feoffment by Hugh prior & convent of B to John the cook, their man, of land in B [nd].
- A7982 Reference to le watergang of the prior of B [nd: Henry III/Edward I?]
- A7982 Demise by Walter Forester citizen of London to Peter de Tenolio and the convent of SSB of his land in B for 30 years from the day of date, for which the prior has demised to him 6 acres of arable in *Southswansworthe* in the field of R called *Clerkeslonde*. Friday in Easter week, 43 Edward III [6 April1369].

A7993 Peter Hareng of B grants to William de Rokesle of London and his wife Sarah for 40s gersum a piece of meadow in p St Mary Rotherhithe between the prior of B's land and the way called *Scitinhalestrat*. Rent m at midsummer [nd].

A11652 Release by Adam son of Elias Russel to John de la Bare of London of his right in a curtilage in p SMMB 'next the curtilage of the chapel of St Mary in the church of the priory of St Saviour etc'. 4 Edward II [1310–11].

# vol vi

Grant by William Wylford, merchant tailor, to John Wyseman of London gent of his interest in a lease of the grange near the late monastery of B and all lands specified in a lease made to the said William, Ralph Wryne of Chester gent and his wife Ellen and Michael Inglysche deceased, by Robert Hogan gent. 23 April 35 Henry VIII [1543].

# CALENDAR OF MISCELLANEOUS INQUISITIONS

#### vol i **1219–1307**

7 February 1272: writ to the mayor and sheriffs of London to enquire as to houses, lands and tenements belonging to Simon de Monte Forti, late earl of Leicester, which have been granted to Edmund the king's son but of which Edmund has not yet had seisin. Inquest – Earl had on the day of his death a house in Westcheap nearly opposite the conduit whereof he was enfeoffed by Hamo de la Stronde. This is now held from year to year by Robert Heyron vintner of John de Edelmeton the elder, cutler, at a rent of 4m, of which John pays 40s pa to the monks of B.

7 September 1293: Writ to Malcolm de Harlegh escheater south of Trent: Henry late prior of B, on the eve of St Lawrence [9 August] presented Geoffrey de Wyttleburi, chaplain to John bishop of Winchester, to the vicarage of Camberwell, then void on the death of Thomas, sometime vicar, who died on the third or fourth day before the said presentation. The prior himself died on Friday after the feast of St Bartholomew last [27 August].

# vol ii 1307–1349

8 December 1323: commission to John de Weston and Hamo de Chigwell re an inquisition at the priory of St Mary Southwark where it was alleged that on Friday before Circumcision [31 December, if the year 1322 is meant] the prior of Bermondsey and others received and aided Jacominus Darynoun and other adherents of the rebels. The jury was unable to find that they were received by any of the city of London, but understood that they were received by the priory of B, Surrey (cf *Cal Patent Rolls*, p 358).

7 May 1337: writ to William Trussel, escheator south of Trent: inquisition at Southwark on 20 June found that Henry I granted the manor of Wadon to SBB (cf *Cal Close Roll*, p 195).

# vol iii 1348–1377

- no 42 15 October 1349: friars of St Augustine have acquired by the king's licence tenements in Bread Street ward for the enlargement of their house etc: they are charged with numerous yearly payments including one of 4s to B.
- 426 7 May 1360: commission to examine defects in the king's free chapel of St Martin le Grand and its possessions in Essex, Herts and Surrey, as left by William de Cusancia, dean. References to William's 'divers goods... in a locked

box in sanctuary in the church of B'. These were sequestrated by the sequestrators of the bishop of Winchester, and remain so.

- 28 January 1363: writ to the escheator in co Mddx: to enquire as to the tenure of a garden in p St Selpulchre [Holborn] taken into the king's hand by Willaim de Hatton, late escheator, because he had found by inquisition that Simon Carpenter had acquired it for the life of the prior of Bermondsey without licence. Inquisition, on 6 March, found that the owner of the garden was St Mary Clerkenwell.
- Wednesday in Easter week [5 April] 1374: inquest before the sheriff of Surrey: the church of Camberwell, worth £20 pa and the church of Warlingham with the chapel of Chelsham, worth 23m, belong to the priory of B: there is no prior as yet.

vol iv **1377–1388** 

no 275 14 October 1384: writ to the mayor and sheriffs of London to enquire into the petition of the priory of B re quitrents owed to them from lands late of John de Northampton, citizen and draper, convicted of treason. The property in question is at le *Steelyerde* in p All Hallows the Great by *le Heywharf*. Long before memory Nicholas Prudfote granted to SSB his land in AHG extending from the king's street called *la Roperie* on the north to the Thames on the south, and from the parish church on the east to the lane called *Steelverde* leading to the Thames on the west, from which the monks gave him 40m. This was confirmed in Hustin. Afterwards William prior of SS granted land with buildings to Edmund alderman and heirs at a rent of 18s pa. Richard Dunton, now prior, and convent always received it until Easter 1383, since when arrears amount to 27s, being a year and a half, which could not be paid because the premises were seized into the king's hand as a forfeiture on account of the treason of John de Northampton.

Tuesday after St John at Lateran gate [7 May] 1387: inquest before Robert Loxle escheator in Surrey: the prior of B has blocked the end of the same highway [*Trevetlane*] towards le Westwall, which abuts on the king's highway towards B, to the grievous nuisance of the whole neighbourhood.

vol vi **1392–1399** 

no 242 [26 October] 1397: an inquisition before royal officials in Essex finds that the prior of B holds a manor called Cowyk in Shering of the lord of the manor of Ouesham by payment of 100s on death or voidance of each prior.

vol vii **1399–1422** 

- no 238 12 July 1403: writ de causa captionis to John Savage, escheator in Somerset, re the manors of Preston Plucknett, Stone and Kingweston, said to have been taken by him into the king's hand. One the king's progenitors, which of them not known, gave Kingweston and Preston Plucknett with members etc to the prior, now called abbot, of B to celebrate divine service daily in the chapel of St Mary within that manor (cf *Cal Close Rolls 1402–5*, p 241).
- 20 April 1406: writ to the sheriff of Surrey for an inquisition said to have been taken by him at Southwark re a parcel of meadow called *Brokeshull* in Bermondsey and Rotherhithe the abbot of B and his predecessors have occupied 22 acres of land and 8 acres of meadow called *Brokeshull* in p Rotherhithe worth 6d per acre, which formerly belonged to the common of the township of Rotherhithe, as parcel of the house of B for 80 years last past, without licence or amortisement (see *Cal Fine Rolls*, vol xii, p 45).
- 12 Augusr 1417: re Preston Plucknett, Somerset, again: abbot John and his predecessors for the last 12 years have wickedly withdrawn the service of the chaplain in the chapel to the prejudice and loss of the king and his heirs. The manor is worth £20 net pa, for which sum it is let to farm (*Cal Close Rolls* 1413–1419, p 411)

# vol i 1226–57

- p 25 25 March 1227: inspeximus of a charter of Henry II to B: all lands, men, tithes, *res... parcis claudendis*, free of scot, gelds, aids, foresters. Theobald abp Canterbury, Richard bp of London, Hilary bp Chichester, Thomas the chancellor [1154–5].
- 3 November 1252: inspeximus of a charter of Edmund son and heir of Thomas Exeport, citizen of London, granting to Deutayntus Willelmi, Florentine merchant, land in p St Mary 'de Neuchirche', paying to the monks of B 8s 4d. Sir Roger son of Roger mayor of London, William son of Richard and Humphrey le Feuere sheriffs.

# vol ii 1257–1300

115 10 February 1269: grant to the prior & convent of B of a weekly market on Monday at their manor of Charlton, Kent, and an annual fair there on the vigil, feast and morrow of Holy Trinity.

#### vol iii 1300–1326

No 6. 4 July 1317: Inspeximus of a charter of Stephen: all lands which his said brother the bishop bought from their *soca* in Southwark *ad ospitandum se ita* quod pro omni servicio et redditibus quos inde antea per annum habere solebant reddantur prenominate ecclesie et monachi de B xl solidos singulis annis sicut conventio facta et confirmata est inter illos et sicut carte eorum testantur. At B.

# vol iv 1327–41

15 July 1330: Henry I: grants and confirms to SSB three *mansiones* of land, 36s 8d rent which Herbert son of Dudeman gives them from land he bought from William son of Hugh de Bochelande. He grants this for buying wine for masses. Also gives St George Southwark, St Andrew Holborn, Colemanchurch and the church of St George in London; the church of St Magnus Martyr by the bridge. Confirms the land Herbert son of Alfred gave them in Westcheap; 10s tithes from the demesne of Esta'tune which Hamelin de Baalun gave; 10s in the mill of Greenwich which Hugo Maminot gave, Wyde... which Ivo de Grantmesnil exchanged for Andredesb'ia which William de Belmeis gave them; the church of Harwidk and the tithe of the same vill and three hides of land in the same vill and a tithe of Upton which Winebald de Baalun. [spurious?] William abp Canterbury, Henry bp Winchester, Robert earl of Gloucester, Richard bp of London.

Charter of Stephen in favour of Faversham, dated at B.

#### vol 1:1272-1307

- p 64 22 January 1276: order to the sheriff of Surrey, escheator in that county, not to intermeddle with the temporalities of the house of B, which the prior thereof has committed during pleasure to the prior of Wenlock.
- 20 September 1275: grant, for a fine of £20, to Peter de Monte Sancti Vincentii prior of B, of the temporalities of the priory in the last voidance thereof.
- 7 October 1285: commitment, during pleasure, to Robert prior of Colongiis, of the priory of B now void.

1307-1319 nil

#### 1319-1327

261 15 March 1324: Commitment during pleasure to the king's clerk, William de Cusancia and brother John de Lodelawe, monk of B, of the keeping of the priory of B, void and in the king's hand, so that they answer at the Exchequer for the issues thereof.

1327-1337 nil

- 27 July 1337: prior of B £100; mainpernour William de Cusancia, clerk, co York
- 16 June 1340: restitution to the prior & convent of the priory of B that the priory, with knights fee, the keeping whereof the king committed to the prior for £100, saving to the king any apport which the prior is bound to pay to any superior house; and grant that they be quit of the tenth granted by the clergy of the realm for the present and following year, a petition having been made on behalf of the prior and convent that whereas they have sustained and do sustain many losses through floods of the Thames in the lands, meadows and pastures belonging to that house, and that the house is much depressed by divers other charges, the king would cause his hand to be removed therefrom for a prompt subsidy to be granted as above; to which petition the king assents because the prior has consented to pay £50 etc.
- 6 March 1342: commitment to the priory and convent, at the request of the king's clerk, William de Cusancia, treasurer, brother of the prior, of the keeping

of that priory and lands, possessions, goods etc, which the king by letters patent dated 16 June 14 Edward III [1340] restored to them for £100 per annum and afterwards resumed into his hand by advice of the council; to hold with knights fees and advowsons of churches during the war with France at a rent of £50 per annum at the Exchequer... a petition having been made... that this house is so depressed by the causes specified... that all the possessions and good belonging to the priory can scarcely suffice for the sustenance of the prior and monks there serving God. Grant also to them that they be quit of tenths etc.

#### 1347-1351

301 16 June 1351: whereas the king lately committed to the priory of B together with lands and possessions thereof to Brother John de Cusancia, prior of that place, to hold for as long as the war with France should last, at a certain yearly farm, and the said prior has gone to Rome with the king's licence to further the business of his house, and the king has learned that a certain monk of the house, who was deputed by the prior to have the rule of the house and its goods, has so wasted the rents and good of the house during the prior's absence that a great part of the said farm is in arrears and there is good reason to fear that the king cannot in future be answered for such farm out of the goods of the house unless a remedy be quickly applied; he has therefore committed the keeping of the priory, and of the lands, goods and other things pertaining thereto, to William de Cusancia, brother of the prior, William de Stanstede, Brother Henry de Morle, monks of the priory, and John de Lambourn to hold during the absence of the prior as he had it before and would have it now, if he it were present, provided that they dispose thereof as shall seem most to the advantage of the house, answer to the king touching his farm, find fitting sustenance for the monks, household and servants of the house, and support all the other charges incumbent on the priory and its lands.

#### 1356-1368

pp 140–1 15 October 1360: commitment to brother John de Cariloco, prior of B, of the keeping of the said priory and all its lands, possessions and goods on the same terms as it was committed on 6 March 16 Edward III [1342] to the prior and convent, as Henry prior of St Milburg, Wenlock, and vicar-general in England of the priory of La Charité, to whom it belongs, to provide for the care and rule of priories in England... has shown the king that brother John de Cusancia, last prior of B, has resigned the priory into his hands and that he has appointed the said John de Cariloco to be prior, praying the king to commit the keeping of the priory to the latter.

# 1369-1377

94 12 November 1370: Robert Crull lease of *la Daierie*, formerly of Walter Forester

- 132 10 November 1371: Prior Peter de Tenolio, alien prior of B, touching the keeping of the same with issues, from 11 June 43 Edward III [1369] for a yearly farm of £20 for the first two years, and £40 thereafter.
- 18 January 1374: appointment during pleasure of brother Richard de Dounton as keeper and approver of the priory of B (now void by the death of the late prior and in the king's hand on that account and by reason of the war with France) and of all lands and possessions pertaining thereto.
- 18 January 1373 [sic]: Same to Richard de Dounton: £40 per annum to the Exchequer.
- 250 14 June 1374: commitment to brother Richard de Dunton of the keeping of the priory, lands and possessions

12 October 1377: grant to brother Richard de Dunton prior of the keeping of the priory, lands and possessions for as long as they shall remain in the king's hand on account of the war with France.

1383-1391 nil

1391-1399 nil

1399-1405

19 17 November 1399: Commitment to John Attilbourgh abbot of SSB and Thomas Styward, of manors of Cluny, to hold during duration of the wars with France.

1405-1452 nil

1452-1461

30 January 1455: commitment to John abbot of B and Thomas Melford monk of the keeping of the soil of a certain hospital, called the hospital of St James, which the prior of St James Derby lately held, at the north end of the lane of St James in the town of Derby and in which the said prior used to lodge poor wayfarers and infirm persons, the said hospital being totally laid waste and for that reason in the king's hand; to hold from Christmas last for 50 years, rendering 12d per annum.

3 June 1460: commitment to Thomas Wente of the keeping of a grange in Depford Stronde and a small wood and 7 acres of arable land adjacent to the said grange, and 62 acres in a meadow whereof 10 lie in Rotherhithe in a meadow called *Erlis Clowis*, 3 acres in a meadow of the abbot of B, etc, in the king's hand by the high treason, insurrection and rebellion of the late Richard, duke of York.

1461-1471 nil

#### 1471-1485

nos 880–2 29 March 1485: re the tenth payable at midsummer next and midsummer 1486, excepting various houses including SSB.

# 1485-1509

no 140 13 April 1487: re the tenth: various houses including B to be excepted on account of 'floods, fires, ruins and accidents'.

#### CALENDAR OF CLOSE ROLLS

- 13 December 1232: for the prior of B: mandate to P de Rivall' that he should let the p of B have full seisin of land a mill at Querendon, which he had leased to Peter de Grendon, chaplain of R. once earl of Chester and Lincoln and which Peter leased on the earl who held it until his death, when it was taken into the king's hands with the earl's own lands.
- 409 24 April 1234: mandate to Peter de Rivall' that he should let the p of B have 10 oaks from the forest of Essex by the king's gift *ad operationem capelle Sancti Crucis, quam construi facit* at B.

- 209 16 November 1235: at the petition of Brother Laudric' pr of La Charité to admit Peter, whom La Charité have sent to England from overseas, as prior of B. And the Crown escheators are to give full seisin of priory lands, taken into the king's hands on the death of Hugh, the former prior.
- 2 August 1237: the pr of B attorns Walter le Clerc *ad lucrandum et perdendum in loquela* in Surrey between Roger of London, plaintiff, and the said pr, def, re 38 acres of land in Rotherhithe.

# 1242-47

- 1 January 1246: order to the constable of the Tower to go with the sheriffs of London and the bailiffs of Surrey to B to see whether any money has been collected for the use of the abbot of Cluny against the king's prohibition and deposited *in archa vel cofinis* and, if they find any, to seal it with their seals and forbid the prior *sicut tenementa sua que habet in Anglia diligit*, to move any of it without the king's knowledge.
- 108 13 December 1247: re converti sent to abbeys, including B:

Willelmus conversus: prior de B

- 14 24 November 1251: king's justices at B
- 22 August 1252: Brother Aym' prior of B approached the king at Missenden on Thursday after the octave of the Assumption [22 August 1252] and did fealty to him. He is to have full seisin of all possessions of his priory.
- 7 October 1253: Mabel the convert received from the pr of B one mark *pro exhibucione sua in domo predicta* for two years from [2 February] next

23 July 1254: prior of B included among those quit of summons to Buckinghamshire (list begins with the prior of Merton excused *propter egritudinem tibie sue*).

# 1254-56

- 183 12 December 1255: justices at B
- 25 April 1256: order to Richard de Muntfichet, keeper of the royal forest of Essex, to return the the prior of B his wood (*boscum*) at Hallingbur', which he took into the king's hands in that the keeper of the wood did not come to a certain summons of foresters.

# 1259-60

- After 7 July 1260: to the dean of St Paul's: not to hold a plea to the prejudice of the Crown in a court Christian concerning the chattels of Gregory of London layman, as we learn from a certain faithful man has come before you on the authority of the lord pope.
- 5 April 1261: re tallage of Crown demesne and the manors of Dulwich and *Legham*, held by the pr of B and once of the ancient royal demesne: to tallaged 'reasonably' by the sheriff.
- 13 May 1261: Geoffrey de Norhant, to whom Wenlock was committed during its last vacancy, to pay the pr of B 20m in damages done during that period. If he doesn't, to be levied from his lands and chattels.

- 10–11 12 December 1261: Arnald, monk of B, detained in our prison of London for the death of Richard de Borham, *unde rettatus est, rettatus est de morte illa odio et atye et non eo quod inde culpabilis sit.* To find 12 lawful men to pledge for him. As a monk, he cannot answer to a lay court.
- 8 January 1261: Quit of common summons to co Bucks
- 109 20 February 1262 ditto for Essex
- 134–5 24 August 1262: justices at B
- 273–4 22 December 1262: quit of summons to Somerset and Essex

- 1263 (nd): pr of B attorns by Brother John de Upton and Richard de Sutton before the itinerant justices re a writ of right between Alice Oytdeniers, Walter son of Anddrew and his wife Agnes, plaintiffs, against the prior, def, re 4½ acres of land in Camberwell.
- 297 20 March 1263: pr of B empowers John de Upton his monk to act for him in the period up to St Peter ad Vincula (1 August).

20 February 1266: for Thomas de Rowell, to whom were lately committed the abbey of St Mary Winchester and the pr of B; in short vacancies he received nothing.

#### 1268-72

- 8 kal January 1268/9: Ivo of Cluny has granted to Sir Imbert de Monte Ferrando his two manors in England, Offord and Tykesore with the advowsons of their churches, paying 40m pa to the priory of B for all services
- April 1271: John pr of B is bound to Adam de Stratton in £40, with powers of distraint. A letter from John of Cluny re a debt of 700m to the same.

  Acknowledgment by B that they owe Stratton 700m. Powers of distraint on their lands in Surrey and Kent.
- 4 November 1272: pr and convent of B have delivered to our wardrobe and its keeper Peter de Wintonia on Friday St Martin, 57th year [11 November 1272] £20, making an end of the custody of the priory at the present vacancy.

- 17 March 1273: the pr of B, going overseas by the king's licence, puts in his place Brother Ralph de Derby, monk of B, and William Godyn in all pleas till St Peter ad Vincula [1 August] next.
- 9 January 1275: the abbot of Hyde, Winchester, puts in place William de Kancia and John Trencheful in a plea of trespass between him and Henry pr of B and numerous others.
- 403 20 September 1277: Guy prior of Montacute re money due to the king from the time when the prior of Thetford and the prior of Bermondsey held the manor of Lodecumbe: they owe it.

46 27 March 1280: quittance of common summons of the eyre in Somerset

#### 1288-96

- 21 January 1290: to the sheriff of Essex: to deliver to the pr & monks of B the manors of Wydeford, Cuwyk and Richemund, which they indiscreetly demised to Adam de Stratton and which have now come into the king's hands, and to deliver the year, day and waste and the corn sown in the king's lands, as the king has granted them the same estate in the manors as they had before the demise. The like to the sheriff of Berkshire for the manor of Optone.
- 378 27 November 1293: quittance of summons of eyre in Surrey

#### 1296-1302

- 27 April 1299: the prior of Wenlock and pr of B acknowledge that they owe William de Hamelton clerk 390m to be levied in default of payment from their lands and chattels in Salop and Surrey.
- 20 July 1302: to the constable of Dover and warden of the Cinque Ports: to permit the prs of B and Wenlock to cross to their chapter general at La Charité on condition they carry with them no money or silver contrary to the form of the king's inhibition.

- 18 December 1307: request to several local heads of houses including B for carts (2) at Westminster on St Stephen's day to carry vessels and equipment of the king's household to Dover. Cost of men will be paid.
- 207 11 April 1310: to the abbot of Cluny: request that he provides at his next general chapter Brother Peter de Sancto Laurentio, monk and almoner of B and brother of the king's yeoman John de SL, with a fitting priory of his order in England, as the king wishes to procure him promotion.
- 4 December 1309: the pr of B acknowledges that he owes John de Dynteon clerk £260 to be levied, in default, in Surrey and Kent.
- 9 October 1311: Henry pr of B acknowledges that he owes John de Bevarlar' clerk £60 to be levied, in default of payment, in Kent, Surrey and Sussex.

- 23 August 1312: to the prior of La Charité: a letter commending to him Brother Peter de SL monk of B for election as pr of B, void by death of H, the last prior, and desiring him to write to the king by the bearer hereof of his proceedings.
- 8 December 1312: pr of B acknowledges that he owes John de SL the elder 100m, to be levied in default in Kent, Surrey and Essex
- 4 May 1313: William de Topclyve, who has long and usefully served the king, is sent to the pr and convent of B to receive the necessaries of life in food and clothing in place of Thomas le Long.

- 130 24 November 1314: to the treasurer and barons of the Exchequer: to discharge the pr of B of issues of the priory when in the late king's hands, who it over on 24 September 23rd year [1295] because it was in so much debt that its goods were insufficient to pay its debts, and who committed the custody to David le Grant clerk so that he should expend all the issues of the house, saving the maintenance of persons without whom the priory could not be ruled, in blocking up the embankment (berce) of the priory broken by inundation of the whereby the priory and lands about it were at that time submerged... the late king having afterwards, on 13 December in the 26th year [1298] taken the fealty of Peter de Sancto Simphoriano, monk of that house, whom the prior of La Charité had made prior of B, and restored to him the temporalities... order to discharge the prior of issues from 13 December 1298.
- 20 July 1314: pr of B acknowledges that he owes Adam de Osgoteby £20 to be levied in default in Middlesex.
- 28 April 1316: pr of B acknowledges that he owes Ebulo de Montibus kt 16m to be levied in default in London.

- 222 25 February 1320: pr of B acknowledges that he owes John Francisci and Magnus Frugerii merchants of Florence 100m, to be levied in default in Surrey.
- 26 October 1320: to Mr Henry de Clyf and Adam de Brom', the king's clerks; not to meddle further with the custody of B, as the king has amoved his hand in the hope that the prior will so rule that religion and the king's alms in this behalf may be properly kept and maintained.
- 21 November 1320: to the prior of La Charité. Request to recall the present prior of B and abstain from sending him another till the king informs him of some circumspect and industrious religious man, although the king lately

requested him to abate the malevolence and matter of suspicion that the prior of La Charité conceived in the present prior, as it was feared, and that he would hold the prior of B wholly excused because he had not obeyed the voidance of him made by the prior of La Charité at his chapter general, at which time the king was not fully acquainted with the state of the priory, as the king now notifies him that the value of lands, churches and rents demised during the time of this prior for life and for terms of years amounts to £292, and that the money thence arising is now wholly exhausted, as was found by those whom the king deputed to survey the state of the priory.

- 8 February 1321: to the prior of La Charité, thanking him for his reply and nominating John de Cusancia, monk of Lewes, as prior. He asks La Charité to present him as soon as possible, and hopes that the house will be reduced to better state by John's regular and wholesome examples, wise solicitude and circumspect diligence.
- 1 October 1321: to Geoffrey de Somersete subprior of B and Mr William de Hallingeo, parson of Newenton. Not to intermeddle further with the custody and to restore all goods to Peter de Sancto Laurencio, who is to have the custody and rule of the temporalities of the priory, hoping that he will henceforth conduct himself discreetly in the governance of the house.
- 699 4 March 1323: William Bale, who has long served the king, is sent to the priory of B in place of William de Topclif deceased to receive for life such maintenance as the latter received.

# 1323-27

- 310 15 September 1324: to the abbot of Cluny. Requests that he nominates James de Cusancia, prior of Prittlewell, and John his brother, prior of Bermondsey, to the [?envoys] of the earl of Surrey, patron of Lewes priory...
- 6 November 1324: John pr of B acknowledges that he owes John de Tyringham £40 to be levied in default in Surrey.

#### 1327-30

215–6
12 August 1327: to the prior of St Mary of La Charité: Brother Walter de Dulydz, late prior of B, has come to the king and shown him that whereas he lately obtained the priory of B by the promotion of the said prior of La Charité and held the same for a long time, Mr Robert de Baldock, then the late king's chancellor, falsely and maliciously charged upon Walter that he was of the quarrel of Thomas, late earl of Lancaster, to pursue Hugh le Despenser, and that he had harboured in the priory Peter de Monte Martini, Percival de Arenton and James (*Jakeminum*), his brother, who, it is said, had conspired for the death of Robert by reason of the said quarrel, and Robert caused Walter to be taken and detained

in the Tower of London until he, under fear of perpetual imprisonment, resigned the priory and promised to go out of the realm with all speed; under which pretext Walter was amoved from the priory and another was substituted in his place (though he resigned under protest). As it was ordained in the late parliament at Westminster that all persons who were of the said quarrel should be restored to their possessions and things from which they

were removed by reason of the quarrel, the king, considering the good behaviour of Walter, who laboured watchfully and diligently about the relief of he estate of the priory when he had the rule thereof, requests the prior of La Charité to restore Walter to his possession of the said priory, according to the said statute, having consideration of the fact that Walter at the time of resignation was in prison and in the hands of those ferom whom he could not escape unless he obeyed their will in all things. The prior of La Charité is enjoined to conduct himself so on this behalf that it shall not behove the king to ordain another remedy through his default. The king hopes that the estate of the priory of B, which is impoverished and wasted for want of good government, will be improved by Walter's prudence and will receive wholesome increase. The prior of La Charité is desired to write back by the bearer hereof what he will cause to be done in this matter.

- 4 May 1328: to Roger de Gildesburgh and Nicholas de Acton: order not to intermeddle further with the custody of the priory of B, which the king committed to them by reason of the dispute between brother Walter de Dulvyd, pretending to be prior thereof, and brother John de Cusancia, the prior, and to permit the prior to dispose of the priory and its possessions and good as shall seem fit to him, as concord has been established between Walter and the prior.
- 6 May 1328: enrolment of a deed of Nicholas de Tunstalle, witnessing that whereas brother Peter, late prior of the house of SBB and convent of the same have given to him a corrody, to be received in their house for life in the form following, to wit each day of his life a white monastery loaf price ½d, a brown (bissum) loaf price ½d, a gallon of monastery ale price 1d, half a gallon of the second ale price ½d in their cellar at B; two dishes (fercula) of meat every one of the four meat days in the week, price 1½d a day, from their kitchen, and on the three other days of the week fish or other things in he same way as a monk, price 1½d a day, and each day two dishes of pottage price ¼d from the convent kitchen; and they have also granted to him each year for his life a robe with fur lining of the suit of their clerks or esquires at his will, price each year 20s, to be received from their chamber at Christmas, and they have also granted to him a house to live in within their enclosure of B, with a plot of land near the said house adjoining their court and the wall of John le Maserer, between the kitchen

and brewhouse of the priory, 66 ft in length and 20 ftr wide, and a pond and curtilage between the said brewhouse and the new garden of the prior and convent, whereof one end aburts upn the lane leading to their barns, and the other upon the highway to Retherheth, with free ingress and egress at his pleasure, and also every year four cartloads of wood from their wood and two cartloads of straw (*litere*) to be carried to his house at B at their cost, and also two acres of meadow enclosed by a ditch in their meadow under Danieleswall, for his life for the maintenance of his horses, as contained in an indented charter of theirs made to him; and they afterwards granted to him for life a part

of their new garden with the apple trees and other trees therein lying between his curtilage and the said new garden, in length 26½ perches, one end of which abuts upon the lane leading from their court to their barns, in breadth 2½ perches, and the other end abuts upon the highway to Retherheth, in breadth 3½ perches, with ways (*vinis*), hedges, ditches, free ingress and egress... and the king has recited and confirmed the aforesaid two charters in his charter to Nicholas; the said Nicholas has now, in consideration of £40 3s 4d paid to him by John de Cusancia, the present prior, rendered the aforesaid three charters to the prior... and he releases all his right in the premises and all his actions against the priory by reason of this corrody.

#### 1330-33

- 30 January 1330: John prior of SBB acknowledges that he owes Hildebrand Suderman 60m, to be levied on default in Surrey.
- 168 12 Decmeber 1330: prior of SBB acknowledges that he owes the executors of Geoffrey de Eyton £120, to be levied on default in Essex and Sussex.

#### 1333-37

29 February 1336: to William de Clynton, constable of Dover and warden of the Cinque Ports: permit John pr of B to cross with £20 for his and his household's expenses.

- 182 15 September 1337: sheriffs of Surrey and Sussex: to desist making distraints on pr of B to whom the king has committed the custody of that priory and all its possessions for paying £100 pa.
- 12 October 1337: to William Trussel escheator this side of Trent: not to intermeddle with 10 acres of land of the pr of B in Waddon, since this was granted by Henry I not by a subject since the Statute of Mortmain.
- 7 March 1338: collectors in the bishopric of London, for the priory of B, paying £100.
- 9 February 1338: John pr of B acknowledges that he owes Alan de Whiteby 20m, to be levied on default in Surrey.
- 8 March 1338: To the treasurer and barons of the Exchequer: to permit the pr of B to have respite until Michaelmas next for £100 which ought to pay yearly for the custody of his priory, as the king has granted his respite in consideration of damage suffered by him suddenly and without his fault after he had the said custody.

8 July 1338: to the pr of B: to pay £31 4s of the £50 he owes for custody until Easter next, for which the king gave him respite till Michaelmas next, to William de Cusance.

# 1339-41

20 April 1339: to John de Warenne, earl of Surrey and keepers of maritime lands in Sussex: orders to supersede the exaction made on the pr of B to find men at arms or other armed men by reason of his lands in that county, as he has shown the king that although his priory was taken into the king's hands as an alien priory, and the prior holds the custody thereof at will for rendering a certain farm yearly, yet the deputies appointed by the keepers distrain him fo find four men, pretending that he and his predecessors had supported such charges. The prior claimed in council that the charge is included in the farm.

#### 1341-43

- 132 11 May 1341: pr of B acknowledges that he owes P de Sancto Johanne £40 to be levied in default in Surrey.
- 12 October1341: John de Cusancia pr of B acknowledges that he owes John Roce fishmonger of London 40m. To be levied on default in Surrey.
- 501 5 April 1342: John de Cusancia pr of B acknowledges that he owes William Neel citizen of London £500. To be levied on default in Surrey.

# 1343-46

- 16 February 1343: John pr of B acknowledges that he owes William de Huntyndon *lynedraper* 40m. To be levied on default in Surrey.
- 19 March 1344: John de Cusancia pr of B acknowledges that he owes William Pecok citizen of London £40. To be levied on default in Surrey.
- 24 October 1345: to the treasure and barons of the Exchequer: to allow to the pr of B what is in arrear to him of a rent of 12m pa from certain lands and mills in the bishop of Winchester's manor of Southwark for the time of the present voidance of that bishopric, and to allow him that rent henceforth so long as the temporalities of the bishopric are in the king's hand.

- 28 March 1346: John pr of B acknowledges that he owes John la Porta prior of Montacute130m. To be levied on default in Surrey.
- 17 September 1346: pr of B acknowledges that he owes Sir Richard de Wylughby £60. To be levied on default in Surrey.
- 14 January 1347: Robert le Chaundeler by reason of good service to Queen Philippa is sent to the pr of B to receive such maintenance in that house for life as Nicholaa sometime wardress of Queen Isabel had of them at the king's request.
- 28 April 1327: John de Cusancia pr of B acknowledges that he owes William de Osberston clerk £100. To be levied on default in Surrey.
- 7 November 1347: John de Cusancia pr of B acknowledges that he owes William de Osberston £200. To be levied on default in Surrey.
- 18 March 1348: Adam Sonce and John Sonce of Lesnes acknowledge that they owe the pr of B £80, to be levied on default in Kent.

- 10 July 1349: John pr of B acknowledges that he owes John Besevill of London 24m. To be levied on default in Surrey.
- 1 March 1350: John pr of B acknowledges that he owes Robert de Guldeford of London draper £40. To be levied on default in Surrey.
- 228 28 May 1350: John pr of B acknowledges that he owes Henry de Ingelby clerk £40. To be levied on default in Surrey.
- 238 15 July 1350: John pr of B acknowledges that he owes Robert atte Brome clerk £100. To be levied on default in Surrey.
- 16 March 1353: John de Cusancia pr of B acknowledges that he owes Richard de Wyght 50m. To be levied on default in Surrey. Enrolment of deed by which the pr of B grants to him a pension of 5m for life. Dated Saturday after St Gregory 27 Edward III [16 March 1353].

- 27 June 1355: John pr of SSB acknowledges that he owes Edmund de Acre clerk £100. To be levied on default in Surrey.
- 28 October 1355: John de Cusancia pr of B acknowledges that he owes William Tauk £9. To be levied on default in Surrey.

- 1 February 1356: Enrolment of a grant made by John de Cusancia pr of B to the king of a messuage and toft in Retherheth held of the gift and fee of Peter de Cusancia clerk of John Lambyn of Colchester citizen of London, and also a toft with a pond made therein lying near that messuage on the east towards Greenwich, also a messuage lying near the porch of the said messuage towards the Thames, which Sarah the late wife of Stephen de Estmere holds for life of their demise with reversion after their deaths to the pr and convent, shall remain to the king on Sarah's death. Dated in chapter at B, 27 January 1356.
- 2 July 1357: John pr of B acknowledges that he owes Thomas de Neuton parson of St Michael le Querne, John de Litlyngton parson of St Benet Paul's Wharf and Robert de Keteryngham parson of St Gregory £20. To be levied on default in Surrey.
- 328 30 October 1356: John pr of B acknowledges that he owes Sir John de Cobham £100. To be levied on default in Kent.

30 June 1361: John Romeseye to the priory of B for maintenance. Geoffrey de Sessouns and Colet his wife.

#### 1364-68

- 30 January 1364: to the treasurer and barons of the Exchequer: to stay their demands made by summons of Exchequer upon the priory & convent of B for £20 16s 9d, discharging them thereof; as out of compassion for the estate of the said priory the king has pardoned them that sum, being the arrears of £50 which the prior thereof lately granted to the king of his priory for a subsidey, the said priory among other houses of the alien religions of the power of France in England by then in the king's hand by reason of the war with France, and to them [committed] on 16 June in the 14th year of the reign [1340].
- 6 30 January 1363: to the same re the same.
- 174 16 May 1365: Philip Mongomery to brother Peter prior of B, John Hurdecote and William de Henton: recognisance for £40 to be levied, in default of payment, of his lands and chattels in Somerset.
- 193 18 October 1365: Philip Mongomery to Peter prior of B re the same.

12 January 1385: to the mayor of London and escheator there. Order, on a petition from the prior of B, so long as the same shall be in the king's hand to pay him and his attorney a quitrent of 6s pa from two shops and two dwelling houses at the west end of the Old Fishmarket in p St Mary Magdalen, and a quitrent of 18s pa of divers lands at the *Steelyerde* in All Hallows the Great by the *Heywharf*, and all arrears since the premises were taken into the king's hands: they were once of John of Northampton. The 6s rent was given by Thomas Haverhille in alms to the church of SSB to find a lamp before the altar of St Mary in the infirmary of that house.

#### 1392-96

5 March 1397: To Angelus Christofori, a Lombard, for 9m payable to Walter Londoun, a monk of B priory.

# 1396-99

- 6 June 1397: to the sheriffs of Surrey: writ of supersedeas and order by mainprise of John Wolverton, Thomas Bircestre, Roger Barbour and Richard Courteour of Southwark at the suit of the pr of B for trespass.
- 31 October 1397: to Eleanor who was the wife of Thomas late duke of Gloucester: order at her peril for particular causes to cause the duke's body to be brought to B priory, and there kept within the church until further order, although the king lately ordered Richard Maudeleyn his clerk to deliver the body, which was by command of the king in his keeping, to the said Eleanor or her attorney for burial within the church of St Peter Westminster.
- 389 18 July 1398: to the sheriffs of Surrey: writ of supersedeas and order by mainprise of Robert Denny of Cambs, Thos Gerberge of Norfolk, John Roger of Herts and Henry Piers of Surrey esq to set free John Cartere the younger, if taken at suit of the king [and] the prior of B for leaving the prior's service before the term agreed.

# 1399-1402

30 March 1399: to the arrayers appointed to array abbots, priors, men of religion and other ecclesiastical persions in the diocese of Winchester: not to meddle in the arraying of the abbot of SBB or his monks his fellows by reason of their possessions and means in that diocese until further order; as the abbot has mainperned in chancery that he shall arm and array himself and them at the abbey according to his power, and by the heedlessness of the last abbot the abbey is so burdened with corrodies and debt that the possessions and means thereof avail not to suport needful charges, as the king has true information.

- 9 March 1400: to the abbot and convent of B: request to admit to their house Peryn de Archemont, king's clerk, whom the king is sending, and to administer to him such maintenance as any other king heretofore had therein by grant of the king's forefathers, making and delivering to him letters patent under the common seal of the house with mention of what he shall take, and certifying to the bearer what they shall do: as for his praiseworthy service the king's will is to make provision of the maintenance of the said clerk, for which no provision is yet made.
- 21 October 1403: Thomas Fermour is sent to the abbot and convent to take such maintenance as Peter ['Peryn' in the warrant] clerk of the king's chapel deceased had therein.

- 12 January 1403: to the escheator in Somerset: order to remove the king's hand from the manors of Kynwardeston and Preston by Yevele, and the issues thereof taken, as it is found by inquisition that the manors were given to B by one of the king's forefathers (which one, unknown) to find two monk chaplains residing at the manor of Preston to celebrate daily in the chapel of St Mary there for the souls of the faithful departed.
- 20 July 1404: to the abbot of B, collector in the archdeaconry of Surrey of the tenth granted to the king in the convocation of the province of Canterbury, for £66 13s 4d.
- 413 20 October 1404: ditto for £40
- 415 28 October 1404: ditto for £20

- 21 June 1406: to the escheator in Surrey: to remove the king's hand in favour of the abbot of B in respect of 22 acres of land and 8 acres of meadow in the parish of Rotherhithe called *Brokeshulle*, held for 80 years past by the abbot and convent and predecessors as parcel of their house with licence of the king and with amortisement, and sometime of the commons of the township of Rotherhithe, every acre being worth 6s pa.
- 26 March 1406: John bishop of Artesfert to Henry abbot of SSB and convent and successors, quitclaiming a pension of £20 pa which by charter under their common seal they granted to the bishop for life, by name of John Attilburgh, to be taken of all their lands in Surrey. Dated 20 March 1406.

- 2 June 1413: to the abbot and convent of B: nomination of Mr Nicholas Colnet the king's clerk and serjeant, his physician, to receive the pension wherein by reason of the abbot's new creation they are boudn to one of the king's clerks, until by them provided with a benefice.
- 3 June 1415: to the abbot and convent of B: order to take again their letters concerning a maintenance for life in their house which Thomas Ferrour has at the request of the late king, to admit Reynold Pope the king's serjeant to their house and administer such maintenance to him, etc; as TF is minded to demise his estate therein to the end that RP may have it at the request of the king.
- 28 January 1417: Thomas Tunbrigge yeoman of the king's kitchen is sent to the abbot and convent of B to take of that house such maintenance as Ralph Pope esq deceased had by gift of the late king.

#### 1429-35

- 19 February 1433: to the abbot and convent of B: nomination of John Croke one of the clerks within the receipt of the Exchequer to receive the pension wherein by reason of the abbot's new creation they are bound to one of the king's clerks, until by them provided with a benefice.
- 300 28 January 1434: to the abbot and convent of B: request to admit to their house Thomas Franke, one of the clerks of the office of the privy seal of the king and the late king, whom with advice and consent of the council the king is sending to them in consideration of his good and unpaid service no small time, and to minister to him for life within the abbey as Thomas Tunbrygge esq deceased had, with houses or a dwelling within the same, which TT or any heretofore possessed of such corrody by gift or command of the former kings had... making him letters patent under the common seal...

# 1435-41

6 March 1439: to the abbot and convent of B: order to take again and cancel letters patent under the common seal of the abbey concerning a corrody or maintenance therein which Thomas Franke one of the king's serjeants has even as Thomas Tunbrygge had, to admit to their house TF and his wife Elizabeth, and minister the same to them... as TF is minded to surrender his said letters to the end that he and his said wife may have that corrody for their lives...

20 November 1447: Robert Fraunceys esq of Fornwerk, co Derby, son of Sir Robert Fraunceys kt and of Isabel his wife, to Thomas Chalton and Alexander Orable, citizens and mercers of London, heirs and assigns; quitclaims of a tenement in the market of Derby on the north side of the tenement of the abbot of SSB, to wit between the market on the east and the house of St James Derby on the west. Dated 20 May [1447].

#### 1461-68

- 12 December 1461: William Philpot groom of the king's cellar is sent to the abbot and convent of B near the city of London, to take such corrody as any other person had therein.
- 26 June 1462: John Kendall esq the king's servant and Margaret his wife are sent to the abbot and convent of B to take such corrody or maintenance as William Philpot groom of the cellar or any other person had.
- 438 4 July 1467: Margaret Stanlowe widow to John bishop of Coventry and Lichfield, John abbot of SBB, George Dawne chaplain and Thomas Quyne, executors and assigns. Dated 11 May 1467.

# 1485-1500

- no 618 22 May 1491: the abbot of B mainprised (along with innumerable others) £200 for the loyalty of Thomas marquis of Dorset.

- 21 November 1234: grant to the pr of B that the king, on account of certain land which he has granted to the parson and parishioners of the church of St Magnus in the city of London for the enlargement (*ad ampliationem*) of the said church, the king does not and will not claim any right for him and his heirs in the advowson of the said church.
- 3 September 1235: justices for Surrey, Kent, Sussex and Hants to meet 'at B' in the octaves of Michaelmas
- 223 10 June 1238: royal assent to the ordination by Theobald, prior of La Charité and the convent of that place, of Brother Guichard to be prior of B; with mandate to the tenants to be intendant upon him.

- 7 March 1259: protection with clause, until a year after Easter, for Eymo prior of B, going to the general chapter of Cluny.
- 5 August 1261: writ de intendendo to the tenants of the prior of B in favour of Gilbert de Bussa, monk of that house, preferred to be prior thereof by the prior of La Charité. Mandate to Richard Oysell, guardian of the said priory, to give Gilbert seisin of the temporalities.
- 8 June 1261: appointment of the prior of B and Edward de Westminster to take fealties in the king's name of the men of the abbot of Westminster; the like, to take fealties of the men of Bermondsey priory.
- 17 August 1265: Simple protection till next Easter of numerous including the prior and convent of B.
- 30 January 1266: commitment to Thomas le Rowell, king's clerk, of the priory of B to keep during the king's pleasure, so that he answer for the issues at the Exchequer.
- 5 February 1266: mandate to Thomas de Rowell, king's clerk, keeper of the priory of B, to restore the temporalities thereof to John de Chartres, monk of La Charité, whom Miles prior of the church of La Charité has appointed to be prior of B and presented to the king as is the custom.

- 20 July 1269: confirmation of commitment by Brother Miles of La Charité of the priory of St Andrew Northampton to John, prior of B, to govern
- September 1269: an annual render to the prior and convent of B of 10m at midsummer, inter alia, by Adam de Stratton, holding for his life St Michael Winterbourne Monkton's manors of Winterbourne, Buketon and Swanwych, with advowson of the church of the manor of Winterbourne.
- 12 April 1272: confirmation of a grant by John de Burgo, son and heir of Hubert de Burgo, earl of Kent, to the church of SBB of his whole manor of *Chaure* with advowson of the church of that town (also spelt *Chaucre*, *Chalcreria* in the same item); and also grants to the same by John son of John de Burgo and by William de Appeltrefeld.
- 12 November 1272: mandate to the subprior and convent of B to whom the king, for a fine of £20, lately committed the keeping of their priory in the then instant voidance, in favour of Henry de Monte Mauri, whom the said Miles has appointed to be prior of their house. - 9 June 1309: commission *de walliis et fossatis* to John de Foxle, Walter de Gloucester, Masters Richard de Abyndon and Henry de Guldeford, on representation of the prior of B and John de Drokenesford, king's clerk, touching a breach of the bank and dyke of the Thames, near B, and the loss and damage consequent thereupon to them in B and West Greenwich, in Surrey and Kent.

- 9 January 1324: appointment of Mr Henry de Clif' and Robert de Swaleclif to the custody of the priory of B, Walter de Lutz the prior having been put in prison for certain causes. Writ *de intendendo* to subprior and convent.

- 397 13 March 1324: safe-conduct till midsummer to Walter, late prior of B, to his native country, the king having remitted his indignation on account of offences committed against him by the prior, for which he was indicted, and willing that he should return home.
- 18 April 1324: mandate to William de Cusancia, king's clerk, and John de Lodelawe, monk of prior of B, keepers to restore the temporalities thereof to John de Cusancia, monk the Carthusian order, preferred to be prior by Peter prior of La Charité. Writ of *de intendendo* to tenants.

- 441 28 June 1324: inspeximus and confirmation (1) of a charter issued at B, Wednesday before St Gregory [11 March] 1321, whereby Peter prior of SSB and the convent of that house granted to Nicholas de Tunstal a corrody there for life, viz: a whole loaf of the price of 1d, a brown loaf of price ½d, a gallon of ale of price 1d, a half gallon of second ale price ½d from the cellar of B, two dishes of meat every day on the four flesh days every week, of the price of 1½d a day, from the kitchen, and for the other three days fish or other things as one of the monks, of the price of 1½d, and every day two dishes of pottage of the price of \( \frac{1}{4} \)d, from the kitchen, and every year one robe of fur of the suit of their clerks or esquires, as he pleases, of the price of 20s, to be received yearly at Christmas; also a house within the close of B to dwell in, with a place of the court lying near the said house and the wall of John le Mazeliner, between the kitchen and the brewhouse 66 ft long by 20 ft wide at each end, and a stank with a curtilage between the said brewhouse and the new garden, whereof one end abuts on the lane leading to the granges and the other on the highway leading to Retherheth', with free ingress and egresss whenever he chooses, also every year four cart loads of wood, and two of litter to be carried at their expense

to his house; also two acres of meadow in their meadow under *Danieleswalle* for the maintenance of his horses, as it is enclosed with ditches; to hold to him for life, and to carry, take away, or assign, wherever, whenever and to whomsoever he will, as well without the said house of B as within it. And they or their successors may pay the said corrody and the above price as they prefer.

(2) A charter dated at B in full chapter, Friday St Barnabas [11 June] 1322, whereby the said Peter and the convent granted to the said Nicholas for life a part of the new garden with the apple trees and other trees in it lying between the court of the said Nicholas on one side and the said new garden on the other, of the length of 26½ perches, whereof one end abuts on the lane leading from their court to their granges and is of the width of 2½ perches and the other end abuts on the highway leading to Retherheth' of the width of 3½ perches, with its vines, hedges and ditches, free ingress and egress and all other appertinances.

- 8 July 1324: reatification of a grant by Peter later prior of SSB & convent to Mr Geoffrey de Eyton, king's clerk, of the manor of Upton, Berks, for the life of Geoffrey and two years after, saving to the king issues and profits of the said manor in times of voidance of the priory, if the ought to belong to the king.
- 30 September 1324: protection for John de Cusancia prior of B, his brother William, and kinsman John de Mate.
- 30 October 1324: protection, at rhe request of William de Cusancia, king's clerk, treasurer of Edward earl of Chester for John de Cusancia prior of B his brother; upon information that the said prior is of the power of the count of Burgundy and not of the king of France, although the priory is subject to the p riory of La Charité, with the dominion of the king of France.
- 24 October 1325: commission *de walliis et fossatis* re the breach on the bank of the Thames between Greenwich and B, in the county of Kent.

- 25 April 1327; protection for one year for Peter de St Laurencio late prior of B, prosecuting business in the king's courts and in fear of his adversaries.
- 8 July 1327: B priory having been wasted and impoverished by the indiscreet rule of former heads, and dissension having arisen between Walter de Duluyd, who claims to be prior, and brother John de Cusancia, who now acts as prior, the king has taken it into his protection and commits its custody to Roger de Gildeburgh and Nicholas de Acton. All persons are prohibited from lodging therein or carrying away anything therefrom without their consent.

- 26 November 1330; pardon to William de Cherleton and Edith Popard for acquiring a messuage, 32 acres of land and 5s rent in Kynewardeston from Alice le Parker, who held the same from Mr Walter de Kynewardeston and from the priory of B, and another messuage and 33 acres of land from Thomas de Luda who held the same from Thomas de Kynewardeston, and he from Mr Walter, and he from the said prior, entering upon the premises, which are held in chief, withouth licence from the king.
- 6 April 1332: protection for one year to the prior of B going beyond the seas.
- 332 11 September 1332: protection for the prior of B now grievously burdened by debts incurred by the neglect and bad rule of late priors and other misfortunes; and the appointment of John Darcy, prior of Stonegate, John de Ludelowe monk of B and others to the custody thereof.

28 April 1334: confirmation of a grant by John prior of SBB to John de Shirbourn clerk, for cash in hand, of the manor of Little Halylngbury, Essex, for life.

- 27 February 1336: Prior John of B, going beyond the seas, nominates William Rous and John de Matee as his attorneys for a year.
- 7 March 1337: confirmation of a grant for life, at a rent of 25s, by John prior of B to William de Latton of Uptone and John his son of lands and meadows there. Fine of 20s.
- 483 28 July: protection for the prior of B.
- 15 December, 1337: Presentation of John de Walyngford to the church of Rotherhithe in the diocese of Winchester, in the king's gift by reason of the temporalities of the priory of B being in his hands.

## 1338-1340

4 May 1338: presentation of John de Waterton to the vicargae of Byrling, diocese of Rochester in the king's gift by reason of the temporalities of the prior of B being his hands on account of the war between him and France.

12 June 1340: licence for the prior and convent of B, who are bound to William de Cusancia, keeper of the king's wardrobe, in a great sum of money which, on account of the intolerable charges daily incumbent upon them in keeping in repair the breach of B for the defence of their land there, as well as for other great sums which they pay yearly to the king for their farm with other aliens, they cannot pay; to lease their manor of Wodeford, Herts, for a certain sum to be paid in advance, or at a yearly farm for a term of life or years, to enable them to relieve their estate and discharge part of their debts.

- 28 May 1341: licence, at the request of Richard, bishop of Durham, for the prior and convent of B to acquire in mortmain lans and rent to the value of 100s pa.
- 18 August 1341: licence for alienation in mortmain by Peter de Cusancia and John Lambyn of Colchester, citizen of London, to the prior and convent of B,

in satisfaction of 30s of 100s yearly of land and rent which the king, at the request of Richard, bishop of Durham, has given them licence to acquire, of a messuage and a toft in Rotherhithe, which are held of the prior and convent in chief.

- 432 15 May 1342: acceptance of a demise by John, prior of B, to Richard de Wylughby and his wife Joan for life of either, of the manor of Wydeford, Herts, and the advowson of the church. Licence also for the more prompt payment of his debts and farm of his priory, custody whereof has been committed to him by the king at a rent, for the prior to demise his manor of Cowyk, Essex, to whomsoever he will for a term of life or years.
- 501 12 August 1340: re same.

#### 1343-1345

Presentation to St Andrew Holborn: in king's hands because of war.

## 1345-1348

- 8 July 1346: commission of oyer and terminer on complaint by the prior of the alien house of B, in the king's hands because of the war with France, that Alan Ferthyng of Southwark and twelve others broke and threw down his close and dykes in B and dug so much in his several soil there that by the throwing down and digging 140 acres of meadow were inundated by the Thames and he totally lost his profit thereof, felled his trees and carried them away with other goods and assaulted his men and servants whereby he lost their service for a great time.
- 8 October 1346: inspeximus of lease for life by John prior of SSB to Alice de Bedyngfeld and assigns of the manor of Upton, Berkshire, at a rent of 25s. If ejected by the priory a £20 pension will be payable to her.
- 240–1 Repeat of 176–7
- 12 April 1347: re a messuage and 17 acres in Camberwell granted for life by the priory to William de Cusancia and taken into the king's hands with other priory property on account of the war with France. The king pardons William for entering into it.

## 1348-1350

225 15 January 1349: licence for the prior of B to acquire in mortmain lands and rents not held in chief, to a value of £20 pa.

- 20 January 1349: protection and safe-conduct till Easter for the prior of B, deputed by the General Chapter of Cluny to make a visitation of priories and cells of the order in England.
- 24 May 1350: licence for alienation in mortmain by William de Cherleton to the prior and convent of B in satisfaction of 20s of 100s pa of land and rent, which the king at the request of Richard, late bishop of Durham, granted them licence to acquire, of a messuage and 65 acres of land in Kynewardeston, of the clear annual value of 11s 8d.
