William de Widevil assarted 3½ acres ½ rood, and holds it himself, and has sown wheat. It is of the fee of the abbey of Grestain and pertains to the vill of Grafton. Robert his son holds.

The same William assarted 1½ acres ⅓ rood of his wood, and holds it himself, and has sown wheat. It is of the same fee and pertains to the same vill. The same Robert holds.

Walter de Widevil assarted 1⅓ roods of his wood in Grafton, and holds it himself, and has sown wheat. It is of the fee of the abbey of Grestain and pertains to the vill of Grafton. James his son holds.

John de Mers assarted 2 acres ½ rood and the fifth part of a rood in Grafton of the wood of Thomas de Widevil, and has sown wheat, and holds it himself. It is of the fee of the abbey of Grestain.

The abbot of Grestain assarted 3 acres 3½ roods in Grafton of his wood, and holds it, and has sown half with wheat and the other half with oats. It is of his fee and pertains to the vill of Grafton.

Henry Gobiun the old of Yardley assarted from his wood of Yardley 8½ acres, of which the Ferrers earl holds half, and has sown oats, and Henry Gobiun his son holds the other half, and has sown oats. It is of the fee of the said earl and pertains to Yardley.

Thomas the hermit of Grafton assarted 1 acre 1½ roods of the wood of Thomas le Sauvag' of Alderton, and the brothers of the same place hold it, and have sown oats. It is of the fee of Thomas le Sauvag'.

The same Thomas made another assart of ½ rood and the fourth part of a rood, of the same fee, which the same brothers hold, and have sown oats.

Thomas le Sauvag' the old assarted 2½ acres of his wood in Alderton, and Sir James le Sauvag now holds it, and has sown oats. It is of the fee of the said Thomas and pertains to the vill of Alderton.

William Bond (dead) assarted 2½ roods of his wood in Alderton, which he holds himself, and has sown oats. It is of the fee of Thomas le Sauvag'. James le Sauvage.

Robert de Salcet' assarted the third part of a rood of the wood of William Bond of Alderton, and Adam son of Roger Marshal of Plumpton now holds it, and has sown wheat. It is of the fee of Lady Joan de Bruer'. Peter son of Osbert now holds.

The same Robert assarted 2 acres 3 roods and the third part of a rood of his wood of Plumpton, and Peter son of Hubert of Plumpton and Beatrice his wife now hold it, and have sown oats. It is of the fee of the said Robert.

The same Robert assarted 4 acres of his wood of Plumpton, and Peter son of Hubert and his wife now hold it, and have sown barley. It is of the fee of the said Robert.

The same Robert assarted 10½ acres of the wood of William Marshal of Norton, and Peter son of Hubert and his wife now hold it, and it lies fallow. It is of the fee of William Marshal.

Robert de Pavely of Paulerspury assarted 3 roods and the fourth part of a rood of his wood in Paulerspury, and Robert his son now holds it, and has sown oats.

The same Robert assarted 1 acre ½ rood of his wood in Paulerspury, and Robert his son now holds it, and it lies newly broken.

The same Robert assarted 1½ acres of the same, and Robert his son now holds it, and has sown oats.

The same Robert assarted 10 acres ½ rood of the same, and Robert his son now holds it, and has sown oats.

The same Robert assarted 1 rood and the third part of a rood of his wood, and Robert his son now holds it, and it lies newly broken.

Henry de Pery assarted 2 acres ½ rood of the wood of Norton of the fee of William Marshal, which the prior of Luffield now holds, and has sown oats. Reginald his son holds.

Geoffrey de Baddesle assarted 2 acres ½ rood of the wood of William Marshal, of the fee of the same, and the same Geoffrey now holds it, and it lies fallow.

Wybery de Touessest' assarted 1½ roods of his wood. It is of the fee of Norton, and he himself holds it, and has sown oats. Alice formerly his wife now holds.

Gregory of Touescet' assarted 2 acres ½ rood and 1 rood of the wood of Norton, of the fee of William Marshal. Robert his son now holds, and has sown oats.

John Marshal the old assarted 2½ acres and the tenth part of 1 rood of his wood of Norton, and William his son now holds it, and it lies fallow.

John Marshal the younger assarted 1 acre 3 roods and the tenth part of 1 rood of his wood of Norton, and William his brother now holds it, and has sown oats.

The same John assarted 6 acres ½ rood there of the same, and William his brother now holds it, and has sown half with wheat and the other half with oats.

The prior of Luffield assarted 9 acres of the wood of Norton of the fee of William Marshal, and the same prior holds it, and has sown half with oats and the other half lies fallow.

The prior of Luffield assarted 8 acres of the wood of Norton of the fee of William Marshal, and the same prior holds it, and has sown half with wheat and the other half with oats.

Warin de Mouch' of Towcester made a purpresture from his wood of Bucknell (*Bokenehul*) and built a grange and a certain cottage and curtilage and it contains by estimation 3 roods.

Roger de Limis assarted 3 acres and a third part of a rood, and Robert Witting of Banbury now holds it, and it lies fallow.

Robert de Wauncy assarted 4 acres $\frac{1}{2}$ rood of his wood in Astwell of the fee of Henry de Pinkeney, and Robert Witting now holds it, and has sown oats. Robert son of Robert de Wancy now holds.

The prior of Brackley assarted 16 acres in Luclehey of the fee of Saer de Quincy, and the same prior holds it, and has sown half with wheat and half with oats.

The abbot of Biddlesden assarted in Bichenho 25 acres $\frac{1}{2}$ rood of his wood of the fee of William de Pinkeney of Norton, and he holds it, and has sown half with oats.

The same abbot assarted 3 acres there of the same, and he holds it, and it lies fallow.

Robert de la Tour assarted 2 acres $\frac{1}{2}$ rood of the king's land in Silverstone and it lies newly broken, and is in the king's hands.

Ralph de Trubbevil assarted 1 acre there of the same, and Reginald Gik and Felicia de Touessc' now hold it, and have sown oats.

Fauch' made a purpresture in Silverstone of $\frac{1}{2}$ rood of the king's land, and Philip Din holds it and pays 8d a year to the king and 4 hens and has built on it.

Stephen de Setgrave made an assart of the fourth part of $\frac{1}{2}$ rood there of the same, and it is in the king's hands and lies newly broken.

Stephen le Syur holds the fourth part of a rood of purpresture made there of the same, which Elias de Ravenesby made and built on, and he pays 8d a year to the king and 4 hens.

Elisie Rousel holds the fourth part of $\frac{1}{2}$ rood of purpresture made there, which Robert de la Tour made and built on, and he pays 8d a year to the king and 4 hens.

Robert Gik holds $\frac{1}{2}$ rood of purpresture made there of the same, which Robert de la Tour made and built on, and he pays 6d a year to the king and 2 hens.

Robert de la Tour made a purpresture there of the same of $\frac{1}{2}$ rood which the king holds.

Elias Carpenter holds a certain part of $\frac{1}{2}$ rood there of the same, which Robert de la Tour made and built on, and he pays 4d a year to the king.

William Totin holds the fourth part of a rood which Elias de Rameshey made there of the same and built on, and he pays 12d a year to the king and 4 hens.

Robert de la Tour assarted the fourth part of a rood there of the same and the king holds.

Fauch' assarted 5 acres $\frac{1}{2}$ rood there of the same, and the king holds, and it lies fallow.

The same Fauch' assarted 2 acres $\frac{1}{2}$ rood there of the same, and the king holds, and it lies fallow.

The same Fauch' assarted 10 acres there of the same, and the king holds, and has sown oats.

The same Fauch' assarted 5 acres there of the same, and the king holds, and it lies fallow.

Aubrey de Burton made a certain purpresture there of the same, and the king holds, and has sown oats.

The prior of Luffield made a certain purpresture anew from the fee of Hinton of 1 acre by estimation, and has sown oats, and he himself holds it.

William de Dive of Wicken assarted 4 acres of his wood of Wicken, and he himself holds it, and has sown oats.

The same William assarted 9 acres and the fifth part of a rood, and he himself holds it, and it lies newly broken.

William son of Hamo of Wicken assarted 6 acres and the fourth part of a rood of his wood in Wicken, and has sown oats, and John son of Alan holds.

The same William assarted 6 acres $\frac{1}{2}$ rood there of the same, and John son of Alan holds it, and has sown oats.

The same William assarted 8 acres $\frac{1}{2}$ rood there of the same, and his wife built 3 cottages on the said assart.

Henry son of Walkelin assarted $8\frac{1}{2}$ acres $\frac{1}{2}$ rood of the king's land in Barue, and the wife of Richard Fisher holds it of the queen, and has sown oats. Alan Balun holds.

Adam le Fleccher assarted 2 acres there of the same and 1 rood, and his wife holds it, and has sown oats.

Hugh de Stratford made a purpresture from the king's land in Puxley and built 7 cottages.

The same Hugh assarted $1\frac{1}{2}$ acres $\frac{1}{2}$ rood there of the same, and he himself holds it, and has sown oats.

The lepers of Stratford made a purpresture from the king's land in Shrob of a tenth part of a rood by licence of J. de Nevil'.

Robert de Ferrers assarted 10 acres 1 rood and the fourth part of a rood of his wood in Potterspury, and William de Ferrers holds it, and has sown oats. Edward son of the king has it.

William de Estpery dug $4\frac{1}{2}$ acres of the king's land called Swetelye, and William Lamber now holds it, and has sown oats.

The same William made a purpresture of 5 roods there of the same, and William Lambert now holds it, and has sown oats.
