Pottery and Ceramic Building Material from York Hotel, York (Site YORYM:1998:707): Assessment Report

Introduction

51 sherds of pottery were submitted for assessment, representing the total assemblage from the York Hotel trial excavation. With one possible exception, the sherds were of Romano-British date, including some that should be earlier in date than the foundation of the *colonia* although the majority of the pottery dated to the 3rd century, with two possible late 3rd or 4th-century sherds.

The possible exception, from context 1005, is either an unusual Romano-British bowl or, perhaps more likely, the rim of a large Victorian flowerpot, such as might be expected to have been in use the garden of the Hotel.

Aims and Objectives

The aims of the assessment were

- to identify and record all the material
- to provide a date-range for the finds
- to use these to infer previous land use
- to recommend and justify any further necessary work on the finds
- to identify any aspects of the site's archaeology recognisable from the ceramic finds which require further study or preservation

Description

All items were recorded to common name and form level and any significant details of manufacture, decoration or use were recorded as comments. Quantification was by sherd/fragment count alone and the data was entered into a MS Access 7 database.

Roman

The pottery was identified and classified according to the system published by Monaghan (Table 1)

There were only four pottery-producing contexts in the excavation, all dating to the Roman period. Their *termini* post quem ranges from 2^{nd} century (1009) to late 3^{rd} or 4^{th} century (1004, 1011) although the majority of the pottery is undoubtedly of 3^{rd} century date (Table 2).

The range of fabrics and forms found indicates a Romanized context for the pottery. Food preparation, storage, serving vessels together with drinking vessels are represented and the activities that gave rise to these sherds are likely to be associated with occupation rather than, say, ceremonial feasts held at the graveside or libations.
