# Assessment of the pottery and ceramic building material from Prudential House, Blossom Street, York (OSA04 WB35)

# Alan Vince

A small collection of pottery and a single fragment of ceramic building material were recovered from a watching brief at Prudential House, Blossom Street, York, carried out by On Site Archaeology (Site Code: OSA04 WB35). The finds date to the 2<sup>nd</sup>/3<sup>rd</sup> centuries and to the 13<sup>th</sup>/14<sup>th</sup> centuries and in the case of the Roman material are sufficiently unabraded to suggest activity on the site.

## Description

Fourteen fragments of pottery and one piece of ceramic building material were recovered, from three contexts (Table 1).

# **Ceramic Building Material (CBM)**

A single fragment of a tile with a curved surface was recovered from context 2008. This is likely to have been an *imbrex* tile, indicating the presence nearby of a Roman structure with a tiled roof.

# Pottery

## Roman (RPOT in table 1)

Nine sherds of Roman pottery were recovered and have been identified according to the classification used by Monaghan ({Monaghan 1997 #113}). They come from two contexts,

2008 and 2003 (Table 2). The wares represented include burnished greywares (YORKB3), Nene Valley colour-coated wares, with light-firing and more orange-firing fabrics (YORKC1, YORKC3), Central Gaulish Samian ware (YORKS3) and East Gaulish Samian ware (YORKS4). The B3 sherds all come from jars, three of which have acute-angled burnished lattice decoration. This indicates that they post-date the widespread use of Dorset Black Burnished ware which was responsible for the spread of this decoration soon after 120 AD. The pottery from context 2003 is associated with medieval sherds and is therefore clearly in a secondary context. As a group, however, the sherds probably date to the 3<sup>rd</sup> century, since if they were any later the Samian vessels would probably not have still been current whilst if they were any earlier the Nene Valley colour-coated wares would have been absent. It is, of course, quite possible that this is a fortuitous association derived from mixed deposits in which case the Nene Valley sherds could easily date to the 4<sup>th</sup> century.

## Medieval (MPOT in table 1)

Sherds of York glazed ware (YORK) and Brandsby-type ware (BRANDSBY) were recovered. The former dates to the later 12<sup>th</sup> and earlier 13<sup>th</sup> centuries whilst the latter dates to the mid 13<sup>th</sup> to the 15<sup>th</sup> centuries, although one of the Brandsby-type sherds comes from a highly decorated jug, a type which is likely to date to the mid 13<sup>th</sup> to mid 14<sup>th</sup> century.

#### Discussion

The terminus post quem of the three contexts is:

2008 – early 2<sup>nd</sup> century (post-120)

2004 – late 12<sup>th</sup> century

2003 - mid 13<sup>th</sup> century

The pottery from context 2008 consists of small but fresh-looking sherds and it is likely that the deposition date of the assemblage is in the  $2^{nd}$  century. For the medieval wares, the condition of the sherds is worse and this means that they are likely to have been redeposited, or subjected to weathering through agriculture, horticulture or being within an active soil horizon. An unknown period of time must therefore be added to the *tpq* to arrive at an actual terminal date for the deposits they were found within. The Roman pottery in context 2003 is later in date than that in context 2008 and its condition suggests that a  $3^{rd}$ -century deposit had been disturbed.

## Assessment

None of the finds is of intrinsic interest and they do not require any further recording or analysis. They may, however, be of some use in future city-wide studies of pottery distribution and should be retained for future study.
