ABSTRACT

Hallgate Construction Ltd commissioned Alder Archaeology Ltd to undertake a photographic survey of a small lodge close to Ruthven Towers in Auchterarder. The work was carried out on the 26th of October 2009 in good weather conditions. The aim was to provide a photographic record of the lodge prior it being demolished. The building was extensively photographed externally and internally and was found to be of very late 19th century or early 20th century date. There were two 20th century extensions, probably dating to the 1930s. The site code was AA12.

1 Background

1.1 Introduction

Hallgate Construction Ltd commissioned Alder archaeology Ltd to undertake a photographic survey of a small building known as 'The Lodge' near Ruthven Towers, Auchterarder. The building lies to the north of Ruthven Towers care home at NGR NN 95148 713085. The site code was AA12.

The work was designed to satisfy the archaeological condition on the site which is a housing development.

1.2 Aims and Objectives

The main aim of the photographic survey was to make a record of the building prior to it being demolished in advance of a residential development.

1.4 Planning and Curatorial Issues

This programme of archaeological work is designed to inform the local authority (Perth and Kinross Heritage Trust) of the internal and external appearance of this building, to assess its importance.

2 Survey Method

The survey was conducted on the 26th of October 2009 by one person. All photographs were taken with a Nikon D50 digital SLR camera.

The external elevations of the building were photographed with shots taken at 90 degrees to the walls (where space permitted) and at oblique angles. The building was also photographed from further back to show it in the surrounding landscape, for context. Any undergrowth and trees that were obscuring the elevations were removed prior to photography. The windows at the front of the lodge and one of the side doors had been covered over with pine planks nailed to the frames; this was firmly attached and could not be removed for the purposes of this survey. Shots of internal rooms and circulation areas were taken systematically using a flash as well as slow timed shots using natural lighting. Important details and fittings were also recorded and notes taken.

3 Results of Investigations

3.1 Setting

The lodge lies at the west end of a boundary running WNW north of Ruthven Towers care home. The boundary comprises a bank covered in mature beeches with a wrought iron fence on its N side. Originally this boundary and the lodge would have belonged to Ruthven Towers. To the NW of the lodge is a driveway in a hollow and beyond a grassy field enclosed by a drystone wall. The land to the E and NE of the lodge, the site of proposed housing, slopes gently downhill. During development this area was found to have deep topsoil containing the remains of greenhouses. Presumably this area was once the garden / allotment for Ruthven Towers.

3.2 Basic Description

3.3 Phasing

There are three phases to the building:

The first is represented by the original building, essentially just two rooms divided by a central wall containing the chimney stack. Originally there would have been fireplaces in both rooms, but the one in the NW room has been blocked up. There was probably also once a doorway between the rooms, but this seems to have been blocked by the insertion of cupboards and a boiler in the SE room. The roof of this original structure is of hipped design (with two gablets at each end) and covered in light bluish Scottish slates of uniform size (but fairly thick and irregular). The wall bricks were not visible because of the cement render and plaster, but the uniform nature of the walls suggests they may be built from colliery bricks.

The second phase is represented by the building of extensions to the front (NE) and back (SW) of the house, essentially a couple of lean-tos. The front extension is little more than a metre high wall with a continuous line of casement windows above (now boarded up). Its roof is at a shallow angle and is covered in darker, thinner more uniform slate than the original roof. The rear extension is slightly wider than the front with a 1.8m high wall containing just 3 windows (now blocked). The roof of the rear extension is covered in similar slate to that of the front but is at an even shallower angle. This area seems to have been used as a kitchen and storage area.

The final change to the house seems to have been the creation of a bathroom. This involved building an internal wall division in the NW room and knocking a hole through the original front wall.

3.4 Date

The earliest part of the building probably dates to the very late 19th or early 20th century, judging by the slate roof and the form of the windows. The extensions definitely of 20th century date, probably 1930s. The bathroom door suggests the bathroom was put in circa 1950s.

4 Conclusion and Recommendations

This survey has enabled a detailed photographic record of this building to be made. The author feels that demolition of this lodge can now go ahead; however, the final decision ultimately rests with Perth and Kinross Heritage Trust.







The Rear Extension











Illus 10 The front extension (excluding bathroom)










