Summary: Sutton, part garden Pink Cottage, Main Road (SUT 223, TM 3054 4633) evaluation trenching for a small scale development comprising two, semi-detached, dwellings within the village and some 130m south-east of the parish church did not reveal any archaeological features or finds (John Newman Archaeological Services for Orchard Valley Homes Ltd).

#### 1. Introduction & background




Fig. 1: Site location (Ordnance Survey © Crown copyright 2006 All rights reserved Licence No 100049722)

- 1.1 Orchard Valley Homes Ltd commissioned John Newman Archaeological Services (JNAS) to undertake the archaeological evaluation works for a small scale residential development comprising two, semi-detached, dwellings on land recently detached from the garden of Pink Cottage, Main Road, Sutton (see Fig. 1). The evaluation requirements were set out in a Brief, following the granting of planning application C/10/2761, which replaced C/05/0115, set by Dr J Tipper of the Suffolk CC Archaeological Service (SCCAS) with the aim of gaining a representative sample by trial trenching of site. The Written Scheme of Investigation for the archaeological evaluation (see Appendix II) was subsequently prepared by JNAS in order to gain a conditional discharge and allow the trenching to go ahead before any other ground works were undertaken.
- 1.2 The village of Sutton is located on the eastern side of the River Deben some 2.5 miles south-east of Woodbridge in that part of Suffolk known as The Sandlings; a name derived from the light soils of the area that historically gave rise to extensive areas of heath land. The local drift geology is made up largely of well drained sands and gravels (deep sands of the Newport Series 20 with extensive areas distant from easily accessible water sources) giving rise to a dispersed settlement pattern scattered across various relatively large parishes. Within this settlement pattern separated by large areas of former heath land small village centres grew from the mid-late Saxon period. At Sutton the main village settlement forms a linear pattern on a north-south alignment along Main Road some 1300m east of the River Deben, but relatively close to some mapped springs to the east, with the parish church being located at the northern end of the settlement on the eastern side of the road. It is likely that the parish church formed the original focal point of the village and the proposed development site is located just below the 20m OD contour some 130m to the south-east with a frontage onto the western side of Main Road.
- 1.3 Archaeological interest in this planned development was generated by its relatively close proximity to the parish church which appears to form the focus for a widespread scatter of Anglo-Saxon artefacts (HER SUT 028 & & 042) in addition to various Roman and medieval period finds. These discoveries being suggestive of settlement type activity in the general area of the church spanning the Roman, Anglo-Saxon and medieval periods.

## 2. Evaluation methodology




Fig. 2: Location of evaluation trench (proposed footprint area- light blue) (Ordnance Survey © Crown copyright 2013 All rights reserved Licence No 100049722)

- 2.1 The area of the proposed development was trenched to a previously agreed plan with the trench being located immediately to the east of the planned footprint area thereby avoiding the main foundation lines (see Fig. 2) using a medium sized 360 machine equipped with a 1500mm flat bucket which was under archaeological supervision at all times with any indistinct areas being hand cleaned for better clarity. At the mid-point in the trench an area of potential disturbance with irregular and diffuse edges was identified and this was mechanically lowered under close supervision in 100mm 'spits' of subsoil before being cleaned by hand.
- 2.2 The sides and base of the trench and the upcast spoil were examined visually and scanned for any finds and any indistinct areas or potential features were investigated by hand. Site visibility for features and finds is considered to have been

good throughout the evaluation which was undertaken under dry sunny conditions. At the end of the evaluation the location of the trench was plotted from nearby mapped features and as the evaluation progressed a full photographic record in digital format (see Appendix I) was taken of the trenching works.

#### 3. Results

3.1 In this case the results are most easily summarised as in the table below as nothing of archaeological interest was revealed (see also Fig. 2):

3.2 As indicated in the table above no archaeological features or finds of any date were revealed during the evaluation with the mainly 600mm deep trench revealing a deposit profile comprising an average depth (250mm) of topsoil over 350mm of mid brown sandy subsoil. At the central point in the trench an area some 1m to 1.50m across was identified as a potential disturbance below the subsoil though with irregular and diffuse edges it appeared likely that it was a naturally derived feature (see Appendix I). This conclusion was confirmed as the disturbed area was lowered mechanically by a further 300mm in 100mm 'spits' and then trowelled clean with the irregular shape and edges that blurred into the surrounding natural yellow sand being highly suggestive of an origin as an animal burrow or possibly adjacent tree root holes.

#### 4. Conclusion

- 4.1 With such negative results regarding any significant evidence for past activity from a substantial sample of the proposed development site it can only be concluded that this site lies outside the nearby area of past activity evidenced by the recorded multi-period artefact scatter.
- 4.2 Based on the evaluation results it is recommended that no further archaeological investigations need to be carried out on the proposed site of the new dwellings on the southern side of the Pink Cottage, Main Road, Sutton.

#### 1. Introduction

- 1.1 Orchard Valley Homes Ltd have commissioned John Newman Archaeological Services (JNAS) to undertake the archaeological site evaluation for a proposed small scale residential development that has recently received consent to go ahead. This written scheme of investigation (WSI) details the background to the archaeological requirements for planning application C/10/276, which replaced C/05/0115, and how JNAS will implement the requirements of the Brief for Archaeological Evaluation set by Dr J Tipper of the Suffolk CC Archaeological Service (SCCAS). The WSI will also set out how potential risks will be mitigated. This proposed development concerns the construction of a pair of semi-detached dwellings and single garage on part of the garden that is to be detached at Pink Cottage, Main Road, Sutton.
- 1.2 The evaluation will be carried out to the standards set regionally in the Standards for Field Archaeology in the East of England (EAA Occ. Papers 14, 2003), locally in Requirements for Trenched Archaeological Evaluation 2011 Ver. 1.1 (Suffolk CC) and nationally in Standards and Guidance for Archaeological Field Evaluation (Institute for Archaeologists 1994, revised 2001).

#### 2. Location, Topography & Geology

2.1 The village of Sutton is located on the eastern side of the River Deben some 2.5 miles south-east of Woodbridge in that part of Suffolk known as The Sandlings; a name derived from the light soils of the area that historically gave rise to extensive areas of heath land. The local drift geology is made up largely of well drained sands and gravels (deep sands of the Newport Series 20 with extensive areas distant from easily accessible water sources) giving rise to a dispersed settlement pattern scattered across various relatively large parishes. Within this settlement pattern separated by large areas of former heath land small village centres grew from the mid-late Saxon period. At Sutton the main village settlement forms a linear pattern on a north-south alignment along Main Road some 1300m east of the River Deben, but relatively close to some mapped springs to the east, with the parish church being located at the northern end of the settlement on the eastern side of the road. It is likely that the parish church formed the original focal point of the village and the proposed development site is located just below the 20m OD contour some 130m to the south-east with a frontage onto the western side of Main Road.

## 3. Archaeological & Historical Background

3.1 To quote from the relevant Brief 'This application concerns the construction of two dwellings and a single garage. The proposal lies in an area of high archaeological interest, recorded in the County Historic Environment Record. Numerous Anglo-Saxon artefacts (SUT 042, SUT 028, PAS ref SF-FF3553) have been recorded from the immediate vicinity of the proposed development, in addition to finds of Roman and Medieval pottery from the surrounding area'. A site evaluation by trial trenching will therefore be required to:

- Identify the date, approximate form and purpose of any archaeological deposit, together with its likely extent, localised depth and quality of preservation.
- Evaluate the likely impact of past land uses, and the possible presence of masking colluvial/alluvial deposits.
- Establish the potential for the survival of environmental evidence.
- Provide sufficient information to construct an archaeological conservation strategy, dealing with preservation, the recording of archaeological deposits, working practices, timetables and orders of cost. The further recording of any archaeological deposits may involve excavation prior to ground works commencing or monitoring of the relevant ground works

#### 4. Aims of the Site Evaluation

4.1 As outlined in section 3 above the main archaeological potential relates to the site's location close to where evidence of Saxon period activity in particular has been recorded. In addition evidence for earlier, Roman, and later, medieval, period has been recorded and the site is close to the historic core of a settlement with mid to late Saxon origins. The aim of the evaluation is therefore to examine the specified sample of the proposed development area with an evaluation trench under controlled conditions so, if archaeological deposits are revealed they can be sampled and characterised. With this information a strategy can then be formulated for their possible preservation in situ or, failing that, the systematic recording of these deposits and the associated working practices, timetables and orders of cost.

## 5. Methodology

- 5.1 The proposed development is for a pair of semi-detached dwellings on what is soft ground in the garden of Pink Cottage, Main Road, Sutton. The evaluation trenching will be in an area that is currently garden.
- 5.2 The Brief requires a single 10m long and 1.8m wide trench and following discussion with the relevant SCCAS officer this can be located immediately in front of the planned footprint area to avoid later problems with foundation trenches. This will be undertaken using a 1.20m or 1.50m wide toothless ditching bucket on a suitably sized machine operated by an experienced driver with a trench plan as set out below. The machine will be closely supervised by an experienced archaeologist as the overburden is removed in shallow spits to the top of any archaeological deposits that are present, where hand investigation will start, or to expose the underlying drift geology which will be further hand cleaned and examined. The spoil

will be stored adjacent to the excavated trench with top and sub soil kept separate to allow for subsequent sequential backfilling. No trenches will be backfilled until the relevant officer at SCCAS has been consulted and should any modification to the trench layout be required due to any unforeseen circumstances, such as local services, then SCCAS will be contacted immediately. A metal detector search will be carried out by an experienced operator at all stages of the evaluation. The up cast spoil will also be closely examined for unstratified artefacts as evidence for past activity in rural areas in particular is often as evident via artefact scatters as by undisturbed archaeological deposits.

- 5.3 Site records will be made under a continuous and unique numbering system of contexts under an overall site HER number obtained from the Suffolk CC HER beforehand. All contexts will be numbered and finds recorded by context. Conventions compatible with the county HER will be used throughout the monitoring. Site plans will be drawn at 1:20 or 1:50 as appropriate and sections at 1:10 or 1:20 (all on plastic drawing film) and related to OS map cover. Sections will be levelled to a datum OD. A photographic record in monochrome film and high resolution digital images will be made of the site and exposed features.
- 5.4 As necessary and to define archaeological deposits exposed surfaces will be trowelled clean before appropriate hand investigation and recording. Exposed archaeological features will be sampled at standard levels with care being taken to cause minimum disturbance to the site consistent with evaluation to a level adequate to properly form a subsequent mitigation strategy. Significant features such as solid or bonded structural remains, building slots or post holes (where fills are sampled) will have their integrity maintained (and during backfilling). Otherwise for discrete. contained, features, sampling will be at 50%- possibly rising to 100% if requested, and 1m wide sampling slots across linear features. If human burial evidence is revealed the SCCAS Officer will be informed and the clear presumption must be to preserve such remains in situ with minimum disturbance during this evaluation stage. If this is not possible then a Ministry of Justice licence will be obtained prior to full on site recording (total 100% sampling if a cremation deposit) and removal of the remains followed by examination by the relevant specialist and possibly scientific dating. If human remains do have to be recorded, removed from site and reported on then these works will add an additional cost to the evaluation works which may involve radiocarbon dating (in this case the likelihood of revealing human burial is assessed as being low at this location).
- 5.5 All finds will be collected and processed unless any variation is agreed with the relevant SCCAS Officer. Finds will be assessed by recognised period specialists and their interpretation will form an integral part of the overall report. Finds will be stored according to ICON guidelines with specialist advice/treatment sought for fragile ones. Every effort will be made to gain the deposit of the site finds to the SCCAS Store under their relevant HER code and site numbering for future reference. If this is not possible then the SCCAS Officer will be consulted over any requirements for

additional recording (which may have an additional cost implication). Any discard policy will be discussed and agreed with the relevant SCCAS Officer.

5.6 Where appropriate palaeoenvironmental samples will be taken for processing and assessment by a specialist conversant with regional archaeological standards and research agendas. The sampling, processing and assessment will follow the guidelines as detailed in A guide to sampling archaeological deposits for environmental analysis (Murphy P L & Wiltshire P E J, 1994). In accordance with standard practice bulk samples of 40 litres (or 100% of the deposit where less) will be taken from a representative cross section of archaeological deposits of all periods (respecting defined fills within features), in consultation with the relevant SCCAS Officer (and RSA if the deposits merit more targeted advice) including deposits that cannot be immediately dated by their artefact content, so the state of preservation and full archaeological and palaeoenvironmental potential of the deposits can be assessed and any further sampling, should further field work take place, be systematically planned and fully costed. Archaeological deposits of all types may reveal valuable data through the processing and assessment of samples with high priority features including the primary fills of pits, wells and cesspits, layers of middens, occupation surfaces and structural features as well as other discrete activity areas, contents of hearths, ovens, and other craft related or industrial structures. In addition more generalised settlement and land use features such as ditches may also yield valuable and informative data when sampling is undertaken systematically as the sum of all the assessment results can add considerably to the interpretation of a site and its landscape. Through an integrated study of all the data recovered from the evaluation the results from the assessment of the samples will be reviewed in terms of:

- What is the quality and state of preservation of charred plant remains, mineralised plant and animal related remains, small vertebrates and industrial residues such as evidence for iron working (contributing to the fullest interpretation of the evaluation results and to aid the planning of any further field work- if any RC dates are required on should features containing suitable material but no easily dateable finds then this will incur an additional cost.
- What is the concentration of macro-remains (to inform sampling strategy in any further field work), in particular how might bulk sampling inform the interpretation of burial deposits.
- Can any patterning or similarities/differences be ascertained between deposits from different periods represented on site, similarly can any useful comparisons be made with undated and unphased deposits (to aid interpretation of the evaluation results and help in the study of undated deposits which may otherwise be overlooked and which may via sampling yield material for RC dating)

- Do waterlogged deposits exist on site, if so is there potential for palaeoenvironmental data from preserved insects or pollen and do such deposits contain organic material suitable for RC dating from samples taken as advised by the relevant soil specialist (who would also coordinate the assessment for pollen and insect remains), the RSA will also be consulted in such cases in conjunction with the relevant SCCAS Officer. Incremental column samples will be taken should waterlogged deposits be revealed in close consultation with the evaluation soils specialist with 10-20 litre sample sizes which will be sub-sampled for preserved pollen, insects, diatoms, preserved parasite eggs etc. If waterlogged wood is encountered it will ideal to leave in situ, if it has to be lifted it will be packed while wet in black polythene and stored at 5C until it can be transferred to a specialist for species identification, assessment and potential for RC dating is undertaken (examination of the topographic location of the site indicates that the presence of waterlogged deposits is unlikely).
- Deep blanket type deposits resulting from both natural and human derived actions and events can yield valuable land use and palaeoenvironmental information. In particular such deposits can form at the base of a slope, if located in the evaluation the relevant SCCAS Officer and RSA will be consulted over monolith sampling and assessment by the relevant evaluation specialist (the composition of such deposits may give information on past land use in the area through a study of the soil matrix notwithstanding additional data if it is waterlogged)
- 5.7 An archive of all records and finds will be prepared consistent with the principles in *Management of Archaeological projects* (MAP2, and particularly Appendix 3). This archive will be deposited with the Suffolk CC HER within 3 months of working finishing on site under the relevant HER number and following the guidelines outlined in *'Deposition of Archaeological Archives in Suffolk'* (SCCAS Conservation Team 2008). As necessary the site digital archive will deposited with the Archaeology Data Service (ADS) within the agreed allowance for the monitoring and reporting works.
- 5.8 The evaluation report will be consistent with the principles of MAP2 (particularly Appendix 3.1 & Appendix 4.1) and this report will summarise the methodology employed and relate the archaeological record directly to the aims of this WSI and section 4 above in particular. The report will give an objective account of the deposits and stratigraphy recorded and finds recovered with an inventory of the latter. The report will include an assessment of palaeoenvironmental remains recovered from palaeosols and cut features in relation to both dated and undated features and in terms of patterning across the site.
- 5.9 Any interpretation of the evaluation will be clearly separated from the objective account of the evaluation and its results and the results will be discussed with the

relevant SCCAS Officer at an early stage in the reporting process following reporting on the day of the immediately apparent conclusions. The report will give a clear statement regarding the results of the site evaluation in relation to both the more detailed aims in section 4 above and their significance in the context of local HER records and of the Regional Research Framework (EAA Occ. Papers 3, 8 & 24, 1997, 2000 & 2011). There will be no further work on site until the evaluation results have been assessed and the SCCAS Officer has considered whether further archaeological works are required if this application receives consent. The report may give an opinion regarding the necessity for further evaluation work as appropriate. A draft copy of the report will be presented to SCCAS following completion of the site works. Once accepted a bound hard copy will be provided for the County HER with a digital version on disc. As required the site evaluation will be registered on the OASIS online archaeological record followed by submission of the final draft in .pdf format. An HER summary sheet will be completed and a summary prepared of any positive results for inclusion in the annual PSIAH round-up. A vector plan of the trench locations will be provided in .dxf format for inclusion in the County HER.

#### Risk Assessment

- 6.1 Protective clothing will be worn on site (hard hat, high visibility vest/coat, steel-toe cap boots, and ear muffs if required). A safe working method will be agreed with the machine operator for excavation of the trenches and examination of the up cast spoil while at the same time allowing efficient use of plant. Suitable clothing will be available to mitigate against extremes of weather.
- 6.2 Vehicles will be safely parked away from work areas and lines of access.
- 6.3 Discussion with the client has already confirmed that there is no known, or likely, ground contamination. No overhead services impinge on the trench locations. Gloves and hand wash/wipes be available and any information on possible ground contamination revealed during the evaluation will be passed to finds and environmental specialists.
- 6.4 A fully charged mobile phone will be carried and a first aid kit will be taken to site.
- 6.5 It is unlikely that any trench plus excavated feature depth will go below c1/1.3m from the present ground level. If any excavations need to go deeper measures such as stepping in the sides will be employed.
- 6.6 JNAS holds full insurance cover for archaeological site works from the specialist provider Towergate Risk Solutions covering Public & Products Liability, details can be supplied on request.


