Part I The Assessment

1 General Introduction

1.1 Assessment Objectives

The research design¹ submitted in December 1991 outlined the objectives and methodology for an initial assessment of the documentary evidence², and provided a *funding contingency* for 12 weeks study.

No funding or programme of study, however, was included in the research design for documentary research to be undertaken during the period of archaeological field work.

The research design emphasized that to date no attempt had been made to collate and assess the historical documentary evidence relating to Dover, even though these materials had been preserved in considerable quantity³.

And that the monitoring of road construction and sewer replacement might possibly provide a mass of important archaeological and palaco-environmental information, following analysis of which, documentary research would enable aspects of the history of Dover to be reassessed.

The objectives comprised the following.

- I. The identification, cataloguing and copying of accessible documentary evidence, with the emphasis being placed on cartographic and pictorial sources, undertaken for the purpose of assisting with the interpretation of archaeological discoveries made during the course of the fieldwork.
- 2. A listing of other documentary evidence that may assist with the interpretation of individual or collective archaeological discoveries.
- 3. A general listing and basic assessment of relevant documentary evidence that may help with the clarification of the topographical development of the town and to provide baseline data for a future project to analyze and chart the origins and growth of the town and port.

1.2 Review of the Assessment

Documentary study was undertaken between May and November 1992, and again between January and the end of June 1993. No specialist documentary consultation was required. During these periods the following work was undertaken.

1.2.1 Catalogue of Sources

Preparation of an interim catalogue of sources, composed largely of primary and printed manuscript records both written and drawn, together with some printed primary sources, based on the following archival collections.

1.2.2 Cartographic Sources

Preparation of an interim catalogue of cartographic sources composed of primary manuscript and printed records. The catalogue is intended to be prefaced with a brief history of the range and quality of local cartographic sources, and relevant catalogue entries with biographical notes of the surveyor concerned.

1.2.3 Archival Notes

The following titles are examples of those in the process of compilation, and have been largely determined by the nature of the surviving documentary evidence.

1.2.4 Documentary Histories

1.2.5 Record Copying

The copying of primary manuscript and printed maps and plans undertaken for the purpose of providing a resource to be utilized during the interpretation of the archaeological and palaeo-environmental remains excavated and recorded during the fieldwork.

A short abstract from the Catalogue of Cartographic Sources, together with an abstract and sample copy illustration taken from a plan of Dover Harbour drawn in 1641 by William Eldred, is provided in *Appendix X*.

2 Potential and Uses of the Documentary Evidence

2.1 Introduction

The assessment of the documentary evidence has shown that a considerable quantity of records of wide variety and good quality concerning the history of the town and port of Dover have been preserved; and that, in a significant number of cases, these can be directly related to, and assist in, the understanding of the historical context of the archaeological and palacoenvironmental record compiled during the fieldwork.

The assessment of the potential and uses of the documentary evidence has been based on broad themes, examples of which are given below in *Tables 1-4*. These have been selected both to illustrate the history of the town and port of Dover, and for which archaeological and palaeo-environmental evidence has been recorded.

2.2 Archaeological Themes

3 Recommendations

3.1 Introduction

The research design submitted in December 1991 called for the identification, cataloguing and copying of the documentary evidence, with particular attention being paid to cartographic and pictorial sources; the use of such evidence in assisting archaeological and palaeo-environmental interpretation during and following fieldwork; and for an assessment of the potential and use of the sources in placing the results of the fieldwork within a wider historical framework.

These three tasks have been undertaken to varying degrees of completeness⁷, and the results presented in Sections 2 and 3 of this report, with supporting detail provided in Appendices I-X.

The following recommendations for further work adhere to the main aims of the tasks set out in the research design, and have two objectives.

- i) The enhancement of the catalogue of documentary sources.
- ii) The identification and selective use of relevant documentary evidence.

3.2 The Catalogue of Sources

3.2.1 Introduction

The preparation of an catalogue is seen as a preliminary essential to the successful integration and use of documentary evidence into the archaeological process, primarily in its use in supporting and confirming the interpretation of material archaeological and palacoenvironmental remains recovered and recorded during fieldwork, and in the writing of the overall narrative.

3.2.2 Enhancement

Two phases of catalogue enhancement and further data collection are proposed based on the consultation of in-county and out-county archives known to have preserved within their collections relevant material.

The number and range of archives consulted would be dependent on the extent and importance of any identifiable sources, and would include business, family, private and any other relevant other artificial archives and collections.

Besides any printed catalogues, indexes or calendars full use would be made of all available searchroom indices and catalogues given that there exists an uneven quality in the range of manuscript and printed, whether published or unpublished, of relevant finding-aids to the sources.

3.2.3 Compilation and Layout

It is recognized that a complete catalogue would be a unrealistic aim, and rather the objective would be to complete a catalogue of the more significant surviving sources.

Primarily the compilation of the catalogue would be by class of record with the aim of recreating any original archival groups. These would be divided into two broad categories covering official and non-official records, and sub-divided according to location and subject.

The catalogue would also be correspondingly divided into three parts covering manuscript, cartographic, and pictorial materials.

Such an approach would determine the layout of the catalogue which would be as follows.

- i) An introduction would provide a brief review of the historiography of local record publication and use of documentary sources both in the historical and archaeological literature, placing the present catalogue within its context. Secondary introductions would describe the major and lesser classes of records and the arrangement of the catalogue. A table of abbreviations would be provided.
- ti) The sections of the catalogue covering each class of record would be prefaced by summaries explaining the events leading to the original creation and contemporary use of the records; the subsequent archival histories; the extent of any former record publication; and the likely uses of the records for archaeological and historical research, drawing attention to any omissions of detail or other limitations inherent in the sources. Such summaries would vary in detail depending upon the local, regional or national character of the records described.
- iii) The catalogue arrangement within each class of record would be chronological, with footnotes providing cross-references to other relevant classes of similar date.
- (v) The catalogue entries would aim to provide descriptions of original single documents, groups of documents, or volumes. Artificial volumes of documents would be broken down into relevant entries. Each entry would also provide, where known, details of the language of

the text, colouring, ornamentation, material type and size. Much of this information, however, would be drawn from existing catalogues and is not envisaged that all entries would be complete in all such detail⁸.

- v) The catalogue would contain selected illustrative material to indicate the palaeography and physical form of the sources listed.
- vi) A listing of archives and classes of records consulted, a bibliography and place and subject indices would be provided.

3.3 Use of the Catalogue of Sources

3.3.1 Current Uses

In its primary role as one of the three strands constituting the Dover A20/Sewers Project, the compilation and enhancement of the catalogue of sources has been seen as a resource enabling the archaeologist and palaeo-environmentalist to locate documentary evidence pertinent to particular themes or specific to site interpretation, and to provide information relevant to the presentation and writing of the overall narrative. To meet this use four undertakings are proposed.

- i) The preparation of a separate place, date and subject index which would be compiled and maintained the course of the compilation of the catalogue of sources providing a unique finding aid for consultation by the archaeologist and palaeo-environmentalist
- ii) The identification of sources and preparation of listings of particular groups of documents to pursue archaeological and palaeo-environmental themes.
- iii) The selection of specific documents for translation and transcription as required,
- iv) The drawing of a series of thematic and period historical plans, reconciled to the present Ordnance Survey 1/2500 plans, showing the development of the urban landscape of the town and port of Dover, at fifty year intervals between *circa* 1600 and 1900, and at lesser intervals as required during the early and later medieval periods.

3.3.2 Future Uses and Combining the Record

The catalogue should also be compiled to enable it to stand on its own as a guide to available documentary evidence of direct relevance to the urban landscape history and development of the town and port of Dover.

To meet this objective it is proposed to undertake the tasks of compilation and enhancement of the catalogue of sources in a way which would enable it any time to be terminated but remain substantially complete in its own right; and perhaps also in a format suitable for inclusion on a data-base.

Since the publication of *Planning Policy Guidance Notes 16*, and the establishment of a county-wide archaeological service within Kent in 1989, the preservation of archaeological remains within their landscape setting has become firmly established within the planning process.

This service has now been widened to encompass the historic environment as a whole under heritage conservation. Archaeology is now considered as one element of the heritage resource, the remaining two being historic buildings and the historic landscape, with the latter including the interpretation of the present landscape and the use of documentary evidence.

Within this framework, the catalogue of sources, together with the archaeological and palaeoenvironmental archives generated during the course of the Dover A20/Sewers Project, may be considered as ideal candidates for inclusion and as a possible starting point for the creation of the Urban Archaeology Database for Dover.

Besides the four tasks proposed for the use of the catalogue of sources in this assessment the scope for its future application remains limited, and consideration should be given to its potential and use as part of a future unified heritage resource archive.

To meet the demands of any future uses it is proposed as a first step to undertake a study to establish the possibility of placing the catalogue on to a computer data-base in a form compatible with the requirements laid down for the Urban Archaeology Database.

4 Time and Cost Estimates

The following time and cost estimates correspond to the arrangement of the recommendations detailed in Section 3.

4.1 Enhancement of the Catalogue of Documentary Sources.

Consultation of in-county and out-county by class of record based on the significance of the any identifiable sources.

To complete this undertaking to a reasonable standard it is estimated that this phase would take 2 years.

In anticipation that there would be a diminishing return of information with time it is suggested that the main task be phased into 6 monthly periods, followed by separate tasks covering the compilation of the catalogue comprising various elements, and an assessment of the necessity or otherwise for further work.

1 Introduction

William Eldred's plan of Dover harbour, completed in 1641, comprises three separate parts, a preface, a series of five plans on ten pages, and a corresponding schedule. The plans depict only a few buildings in elevation and the majority of the individual properties are shown in block plan, within which is given the name of the respective tenant in 1640, and the measurements of the boundaries of each property in feet. The schedule, which is written on the verso of each plan, is in a boxed tabulated form describing each parcel of land or property under the heads of the individual streets, giving the names of the respective tenants holding a property in both 1605 and 1640, with the final column giving the property abuttals and the measurement of each boundary in feet. Whilst the following transcript broadly reproduces the original arrangement of the schedule its layout has been modified for the sake of clarity. The spelling, which in the original varies considerably, has likewise been made consistent and similarly, all contractions have been expanded. The original forms of all proper names have, however, even where obviously inconsistent, been retained and are shown thus in italics.

2 Description of the Plans

Part of the western end of *Snargat Strete*, from Snargate, showing layout of properties and boundaries on its north and south sides, with intervening alley ways on north side. Linear measurements in feet for each property and with name of tenant. Buildings are not depicted.

Between Butchery Gate and Snargate a large building in elevation, presumably the Customs House at the Pennyless Bench on the site of the Boldware or Severus Gate.

To the south of the Great Pent a semi-circular access described as the *The Croofe Wale of the Great Pente* and abutting on the east a quayside property with name of tenant and linear measurements in feet.

To the south-west of *The Great Pente*, sited on the shingle beach, an ornamentally fenced enclosure with buildings in each corner and central northern gateway entrance described as *The Bowling Place*.

To the south, a timber jetty or pier, shown in elevation, and described as The newe Head made in A° 1638.
