## Data Supplement Volume (Stage 3a)

This volume contains all the data gathered during this assessment, including that incorporated in the Stage 1 and 2 Data Supplement volume. In certain instances data in the earlier volume has been updated (for example, there are instances where the land use has changed between the dates of compiling the two reports). An explanation of the means by which the data has been collected will be found in the Stage 1 and 2 Evaluation Report, and the Stage 3a Evaluation Report. Both reports are accompanied by separate volumes of Figures. In the case of the stage 3a report only the 1:10,000 plans are presented in the figures volume; all other illustrations are presented in this volume, and will be found immediately following the data records to which they relate. Where plots of artefacts recovered from more than one adjacent field have been combined on the same plan, appropriate cross-referencing has been made under "Field Description".

Records for areas which were included in Stages 1 and 2, but subsequently excluded from the corridor defined as the Stage 3 study area, have been included for the sake of completeness, but are shown as having been excluded from assessment at Stage 3 by a suitable rubric at the end of the entry.
