Licence, for 100*s*., which Hugh Cokhevede of Barton will pay to the king for alienation in mortmain by the abbot and convent of Louth Park to the chaplain of a chantry to be ordained by the said Hugh in the chapel of St Mary, Barton-upon-Humber, to celebrate divine service daily in that chapel for his good estate and for his soul when he is dead, and for the souls of his ancestors and his heirs, of 5 marks rent, secured on the abbey and the manor of Ravendale.<sup>109</sup>

#### Annexe 2: Foundation of Ouresby's Chantry

21 May 1392. Licence, for 20*l*., paid to the king by John de Ouresby of Barton, for alienation in mortmain by him of a yearly rent of 100*s*. receivable from 15 messuages, one mill, 100 acres of land and 50 acres of meadow in Barton, not held in chief, to a chaplain to celebrate divine service daily at the altar of St Thomas the Martyr in the chapel of St Mary, Barton, for the good estate of the said John, Maud his wife, for their souls after death and the souls of their parents, brothers, sisters, ancestors, and heirs and others, in accordance with his ordinance.<sup>110</sup>

#### Lists of churchwardens of St Peter's and St Mary's

Warwick Rodwell

Books containing seventeenthand eighteenth-century churchwardens' accounts for both St Peter's and St Mary's were extant in the late nineteenth century, but were subsequently lost. These were not only a valuable record of works undertaken and expenses incurred, but also supplied the names of the churchwardens of the time. It was usual for one to change each year and the other to continue for a second term, thus ensuring continuity; on the other hand, some were repeatedly re-elected. Partial transcripts of information contained in the lost accounts were made by Hesleden, Ball and Moor, and some excerpts from these were printed in the Barton Parish Magazine (Moor 1893).

Hesleden compiled a near-complete list of St Peter's churchwardens for the period 1650–1772, using an account book which is now lost.<sup>111</sup> It was seen by Ball, but had disappeared before 1889.<sup>112</sup> The extant accounts for St Peter's, cover the period 1847–1902.<sup>113</sup> A list of churchwardens from 1819 was compiled in 1915 from surviving sources.<sup>114</sup>

The churchwardens' accounts book for St Mary's covering the years 1640-1760 was also seen by Hesleden and Ball,<sup>115</sup> but that too had been lost sometime before 1889. It was recovered by Moor in 1893, but was once again missing by 1912.116 Unfortunately, names of the the churchwardens were not abstracted, and

are thus unknown. Additionally, Moor found another source giving churchwardens' names back to the beginning of the seventeenth century.<sup>117</sup> Accounts now survive only from 1855– 1902, but a list of churchwardens compiled in 1915 extends back to 1819.<sup>118</sup> There is a combined book of accounts for St Peter's and St Mary's, covering the period 1902– 20.<sup>119</sup>

The lists of churchwardens have not previously been consolidated and published. Here, they have been assembled from the foregoing sources, but their accuracy cannot be vouched for; and there are gaps. Variant spellings and contractions have been retained. Numerous mentions of churchwardens appear en passant in legal and other documents, and these provide not only cross-checks with the lists but also additional names. Extensive research amongst these sources awaits the undertaking.
