

### ARCHAEOLOGICAL WATCHING BRIEF

#### NON-TECHNICAL SUMMARY

- On the 31<sup>st</sup> October 2001, a representative from the City of Lincoln Archaeology Unit undertook a watching brief on behalf of the UK Golf Group, during the groundwork associated with the construction of a clubhouse at Moor Lane, Thorpe-on-the-Hill. The clubhouse formed one element of a proposed golf academy extending over an area of approximately 17 hectares.
- The watching brief revealed no archaeological features or deposits. However, whilst negative, this information could be of value for future decision-making with regard to the management of the archaeological resource in this area of North Kesteven.

### ARCHAEOLOGICAL WATCHING BRIEF

#### **1.0 INTRODUCTION**

On 31<sup>st</sup> October 2001, a representative from the City of Lincoln Archaeology Unit (CLAU) undertook a watching brief on behalf of the UK Golf Group, during the construction of a clubhouse at Moor Lane, Thorpe-on-the-Hill, Lincolnshire. The watching brief was carried out in response to a brief set out by the Heritage Officer to North Kesteven District Council (Hambly 2001). The brief required the implementation of a watching brief during groundwork associated with the development in accordance with a condition of planning consent (Planning Application N/64/0563/01).





Fig. 1: Site location plan.

The site (Fig. 1) lies in the parish of Thorpe-on-the-Hill, approximately 2 miles south of the city of Lincoln (see Fig. 1). To the north of the site lies Moor Lane, while agricultural land is located to its east and west. The village of Thorpe-on-the-Hill is located to the south-west. Topographically, the site lies at approximately 15m OD with underlying geology consisting of sand and gravel over lower lias clay.

#### 1.1 Summary Archaeological Background

The following information has been extracted from the *Brief for Archaeological Observation and Recording* produced by the Heritage Officer for North Kesteven District Council (Hambly 2001).

The Roman road, the Fosse Way, traverses the landscape approximately 400m south-west of the western limits of the proposed development area. The Fosse Way was a major Roman road constructed in the second half of the  $1^{st}$  century AD by the Roman army to connect the legionary fortress of Exeter with Lincoln.

Field survey was carried out prior to the upgrading of the Fosse Way within a 1km corridor along the length of the highway. Two significant concentrations of Roman pottery were recorded within 200m and 400m south-west of the area of proposed development.

Two prehistoric stone axes have been recorded from Thorpe-on-the-Hill. The village itself is of medieval origin.

#### 2.0 AIMS & METHODOLOGY

The aims of the watching brief were:

A. to produce an archive record of deposits and remains generally within the constraints of the groundwork contractors' working methods and programme as related to the project design, with due regard to current Health and Safety legislation.

B. to produce a report on the potential archaeological importance of the discoveries.

C. to produce a project archive from which the potential for further study and academic research could be assessed.

D. to provide information for accession to the County Sites and Monuments Record (SMR).

The archaeological record was secured by means of trench-side notes. A photographic record of the groundworks was also compiled.

#### **3.0 RESULTS**

Excavation of the foundation trenches (Fig. 2) for the clubhouse revealed no archaeological features or deposits. Sands and gravels occurred 300mm-400mm below the level of topsoil (Context [001] - a friable, dark brown coarse sandy soil with occasional-frequent small rounded pebbles).

Although the results of the monitoring of the groundwork were negative, this information could be of value for future decision-making with regard to the management of the archaeological resource in this area of North Kesteven.
