A steep cut to the north of the cellar wall (containing a loose light brown earth with frequent limestone fragments) was interpreted as the construction trench for the cellar. A similar cut was noted at the east end of the east-west trench, once again in association with a cellar wall. It had been cut through mid brown earth with an approximate depth of 0.75m which in turn sealed a loose light brown mortar (approximately 0.1m thick). A dark brown earth (approximately 0.4m thick) then extended to below the lower limit of excavation. Site workers reported a limestone wall extending northwards from the north west corner of the building. Its precise depth was not clear but it appeared to lie directly below a later brick wall.
