#### Summary

An archaeological watching brief was undertaken during groundworks at the above site. A number of Victorian dumped deposits were present but no significant archaeological remains were found.

#### Introduction





Fig.1 Location of College Farm, Saleby, Lincs (Crown copyright: c reproduced from the 1956 Ordnance Survey 1:10,560 scale map sheet TF47 NE with the permission of the Controller of the HMSO. LAS Licence No. AL 100002165)

Lindsey Archaeological Services was commissioned by Mr and Mrs Brudenall in October 2005 to undertake an archaeological watching brief at College Farm, Saleby, Lincs (Fig. 1). The work was carried out in accordance with the brief and general requirements set out in the *Lincolnshire Archaeological Handbook* published by the Archaeology Section, Lincolnshire County Council (1998). Richard Pullen and Matthew Jordan recorded the site.

#### Site Location and Description

Saleby is a small village located in the Lincolnshire Marsh 3km north of Alford. College Farm is situated near the centre of the village. It is located on the south side of Mill Lane, west of the main T-junction in the centre of the village.

#### Planning Background

Planning permission was granted for partial demolition of the existing building and the construction of an orangery and a larger extension, subject to an archaeological watching brief being carried out during the groundworks phase of construction.

#### Archaeological Background

Saleby is mentioned in the Domesday Survey of 1086 when there was land held by two estates based in Claxby. It was clearly an established settlement in the Saxon period but probably a minor one. The present church is 19<sup>th</sup> century in date but sites on the site of an earlier building. A medieval moated site is located south of the village. Medieval occupation evidence may be disturbed during the groundworks phases of construction.

#### Aims and Objectives

The purpose of the Watching Brief was to record any archaeological deposits disturbed during groundworks at the above site.

#### Method

Groundworks were to be carried out on three separate occasions comprising

- Excavation of strip foundations for the orangery measuring 5 x 3m
- Excavation of strip foundations for the extension measuring 14 m x 6m
- Excavation of service trenches

There was one experienced archaeologist on site to observe earth moving operations. After consultation with the Assistant Built Environment Officer, Louise Jennings, it was decided an archaeologist need not be present during excavation of the service trenches as these would not go beyond the depth of the previously monitored groundworks.

Archaeological features were to be excavated, and drawn where appropriate, depending upon safe access. A full photographic record was made of the works on site. Finds located in archaeological features, were identified accordingly and a context numbering system for archaeological remains was in operation. LAS operates a standard context recording system, developed by its staff over the past 20 years based on MOLAS and CAS models.

#### Results (Fig. 2, Pl. 1)

#### Excavation of strip foundations for the orangery






Fig. 3 Typical section seen in Orangery foundation trench

The foundation trenches for the orangery were dug 27<sup>th</sup> October 2005 to an average depth of 1m. They were dug through a 0.40m thick mid brown sandy silt topsoil layer, **100**, which overlay a brown 0.30m thick orange clay subsoil layer **101**, which overlay the natural, a cream buff compact clay with frequent limestone fragment inclusions **102** (Fig. 3, Pls. 2, 3 and 4). This profile was seen throughout the trench, the only variation being disturbance related to construction of the house and cellar/underground log store. No archaeological features were seen.

#### Excavation of strip foundations for the extension





Fig. 5 Section through cess pit and outside toilet in extension foundation trench

Foundations for the extension to the northeast of the house were dug on the 4th of November. The northwest section of the foundation trench extended 14m northeast from College Farm. The first 4.8m of the trench cut through the floor surface of the former scullery which had been removed prior to this phase of the work (PI. 5). The profile in this part of the trench showed a 0.10m compact limestone surface **200**, which overlay a 0.10m thick grey clay bedding **201**. This overlay a 0.34m thick, grey orange sandy clay subsoil **202**, which overlay a compact orange brown clay **203**, which represented the natural deposits. Just north of the remains of the scullery were the remains of an outside toilet and cess pit. Cess pit/earth closet **204** measured 1.5m wide x 1.2m deep. The pit contained **209**, a compact grey clay which overlay a dark grey brown silt **205** which contained Victorian pottery fragments, broken glass and brick. This overlay **206**, a dirty grey clay. Cutting these fills was pit **211** which contained the brick foundations **207**, comprising parallel walls 0.80m apart which contained fill **208** a brown grey silty sand between the walls (Fig. 5, PI. 6). These are the remains of a later outside toilet structure. In the rest of the foundation trench a mid brown sandy silt topsoil **210**, overlay the subsoil **202**, no further features were seen with the exception of occasional pieces of Victorian pottery in the topsoil (Fig. 4, PI. 7, 8).




PL. 2 View of location of orangery, west side of College Farm
