
#### SUMMARY

A watching brief was maintained at Percylieu on 24 October 2011 for installation of a wind turbine (Aberdeenshire Planning Application 2011/2421). No archaeological remains were uncovered and it is recommended that no further archaeological work is required at this site during the current development although the final decision remains with Aberdeenshire Archaeology Service.

## 1 INTRODUCTION

A watching brief was carried out at Percylieu, Clatt, Huntly, Aberdeenshire on 24 October 2011. The site is in Clatt parish, the NGR for the site is NJ 53285, 26369 and the it lies at 220-230m OD. The work was commissioned by Mr Anderson, Percylieu, Clatt and refers to Aberdeenshire Planning Application 2011/2421 for the erection of a wind turbine; condition 8 states that the applicant must secure an archaeological watching brief during the soil removal for the turbine base.

The watching brief was carried out in the context of Scottish Planning Policy (SPP) Planning Advice Note (PAN 2/2011) and Scottish Historic Environment Policy (SHEP), which state that archaeological remains should be regarded as part of the environment to be protected and managed.




III 1 Location plan (© Crown copyright and database right 2010).

## 2 ARCHAEOLOGICAL BACKGROUND

There are no known sites of archaeological significance in the fields surrounding the wind turbine trench but many sites are known in the wider vicinity.

- 2.1 A small urn (possibly a food vessel) was found in the mid 19th-century 250m NE of Newbigging farmstead (NJ52NW 17; NJ 5322 2622). It was about 6 inches (152mm) high and 4 inches (102mm) in diameter and a sketch was made from the description of the Rev J Minto, schoolmaster, Kirktown of Clatt. (Name Book 1866, 21). The vessel is now lost.
- 2.2 Upwards of twenty tumuli (NJ52NW 11; NJ 532 263) were located on what is now cultivated ground 250m SW of Percylieu. They were destroyed during land reclamation about 1846. Each consisted of 'a continued series of upright stones' about 18 feet in diameter. In the centre a grave 'of the usual dimensions' had been dug, some cut in solid rock to a depth of about 5 feet. Burnt bones were found in some of them, and in others ornamented urns full of calcined bones (Name Book 1866, 24-5).
- 2.3 Several fragments of Pictish stones are known from the area. Two symbol stones remain in the churchyard at Clatt (NJ52NW 7; NJ 5389 2600). One is a small triangular fragment decorated with a double disc and Z-shaped rod symbol whereas a larger fragment is now built into the churchyard wall and bears the 'elephant' symbol and the 'arch or horse-shoe' symbol (J Ritchie 1910, 6). One other fragment from Clatt churchyard is now to the south wall of Knockespock House (NJ52SW 12; NJ 5442 2408). It is incised with a triple ring and bar symbol, double disc and Z-rod and mirror (J Ritchie 1910, 6).



A rectangular slab of whinstone now at Leith Hall (NJ52NW 19; NJ 5399 2998) bears at the top, the two fins of a fish, the rest of which is broken away, and below it the horse-shoe symbol which is ornamented with lines and dots (III 2, Ritchie 1910, 209-12). Gurnell (1884) adds that the stone stood at a well called the 'Salmon Well' at Hillhead (NJ 521 265) until about 1844 when it was removed to Percylieu, where it was broken to fit a door sill. About 1887 it was taken to Cransmill (NJ 461 306) and then to Mytice (NJ 475 309).

## 3 THE WATCHING BRIEF

A watching brief was maintained on 24th October 2011 during the topsoil strip of a 5 x 5m trench for a wind turbine. The well-drained topsoil was 0.4-0.5m deep and the natural subsoil was light brown sandy clay. No finds or features were identified.
