
SUMMARY

A watching brief was maintained at land north of Ardlair, Strachan, Banchory, Aberdeenshire on 2 February 2012 for installation of two wind turbines (Aberdeenshire Planning Application 2011/1472). No archaeological remains were uncovered and it is recommended that no further archaeological work is required at this site during the current development although the final decision remains with Aberdeenshire Archaeology Service.

1 INTRODUCTION

A watching brief was carried out at land north of Ardlair, Strachan, Banchory, Aberdeenshire on 2 February 2012. The site is in Strachan parish, the NGR for the site is NO 67054 93378 and it lies at 205-215m OD. The work was commissioned by Enviko Ltd (contact Louisa Coursey) on behalf of Mr Brian Middleton, Ardlair and refers to Aberdeenshire Planning Application 2011/1472 for the erection of two wind turbines; condition 9 states that the applicant must secure an archaeological watching brief during the soil removal for the turbine base.

The watching brief was carried out in the context of Scottish Planning Policy (SPP) Planning Advice Note (PAN 2/2011) and Scottish Historic Environment Policy (SHEP), which state that archaeological remains should be regarded as part of the environment to be protected and managed.

2 ARCHAEOLOGICAL BACKGROUND

- 2.1 200m west of the current site is a cairn (NO69SE2) of bare stones partly robbed at the north and south. It appears to stand on a platform 29m in diameter and 0.6m high.
- 2.2 200-300m north of the current site is a robbed cairn lying within a field system (NO69SE7) consisting of stone clearance heaps and lynchets.
- 2.3 400m east of the current site is a large E-W rectilinear enclosure (NO69SE14) seen on aerial photographs; there are also stone clearance heaps, a hollow way and earlier field boundaries.
- 2.4 The farm name Ardlair appears on the First Edition Ordnance Survey map (surveyed 1867; Illus 2).
- 2.5 The fields have been regularly ploughed by the current farmer and his father who bought the farm in 1924 (Brian Middleton pers comm).

3 THE WATCHING BRIEF


A watching brief was maintained at land north of Ardlair, Strachan, Banchory, Aberdeenshire on 2 February 2012 for two trenches for the installation of two wind turbines. Two trenches 6 x 6m in size were excavated using a tracked machine and 1.8m ditching bucket.

Trench 1

Trench 1 was located at the SE corner of the field (Illus 3). The heavy clay ploughsoil was 10cm deep at the east of the trench next to the field dyke and 25cm at the west of the trench. The subsoil was rusty brown sand with many large and medium stones. Several stoneholes were investigated but no archaeological features or finds were identified in this trench.

Trench 2

Trench 1 was located at the east side of the field near the brow of the hill (Illus 3). The heavy clay ploughsoil was 10cm deep at the east of the trench next to the field dyke and 20cm at the west of the trench. The subsoil was rusty brown sand with many large and medium stones. No archaeological features or finds were identified in this trench.

4 **RECOMMENDATIONS**


It is recommended that no further archaeological work is required at this site; this is subject to advice from Aberdeenshire Archaeology Service.
