

1 INTRODUCTION


Aberdeen City Council are carrying out a soft strip and possible demolition of St Nicholas House, the former headquarters of the Council. The work is not subject to Planning Permission but the Council has appointed Cameron Archaeology to carry out archaeological work following advice from Judith Stones, Lead Curator, Local History and Archaeology Museums and Galleries, Education, Culture and Sport, Aberdeen City Council. The project contact is Andrew Sproull, Programme Director, Marischal College Project, Marischal College, Aberdeen, AB10 1AB. The site is at NJ 94198 06385 (centred), in the parish of Aberdeen and at 20-25m OD.




Illus 1 Site location (Contains Ordnance Survey data © Crown copyright and database right 2012).

2 BACKGROUND

- 2.1 The site is centred upon National Grid Reference NJ 94198 06385 and is bounded by Broad Street to the east, Upperkirkgate to the north, Flourmill Brae to the west and Netherkirkgate to the south.
- 2.2 Mesolithic activity has been found at several sites in the vicinity. Several hundred flints were recovered from earliest layers at the adjacent 16-18 Netherkirkgate/ Guestrow site (Cameron 2001, 30; Illus 2 No 3) and at 12-26 Broad Street (Murray 1982, 26-27; Illus 2, No 6).
- 2.3 This site is at the centre of the medieval burgh of Aberdeen; Parson James Gordon's map of Aberdeen 1661 (Illus 3) shows that this area was well developed by this period. Substantial well-preserved medieval remains were found at several sites in the vicinity including Marischal College on the opposite of Broad Street (Cameron forthcoming), Gallowgate Middle School (Cameron 2001, 73-79), 43-57 Upperkirkgate/Flourmill Brae (Cameron 2001, 50-58), 16-18 Netherkirkgate (Cameron 2001, 28-37), 30-46 Upperkirkgate (Stones 2001, 60-69) and 42 St Paul Street (Murray 1982, 46-84).




Illus 2 St Nicholas House with neighbouring archaeological interventions (*Contains Ordnance Survey data* © *Crown copyright and database right 2012*).



- 2.4 Provost Skene's House was built in the 16th century, and is one of the Aberdeen's few surviving examples of early burgh architecture. The first reference to the plot of land was in 1545 when Alexander Knollis took possession of the site on Guestrow, one of Aberdeen's principal streets at that time . By 1661 (Illus 3) the NE part of the site is occupied by houses on the south side of Broad/Bread Street, south of which Guestrow (Gwestraw) runs across the current site NW-SE and south of this another line of buildings which include What is now Provost Skene's House. South-west of these buildings are backlands running along the entire west edge of the site.
- 2.5 The site is heavily built up in the First and Second Edition Ordnance Survey maps (Illus 4) with Guestrow still extant across the site and extensive buildings on both the north and south of this street.

3 HOARDING POST PITS - WATCHING BRIEF

Three areas of pits for the posts for the hoarding were observed. All pits contained only 19th and 20th century deposits and these were mainly concrete, brick and stone associated with the roads, St Nicholas House and the 19th-century tenements which had previously occupied much of the site. Details appear inn archive. No watching brief was carried out at the Upperkirkgate end of the site as this area has been disturbed by the underground car park. The hoarding on the north and NW sides of Provost Skene's House were attached onto existing fences and fittings and so no post-holes were required in these areas.

4 ARCHAEOLOGICAL EVALUATION

A grassed area 9 x 20m in size was available for archaeological evaluation and two trenches were excavated on 28 September 2012.

Trench 1

This trench was a maximum of 3m wide and the full width of the area. To the west an electric cable was encountered; a bore hole had been sunk to the east of this trench. Two wall foundation trenches (F1 and F2; Illus 7, 10) were up to 1.2m deep and 1m wide and were associated with the 19th-century tenements which were on the site on the OS maps (Illus 9).

Trench 2


Trench 2 was at the NE end of the available area. A concrete duct (F3; Illus 8-10) was 2m wide and had cut through all deposits at the NW end of the trench. Garden soil deposits at the SE end of the trench on top of natural subsoil indicated that this area had not been disturbed in the medieval or later period. No features or finds were recorded however. There is therefore potential in this area for archaeological deposits to survive and it is recommended that an archaeological evaluation of the surrounding area (Illus 10) should be carried out prior to any future development.




