#### SUMMARY

A watching brief on the soil strip for the new garage and a Level 2 standing building survey were carried out on 30 September 2013. The building to be partly demolished is a former farm mill and details were recorded. The watching brief showed that the area had been previously disturbed, planted with trees and then used as an area for dumping and no archaeological contexts or finds were recorded. It is recommended that no further archaeological work is required during this current development.

# 1 INTRODUCTION


A planning application P130762 for conversion and extension and construction of a new garage at Viewfield, Clinterty, AB21 0TL was passed by Aberdeen City Council on 12.9.13 with a standard archaeology condition (condition 1). The work was commissioned by Keith Moir, Squire Associates on behalf of clients Mr and Mrs Tim McKay. The site is at NJ 83442 11795 in the parish of Newhills and at a height of 85-90m OD.

# 2 THE WATCHING BRIEF

A watching brief on the soil strip for the new garage (Illus 2) was carried out on 30 September 2013. In the late 19th century a cist and burial (Shepherd, I A G 1986) had been found immediately south of the proposed garage (Illus 7, 8). The watching brief showed that the area had been previously disturbed, planted with trees and then used as an area for dumping and no archaeological contexts or finds were recorded.



Illus 2 Plan showing watching brief area and building surveyed (based on copyright Squire Associates).


# 3 THE STANDING BUILDING SURVEY

A Level 2 Standing Building Survey was carried out on 30 September 2013 as the structure is to be partially demolished to allow for redevelopment. The building is constructed of large pink granite blocks with cherry cocking. It is 9.7m long and 4.1m wide and the walls are c 0.75m wide and is oriented on an ESE-WNW alignment. The building can be seen on the First, Second and Third Edition OS maps as part of Clinterty Cottage and associated farm buildings (Illus 7, 8).


The north wall of the building originally had three apertures (F1, F2 and F3; Illus 3, 4) which had subsequently been blocked. The small size of the apertures ( $c 0.5 \times 0.5m$ ) and the fact that they are sited low on the walls suggests that were probably for drive shafts and other mechanisms for a mill indicating that the building had been used as a mill, possibly a threshing mill for the farm. The First Edition OS map shows a mill pond to the east of the building (Illus 7) and issues bringing water from the NE to the farm; a lade presumably took


the water to the mill along the property boundary at the north side of this building but all traces have been lost on the ground and this is not indicated on the OS maps.

These apertures were then blocked and alterations carried out at the west end of the building including blocking a door at the west end of the south wall and also possibly shortening the building, possibly due to widening of the road. Subsequently the foundations have been revealed by reduction of the ground level at the west end causing large cracks in the north and south walls.




