

## SUMMARY

The watching brief took place on 9 July and 22 August 2014. One agricultural furrow was identified in the NW turbine base but no other archaeological features or finds. The soil strip for the proposed turbine is now complete and no further archaeological work is required.

#### 1 BACKGROUND


- 1.1 The site (Illus 1) is located on the east side of Dykelands Farm, Laurencekirk. It is centred on NGR NO 70453 68673, at 100-110m OD.
- 1.2 The work was commissioned by Richard Milne, Dykelands Farm. Full planning permission (2012/4209) for erection of 2 100kW wind turbines and associated meter housing and access track was granted by Aberdeenshire Council Planning Committee on 13 May 2013 with a standard archaeology condition (condition 5). Aberdeenshire Council require a watching brief on all ground disturbance for the wind turbine bases and cabling.
- 1.3 All the archaeological work will be carried out in the context of Scottish Planning Policy (SPP) Planning Advice Note (PAN 2/2011) and Scottish Historic Environment Policy (SHEP), which state that archaeological remains should be regarded as part of the environment to be protected and managed.


#### 2 ARCHAEOLOGICAL BACKGROUND

- 2.1 There are no Scheduled Ancient Monuments or Listed buildings within 1km of the proposed development site.
- 2.2 In the field north of the proposed development air photography has revealed the cropmark of a ring-ditch in arable ground on a gentle NW-facing slope at an altitude of 110m OD. The faint trace of a possible second ring-ditch is apparent immediately NW of the first ring-ditch and partly overlain by it (NO76NW 22 NMRS, MS/712/90; M Greig 1999, 6).

#### 3 THE ARCHAEOLOGICAL WATCHING BRIEF

The watching brief took place on 9 July and 22 August 2014 (Illus 4). The soil strip of the track had been mostly completed prior to arrival but inspection of the track revealed no archaeological features or finds. The topsoil was 0.1m deep over much of the track to a maximum of 0.25m deep in places. The topsoil is heavy reddish brown sandy clay and the subsoil heavy reddish brown clayey gravel.

The turbine bases were 7.8 x 7.8m in size and the depth of the topsoil is 0.2-0.3m. One undated furrow up to 2m wide and 0.05m deep ran WNW-ESE across turbine base 1 was recorded but no further archaeological features or finds were identified.


