SUMMARY

A Level 1 standing building survey was carried out on 27 July 2018. Three phases of development were identified with Phase 1 being an early 19th-century cottage, with a small stone steading added in Phase 2 and an unroofed enclosure in Phase 3. All were completed by the date of the First Edition OS map. It is recommended that no further archaeological work is required during the current planning application.

1 INTRODUCTION

- 1.1 The site (Illus 1) is located on the SE side of the B993 just S of Millbank. It is centred on NGR NJ 65967 10438, at 155-160m OD (Illus 1) and in the parish of Midmar.
- 1.2 The work was commissioned by Robert Murray. A planning application APP/2018/1347 for a replacement house is awaiting decision. There is a requirement for a Level 1 standing building survey.
- 1.3 All the archaeological work was carried out in the context of Scottish Planning Policy (SPP) Planning Advice Note (PAN 2/2011) and Scottish Historic Environment Scotland's Policy Statement (HESPS), which state that archaeological remains should be regarded as part of the environment to be protected and managed.




Illus 1 Location plan (Contains Ordnance Survey data © Crown copyright and database right 2018)

2 BACKGROUND


The building does not appear on the Aberdeenshire Sites and Monuments Record or on the Historic Environment Scotland National Monument Record. On the First Edition OS map (Illus 14) the three rooms are recorded with the SE Room 3 being unroofed. By the 2nd Edition OS map (Illus 15) the building is on the same proportions divided into two rooms (probably inaccurately recorded) with a small building to the NE which has since been demolished.

3 THE LEVEL 1 STANDING BUILDING SURVEY

A level 1 standing building survey was carried out on 27 July 2018. The weather was hot and sunny. A full photographic record was taken, architects plans and elevations checked and amended and measurements recorded.

Phase 1

In Phase 1 a cottage was constructed 5.2m wide and 11.25m long (Illus 4). It has a central door and windows on the NE façade and two small windows on the SE end of the SW façade (W1, W2; Illus 5). The cottage was roofed in grey slate but some of the NE facing roof has been replaced with corrugated tin. The cottage is constructed of red and grey granite with grey granite door and window dressings and fieldstone rubble. The walls are 0.5m thick. The interior walls have been removed but the scar of the SE gable wall can be seen (F5 and there is a fireplace in the NW end of the building (F3; Illus 6) and a fireplace has been removed from the SE end of the building (F4). The floor has been concrete but some has been removed revealing the earthen surface underneath.

Phase 2

Phase 2 was a room (Room 2) butted on to the SE wall of Room 1. Room 2 is 5.2m wide and 8.3m long. It is made of stone rubble, grey and pink granite and grey granite sills and lintels. There are two doors on the NE wall (D2, D3; Illus 7) and one small window in the SW wall (W3; Illus 8). There has been a cobbled stone floor (Illus 9) some of which has been removed suggesting that this would have been a room for housing animals. The roof is corrugated tin and the SE wall has been removed but the scar is visible (F6).

Phase 3

In Phase 3 a small unroofed extension was butted onto the SE end of Room 2. It is 4.8m long and 5.2m wide and the SW wall is 0.4-0.55m wide and survives to 1.35m high whereas the NE wall is 0.4-0.5m wide and survives to 1.6m high (Illus 12). The walls are of granite rubble and fieldstone. There is a door in the NE wall (D1) and an aperture F1 (Illus 10, 11) in the SW wall. This aperture is constructed of grey granite lintel and sill and has a large grey granite blocked wedged into the aperture; the block has four drill holes on the internal façade. This aperture may have originally been a window and been blocked with a stone which may have been associated with a fitting such as a cheese press.



4 CONCLUSIONS AND RECOMMENDATIONS

A Level 1 standing building survey was carried out on 27 July 2018. Three phases of development were identified with Phase 1 being an early 19th-century cottage, with a small stone steading added in Phase 2 and an unroofed enclosure in Phase 3 (Illus 13). All were completed by the date of the First Edition OS map. It is recommended that no further archaeological work is required during the current planning application.




Illus 13 Phase plan showing main phases of development of the building (copyright Gordon Gauld)





