1 NON-TECHNICAL SUMMARY

Pre-Construct Archaeology Itd (PCA) was commissioned by Hugh Steed to undertake an archaeological watching brief during groundworks for the construction of a residential property including a basement, at 73 Switchback Road South, Maidenhead, Berkshire (487949 183062). The watching brief was carried out in two site visits, on the 7th and 12th August 2015.

No archaeological deposits, features, artefacts or environmental remains (significant or otherwise) were observed during the course of the watching brief. Natural gravel, encountered in the 3m deep proposed basement excavation, was sealed by a layer of 'Brickearth', in turn covered by a thin layer of modern build up. No other natural deposits were encountered.

The intact Brickearth, which showed no sign of previous disturbance, suggests the site does not lie over a former gravel quarry and is unlikely to have been the provenance of early prehistoric finds recorded from historic gravel extraction in the vicinity of the site.

2 INTRODUCTION

2.1 Project Background

- 2.1.1 Pre-Construct Archaeology Itd (PCA) was commissioned by Hugh Steed to undertake an archaeological watching brief during groundworks for the construction of a residential property including a basement, at 73 Switchback Road South, Maidenhead, Berkshire (487949 183062), hereafter 'the site' (Fig1). The watching brief was carried out in two site visits, on the 7th and 12th August 2015.
- 2.1.2 The site is the subject of a development, for which planning permission was been granted by the Local Planning Authority (LPA) The Royal Borough of Windsor & Maidenhead (planning reference 14/02145 an amendment to 13/00849), comprising the demolition of an existing dwelling and construction of a detached dwelling with basement and detached single garage. Planning permission for the development is subject to a condition, No.9, which states: 'No development shall take place within the application area until the applicant has secured the implementation of a programme of archaeological works, in accordance with a written scheme of investigation, which has been submitted by the applicant and approved by the Planning Authority'. The reason for the condition is given as: 'The site is within an area of high archaeological interest in relation to Palaeolithic remains, as demonstrated by the Berkshire Archaeology Historic Environment Record. A programme of archaeological investigation is required to mitigate the impact of development and ensure preservation "by record" of any surviving remains, or allow provision for preservation in situ should any such remains be considered to be of national significance. Relevant Policy Local Plan ARCH2'.
- 2.1.3 The required Written Scheme of Investigation (PCA 2015) was submitted to the LPA in February 2015. This report presents the results of the archaeological watching brief that took place over two site visits on the 7th and 12th August 2015. It has been prepared in accordance with the Chartered Institute for Archaeologists standard and guidance for an archaeological watching brief (IfA 2008) and *Management of Research Projects in the Historic Environment* (English Heritage, 2006).

2.2 Location, Geology and Topography

- 2.2.1 The site is located on the west side of Switchback Road South, Maidenhead, Berks, in the area of Furze Platt and approximately 2km west of the River Thames (figure 1). It is located in a residential area, with the current work contributing to the re-building of a residential property and basement.
- 2.2.2 Superficial deposits beneath the site comprise sand and gravel of the Lynch Hill Gravel Member (http://mapapps.bgs.ac.uk/geologyofbritain/home.html), part of the sequence of River Thames terrace deposits formed in the Quaternary Period up to 2 million years ago. Bedrock geology comprises Chalk.
- 2.2.3 The topography of the site is flat. Ground level occurs at approximately 42m above OD.

2.3 Archaeological and Historical Background

2.3.1 The site lies in an area of known archaeological sites and findspots that range in date from the Palaeolithic period to the post-medieval period. Of particular relevance, the site lies close to a number of significant finds of Palaeolithic date, namely flint tools including handaxes. These occur re-deposited within the Thames valley gravel terraces and notably the Lynch Hill Terrace on which the site is located. As such the proposed development of the site, particularly the proposed basement excavation has the potential to uncover Palaeolithic finds and related geo-archaeological deposits. However, there was some evidence that the site's archaeological potential had been affected by gravel extraction works.

3 AIM

3.1 Archaeological Watching Brief

3.1.1 The aim of the watching brief was to monitor ground works for the new development in order to identify and, if necessary, investigate, sample and record any archaeological resources that are present within the site, taking account of their potential to contain biological, palaeo-environmental and geo-archaeological remains. The aim of this report is to demonstrate that the watching brief was carried out in accordance with the approved Written Scheme of Investigation and in satisfaction of Condition 9 of planning permission.

4 RESULTS

4.1 Introduction

4.1.1 The following summary of results is based upon the site archive, which comprises the site diary and digital photographs. The archive is held at PCA's Winchester office under the PCA site code SRMB15 and will in due course be deposited with the appropriate museums service

4.2 Watching Brief

4.2.1 The watching brief comprised monitoring visits to observe groundwork for the proposed development, including new foundations and excavation for a new basement. Arrangements were put in place so that all ground work was effectively monitored by PCA as part of the ground work programme. Areas of the site that were monitored and found to be of no archaeological interest were identified by PCA to the main contractor.

4.3 Observations

- 4.3.1 No archaeological deposits, features, artefacts or environmental remains were observed during the course of the watching brief.
- 4.3.2 During the course of ground works the following natural undisturbed deposit sequence was observed in the excavated areas (Appendix 1, Plates 1-3 & Figure 2):

- Between 0.00m and 0.05m Below Ground Level (BGL):- Modern demolition build up
- Between 0.05m and <3m BGL:- 'Brickearth' of the Langley Silt Complex
- 3m+ BGL:- Gravel
- 4.3.3 Both the clay and the gravel was inspected for the presence of archaeological resources, however no deposits of a later prehistoric or historic date were identified in the clay and no evidence for early prehistoric activity was identified in the lower gravels.

4.4 Conclusion

- 4.4.1 Although the wider area around the site may have significant archaeological resources, the excavated area observed during this watching brief did not contain any features or deposits that could be considered archaeological.
- 4.4.2 The intact Brickearth, which showed no sign of previous disturbance, suggests the site does not lie over a former gravel quarry and is unlikely to have been the provenance of early prehistoric finds recorded from historic gravel extraction in the vicinity of the site.

5 ARCHIVE PREPARATION AND DEPOSITION

5.1 The Site Archive

5.1.1 The Site archive, to include all project records and cultural material produced by the project, will be prepared in accordance with 'Guidelines for the Preparation of Excavation Archives for Long-term Storage' (UKIC 1990) and the Institute for Archaeologists 'Standard and Guidance for the creation, compilation, transfer and deposition of archaeological archives' (IfA 2009). On completion of the project PCA will arrange for the archive to be deposited in accordance with the provisional arrangements made at the onset of the watching brief. Any alternative arrangements will be agreed with the Historic Environment Officer and the Local Planning Authority.





As such early prehistoric finds from gravel extraction could not have originated from this particular location.
