

#### 1 INTRODUCTION

- 1.1 An archaeological watching brief was conducted by Pre-Construct Archaeology Ltd at Cannon Wharf Business Centre, 35 Evelyn Street, Deptford SE8 5DG.
- 1.2 The watching brief consisted of the archaeological recording of a single trench measuring 11.20m by 2.25m trench located within the central southern area of the site, to a depth of approximately 2.3m below the bulk excavation dig level required for the new scheme.
- 1.3 The work was conducted on 19<sup>th</sup> May 2016, and was required by a planning condition attached to the permission for development which was granted by the London Borough of Lewisham under application number DC/08/68523. The redevelopment of the site will comprise commercial and residential units with external landscaping and car-parking.
- 1.4 The archaeological observation and recording was undertaken by James Webb and was project managed by Chris Mayo, both of Pre-Construct Archaeology Limited. Other, occasional monitoring visits to site were completed by the author in advance of the excavation of the trench.
- 1.5 Pre-Construct Archaeology Limited (PCA) were commissioned for the work by CgMs Consulting acting on behalf of the client, Barratt Homes.
- 1.6 The archaeological project was monitored for the local planning authority by Mark Stevenson of the Greater London Archaeological Advisory Service (GLAAS), of Historic England.
- 1.7 The study site lies within an Archaeological Priority Area as designated by the London Borough of Lewisham within their Unitary Development Plan.
- 1.8 The central National Grid Reference for the site is TQ 3621 7868.
- 1.9 The site was allocated the Museum of London site code EVN16. The complete archive comprising written, drawn and photographic records will be deposited within the London Archaeological Archive and Research Centre (LAARC).

#### 2 METHODOLOGY

- 2.1 An archaeological desk-based assessment was prepared for the site by CgMs Consulting (Gailey 2007) to support a planning application for the redevelopment of the site at Cannon Wharf Business Centre.
- 2.2 Planning permission (Planning ref: 08/68523/X) was granted for the redevelopment of the site in 2008 and a schedule of planning conditions was issued, including the following relating to archaeology:

#### 27 - Archaeology

No development shall take place on the site until the applicant, or any successors in title, has secured the implementation of a programme of archaeological work in accordance with a written scheme of investigation, observation and recording which has been submitted to and approved in writing by the local planning authority.

- 2.3 Following discussions with the Historic England GLAAS officer the following mitigation measures were agreed: the preparation of a heritage report on the industrial history of the site and an archaeological observation and recording exercise, during remediation works in a localised area of archaeological interest in the south of the site. In the event that the remediation works did not reach the natural geology then a single 10mx 1.8m trench was to be excavated instead.
- 2.4 The heritage report on the industrial history of the site was prepared by PCA in 2013 and subsequently approved by the Historic England GLAAS officer (Thompson 2013).
- 2.5 The fieldwork was executed on the 19<sup>th</sup> May 2016. A trench measuring 11.30m north-south by 2.25m east-west was excavated within the agreed area of archaeological interest, towards the southern edge of the site (Figure 2). The trench was excavated to a depth of approximately 2.30m BGL (a level of 0.0m OD).
- 2.6 The trench was excavated by mechanical plant provided by the Principal Contractor. It used a flat-bladed bucket to grade through soil horizons under close archaeological control until the lower alluvial units were reached.
- 2.7 The trench was inspected from ground level and fully recorded using standard single context recording methods as presented in PCAs *Operations Manual 1* (Taylor, 2009) and as outlined in the approved Written Scheme of Investigation (Gailey 2016).
- 2.8 The trench was planned and located from known points on site survey drawings, and the south facing section of the trench was drawn at a scale of 1:10. Digital photographs were taken as appropriate.
- 2.9 The site archive was labelled and identified with the unique site code EVN16.

#### 3 ARCHAEOLOGICAL SEQUENCE

- 3.1 It is known from geotechnical investigations (Gailey 2007) that the site is underlain by Kempton Park river terrace gravels and Thanet Sands; however these were not seen within the trench as excavation ceased at a height of 0.0m OD.
- 3.2 The lowest layer seen in the trench was a soft, dark brown peat [5] which was at least 0.15m thick from an upper height of +0.15m OD (Figure 3).
- 3.3 A layer of firm, blue grey clay [4] sealed the peat, at an upper height of c. +0.80m OD (Plates 1 and 2). It was around 0.64m thick. No finds were seen within this layer which was clearly a water lain deposit.
- 3.4 At c. +1.30m OD was an approximately 0.55m-thick layer of firm, yellowish grey silt clay [3]. This also contained no artefacts however sub-angular stones were noted.
- 3.5 A 0.32m-thick layer of redeposited peat [2] was found at a height of c. +1.65m OD. This soft, dark brown layer contained charcoal but no datable material.
- 3.6 Modern 20th century made ground was found at a height of c. 1.90m OD, 0.4m below modern ground level. This layer was approximately 0.3m thick and very clearly modern, containing CBM fragments, deeply frogged yellow bricks and charcoal. This layer was most likely a levelling deposit, relating to the reclamation of open pasture to allow the development of the site in the 19<sup>th</sup> century. The trench was sealed by a modern 0.25m-thick slab of concrete on top of which was a 0.15m-thick layer of tarmac.

#### 4 CONCLUSIONS

- 4.1 The single trench executed during the archaeological work was excavated to a depth of approximately 2.3m below ground level, which was below the bulk excavation project level which is required for the new development<sup>1</sup>.
- 4.2 Natural superficial geological horizons (terrace sands and gravels) were not encountered within the trench, however from borehole records located near to the trench (see WS1, 3, 4 & 5 in Gailey 2007, Appendix 1) they can be expected to exist at undulating levels beneath the site ranging from 2.8m BGL to over 3.5m BGL). The undulating nature of these deposits is entirely due to the sites' location within the former Thames estuary.
- 4.3 The peat layer may be evidence of the Bronze Age peat marshes which have been recorded on nearby sites such as the evaluation at Grove Street (Gailey 2007) and The Wharves in Deptford, located at TQ 36508 78337 (Hawkins 2015).
- 4.4 No archaeological finds or features were seen during the excavation.
- 4.5 The top 0.70m of the trench comprised 19<sup>th</sup> century and modern material, deposited as ground levelling. Below this no modern intrusions were seen.
- 4.6 The results of the site investigation will be published by PCA as a summary in the annual 'Round-Up' of *London Archaeologist*.
- 4.7 Upon approval this report and with confirmation that the site work is complete, the archive will be deposited with the London Archaeological Archive and Research Centre under the unique site code EVN16. Until then it will be stored by PCA at its offices in Brockley, SE4.


