1 INTRODUCTION

- 1.1 Observation of ground reduction was undertaken at the site of 14 Lansdowne Crescent in the Royal Borough of Kensington and Chelsea on 10th and 11th of January, and 13th March 2017 (Figure 1). The investigation was centred at TQ 24505 80746. The work was subject to an archaeological watching brief conducted by Kari Bower and Chris Mayo. It was given a unique site code of: LAD17.
- 1.2 Ground reduction occurred in an area to the north and east of the existing building, within the footprint of the lower ground floor built in the 1990s and the existing external reduced ground level beyond this basement on the northern side of the property. Modern concrete was broken out by machine and removed with a toothed bucket, while the topsoil was stripped with a ditching bucket under archaeological supervision until natural soils were encountered. Levels were taken from below ground level, although there is a slope down from Lansdowne Crescent in the west to the rear garden in the east.
- 1.3 The reason for archaeological monitoring of the site, which is located within the Notting Hill Archaeological Priority Area, was "to safeguard the archaeological heritage of the Borough in accordance with policy CL4 of the Consolidated Local Plan" (Planning Ref: PP/16/06526). The mandate of the watching brief was to investigate the location, extent, date, character, condition, significance and quality of any surviving archaeological remains, as well as record the elevation and nature of the natural drift geology if observed.
- 1.4 The ground reduction occurred within an area measuring approximately 135m² (Figure 2). The scheme involved the demolition and rebuilding of the existing side extension at lower and upper ground floor levels, a basement extension (new floor) to the replacement side extension and a lower ground floor rear extension. The new basement level would have an underside floor slab height of 20.71m OD, a depth of 5.29m below Lansdowne Crescent ground level, which is at 26.00m OD.
- 1.5 PCA was commissioned for the work by Mills Whipp Projects on behalf of Matthew Peacock. The project was managed for PCA by Chris Mayo. Curatorial oversight was provided by the Greater London Archaeological Advisory Service (GLAAS), on behalf of the Royal Borough of Kensington and Chelsea.

2 ARCHAEOLOGICAL RESULTS

- 2.1 The site is underlain by firm orange-brown natural London Clay [1], the top of which was at a depth of c. 0.50m below ground level (BGL). This was heavily truncated by later building works. The removal of the retaining wall to the east revealed the cut for the garden steps [2], which clearly truncated the London Clay (Plates 1 & 2). Across the east of the site, a layer of topsoil [3] lay directly over the London Clay with a thickness of c. 0.4m. Slight variations in colour and thickness are likely to represent shallow garden features related to the existing house, which was originally constructed in the 1840s as part of the Ladbroke Estate.
- 2.2 The existing basement in the north of the site was constructed in the 1990s, and the underside of the floor slab was at a depth of 24.65m OD. During the demolition works, 3-4 concrete slabs were uncovered below the basement floor, cutting through the London Clay and any earlier deposits which may have existed (Plates 3 & 4).



3 CONCLUSIONS

- 3.1 The work undertaken has demonstrated extensive previous truncation to the site, with the area clearly having been terraced prior to the construction of the 14 Lansdowne Crescent in the 19th century.
- 3.2 Removal of the staircase retaining wall leading from the existing basement level to the rear garden at the eastern side of the property revealed that the steps had clearly been cut into the natural London Clay, with a layer of topsoil for the garden overlying the clay. Demolition of the previous northern extension to the property revealed 3-4 concrete slabs, heavily truncating the natural London Clay. It is not considered that there is any potential for archaeological survival on the site.




