1 ABSTRACT


- 1.1 This document details the results of an archaeological watching brief at 10 Broadstrood, Loughton, Essex. The watching brief was commissioned by CgMs Consulting and comprised monitoring the excavation of footings for the construction of a new house. A Written Scheme of Investigation for this work was prepared by Tim Bradley of Pre-Construct Archaeology, March 2011. The watching brief took place on the 7th of March 2011.
- 1.2 No archaeological features or artefacts were encountered during the watching brief. Deposits recorded comprised natural deposits of clay and gravel overlain by modern garden soil or areas of modern tarmac and concrete relating to the recently demolished 1950s bungalow occupying the site.

2 INTRODUCTION

2.1 This document details the results of an archaeological watching brief at 10 Broadstrood, Loughton, Essex. Planning permission (EPF/0043/10) was granted to demolish an existing building and erect a detached dwelling and associated landscaping on the site. An archaeological planning condition was attached to the site as follows:


'No demolition/ conversion or preliminary groundwork's of any kind shall take place until the applicant has secured the implementation of a programme of archaeological work in accordance with a written scheme of investigation which has been submitted by the applicant and approved by the local planning authority'.

- 2.2 The watching brief, which was commissioned by CgMs Consulting, comprised monitoring the excavation of footings for the construction of a new house. A Written Scheme of Investigation for this work was prepared by Tim Bradley of Pre-Construct Archaeology, March 2011. The watching brief was carried out on the 7th of March 2011.
- 2.3 The subject site lies to the northern end of Loughton, a short distance to the east from the A121 at Goldings Hill. The site is immediately south of Broadstrood Plain on the northwest corner of Broadstrood.
- 2.4 The proposed new construction covers an area of approximately 15m x 15m. Foundations for the new construction were generally located within the footprint of the demolished bungalow. New footings, cutting through areas formerly occupied by a lawn and path were excavated along the western edge and northwest corner of the site.
- 2.5 The Written Scheme of Investigation (WSI) prepared by Tim Bradley, Pre-Construct Archaeology Ltd., provides detailed description of the working methodology followed and outlined the archaeological background to the site (reproduced in Section 3 below).





Figure 1 Site Location 1:20,000 at A4





3 GEOLOGICAL, TOPOGRAPHIC AND ARCHAEOLOGICAL BACKGROUND

- 3.1 The BGS map of the area indicates that the site lies on Claygate Member deposits (http://maps.bgs.ac.uk). No drift geology is noted, although the site is situated just to the east of a southern spur of the Stanmore Gravel formation.
- 3.2 The site slopes gently north-south by approximately 0.50m across the site, with ground level at between approximately 94m OD and 93m OD.
- 3.3 The Historic Environment Record (HER) for Essex indicates that the proposed development lies adjacent to a medieval and post-medieval pottery making site, identified from documentary evidence to the east of Goldings Hill. Waste material consistent with pottery production was found a short distance (though not immediately adjacent) to the southeast of the site at No.4 Campions Way during Archaeological Investigation in 2003.

4 ARCHAEOLOGICAL METHODOLOGY

- 4.1 The methodology followed during this watching brief was outlined in the WSI prepared by Tim Bradley, PCA, March 2011.
- 4.2 The excavation of new footings for the proposed building were excavated by tacked machine fitted with a flat-bladed ditching bucket. The trenches measured 0.80m wide x 1.50m deep.
- 4.3 All excavations were closely monitored for archaeological deposits and features. Representative section drawings were made of the deposit sequence within the foundation trenches. A full photographic record was also made.
- 4.4 The site was assigned the code EBSL11.

5 DEPOSIT DESCRIPTIONS

- 5.1 The earliest deposit encountered during the investigations was stiff yellow-brown clay [3]. The clay had a maximum exposed thickness of 1m and was recorded at heights of between in 92.70m OD (0.80 below ground level) Section 1 at and in 92.90m OD (0.60m bgl) in Section 2 (see Fig 3).
- This was overlain by a brownish grey sub-angular natural gravel substrate [2]. The top of this deposit was recorded at between 93.1m OD (0.40m below ground level) and 93.20m OD (0.30m below ground level), and it had a maximum thickness of 0.40m.
- 5.3 Overlying the gravel in Section 1 was the modern garden soil [1] and in Section 2, a tarmac surface, both recorded at 93.50m OD.
- 5.4 No archaeological finds, features or deposits of any date were recorded during the archaeological monitoring.

6 INTERPRETATION AND CONCLUSIONS

- 6.1 The clay [1] was interpreted as representing the upper 'weathered' horizon of the Claygate Member deposits. The gravel layer overlying this was also interpreted as a naturally formed drift deposit layer which extends across the site, possibly derived from Stanmore Gravel formation previously recorded to the west of the site.
- 6.2 There was no evidence of any activity of medieval and post-medieval pottery production encountered at this location. Similarly there was no evidence of any other archaeological features or remains observed during this watching brief.
- 6.3. Apart from the probable former use of the land in the past for agricultural purposes and construction of the 1950s bungalow, the site at 10 Broadstrood produced no evidence to suggest occupation prior to the 20th century.
