SUMMARY

An archaeological evaluation consisting of a single trial trench was undertaken on behalf of John Bridges at Heart of England Cooperative Society on the edge of the suspected extent of the medieval settlement, in advance of redevelopment. Two successive linear features of 18th and 19th century date aligned parallel to Townsend Lane were recorded. These are likely to have been drainage features which ran close by an area of activity further evidenced by a shallow feature which cut the medieval and post-medieval plough soils. The redevelopment of the Co-op is unlikely to impact on any significant archaeological deposits.

1 INTRODUCTION

1.1 Planning permission has been granted by Rugby Borough Council for the construction of a new local convenience store, ancillary customer parking with associated external works, together with the demolition of the existing store and adjacent dwelling at the Co-op Late Shop, Townsend Lane, Long Lawford, Rugby, Warwickshire (R15/2452).

1.2 A planning condition attached to the consent requires that the applicant secures the implementation of a programme of archaeological work in accordance with a written scheme of investigation, submitted by the applicant and approved by the Planning Authority.

1.3 Archaeology Warwickshire have been commissioned to undertake an archaeological evaluation in accordance with a Written Scheme of Investigation approved by the planning authority.

2 SITE LOCATION

2.1 The site is located to on the corner of Townsend Lane and School Street, Long Lawford, Rugby, Warwickshire and is centred on National Grid Reference SP 47364 76017. The present character of the site is a local Co-op shop with parking and a triangular patch of grassed land in the northeast section.

2.2 The underlying geology of the site is Rugby mudstone and limestone bedrock (BGS2016) with superficial deposits of Wolston Sands and Gravel.



3 ARCHAEOLOGICAL AND HISTORICAL BACKGROUND




Fig 1: Location of application area and Historic Environment information

3.1 Roman period ditches and other features (Warwickshire Historic Environment Record No. MWA 10276) were discovered to the west of the development site (Fig 1) during work at land to the west of the Caldecott Arms (EWA 7407/7674). At this time there was an indication that settlement may have continued into the Anglo-Saxon period as two sherds of pottery of this date were also found (MWA 10277). Further features may have been medieval, but secure dating was absent (MWA 9847).

3.2 The development site is to the east of the probable extent of the medieval settlement of Long Lawford (MWA 9526). Archaeological work within the settlement has uncovered medieval and post – medieval remains: A medieval gully was found at Land to the north of Bailey's lane in 2015 (Gethin 2015). Extensive post-medieval features were found on land adjacent to 6 Chapel Street (MWA 12844/EWA 9734) to the west of the development site and quarry pit activity was noted at no 28 Chapel Street (EWA 9161).




Fig 2: Detail of First Edition Ordnance Survey map of 1887-9

3.3 At the time of the First Edition Ordnance Survey map of 1887-1889 the development site was part of a field (Fig 2). The presence of ridge and furrow earthworks to the south (MWA 13057) could indicate that the site had been in agricultural use from at least the medieval period.

4 AIMS AND METHODS

4.1 The main aim of the evaluation was to determine if there are any significant archaeological remains in the area to be developed; to form an understanding of their value and their potential to shed light on the subsequent development of the area.

4.2 Secondary aims include placing the results in their wider local and regional contexts as appropriate.

4.3 The objectives were to locate, record and analyse archaeological materials and deposits and to disseminate the results in an appropriate format.

4.4 A single trench 19m long & 1.80m wide was excavated using a JCB excavator with a toothless ditching bucket. Topsoil and other plough soils were removed under the supervision of an experienced archaeologist until either the top of archaeological remains or geological natural was reached.

5 RESULTS

5.1 The geological natural consisting of light brown orange gravels and sand (102) was first encountered at 88.031m aOD. Overlying the natural was a 0.62m thick sandy silt layer of former plough soil (101) which probably developed in the medieval and post-medieval periods.




Fig 3: Detail of trench and section A

5.2 An east-west aligned ditch 105, with moderate to steep sides and rounded base, 0.77m wide and 0.31m deep (Fig 3, Photos 1 & 2) cut through 101 and was filled with dark grey brown sandy clay silt (106) with frequent charcoal flecks and occasional small rounded pebbles.

5.3 Ditch 105 was cut by east-west aligned gully 103, which had steep sides and slightly rounded base, 0.70m wide and 0.16m deep. This was filled by grey-brown sandy clay silt with occasional pebbles (104).

5.4 In the northwest end of the trench a shallow cut 108 containing dark grey brown sandy silt with rounded pebbles and brick inclusions (107) did not penetrate the natural geology.

5.5 The trench was sealed with sandy clay silt topsoil (100).

6 CONCLUSIONS

6.1 The deposit sequence across the trench is broadly that of a ploughed field cut buy a sequence of linear features containing 18th and 19th century pottery sherds. The tithe map of 1846 depicts such a field, albeit without any internal boundary features. Such maps seldom show drainage features and thus it seems most likely that the ditch and gully recorded were drainage features. The shallow cut 108 in the north-west part of the trench might be taken to imply that some localised activity was undertaken in this vicinity.

6.2 The archaeological evaluation has successfully established that no significant archaeological depoits are likely to be disturbed by the re-development of the Co-op.
