1. Background

1.1 Proposals for the extension of the Midmill Industrial Estate into two areas lying to the E of the current development by Malcolm Allan Housebuilders Ltd, are being discussed with Aberdeenshire Council as part of the planning process.

In the light of previous archaeological discoveries on the Estate, an archaeological evaluation was required.

The archaeological implications for the expansion of the development into the two areas were discussed with Bruce Mann, Archaeologist, Aberdeenshire Council, who proposed that a 5% archaeological evaluation would be appropriate.

This proposal was made in the context of Scottish Planning Policy (PAN 2/2011, SPP, SHEP).


1.2 Murray Archaeological Services Ltd was commissioned by Malcolm Allan Housebuilders Ltd to undertake the work, the field element of Area 1 was carried out 13th June 2014 and the evaluation of the present site, Area 2 was undertaken on 18th September 2014.

2. Desktop Survey

2.1 A search was carried out in the Sites and Monuments Records of the Royal Commission for Ancient and Historic Monuments in Scotland (RCAHMS) through Canmore and Pastmap. The historic OS maps for the area were also consulted. The following map search applies to both areas.

- 2.2 **Roy's Military map of Scotland 1747-55** shows settlements just to the E of Midmill at *The Braye* (Brae Farm) and at *Tofthills* (Tofthill) but no settlement at Midmill itself, although the general area is shown as partly cultivated.
- 2.3 The 1st ed OS 25" Aberdeen sheet lxv.5 (Kintore) 1865 (pub 1869) shows this area before it was improved. Both Areas 1 and 2 are part of an unenclosed area. Part of this ground is shown as cultivated/grazing but the E side of Area 1 is shown as wet and uncultivated.
- 2.4 **OS 25" Aberdeenshire 065.05 1899 (pub 1900)** shows the land after it had been enclosed into the rectilinear pattern now existing. In Area 1, the field boundaries shown are those dykes that still exist. In Area 2, the N part was enclosed but the SE part is still shown as rough ground.
- 2.5 **OS 25" Aberdeenshire 065.05 1924 (pub 1925)** shows both areas unchanged.
- 3. The Site
- 3.1 The proposed site comprises parts of two areas lying to the E of the existing Midmill Industrial Estate (Illus 2), to the E of the B994 and N of the A96. Area 2, which is the subject of the present report, lies to the S of Area 1, on higher ground further from the Tuach Burn. The higher ground on a ridge from c 75m OD, directly to the S of the present site, extends to the field systems and cairns that lie between Coolgardie and Hill of Boghead (Murray & Murray 2014. Report MAS 2014-30)



- 3.2 Area 2 (c 5.24 hectares) lies on a slope down to the N.A small area of the W end of the field had been previously disturbed in an attempt to drain a natural spring which was flooding ground to the N.
- 3.3 At the time of the evaluation the field was in grass.

4. Methodology

4.1 Nine evaluation trenches were excavated in Area 1. Topsoil was removed using a full slew excavator with a 2.1m wide toothless ditching bucket. Any possible features were cleaned and excavated by hand.

4.2 All mapping was done with a Magellan Mobile Mapper 120 GPS and Glonass.

5. The Results

As the only features exposed were late 19th- and 20th -century drains, these have been plotted on the plan (illus 2) but have not been tabulated below. There were no finds of any date.

6. Discussion

There was no evidence of prehistoric or medieval activity in the areas evaluated. The soils were exceptionally shallow which might argue that there would have been greater loss of features; however the total lack of any artefacts (even modern china etc) suggests there was a genuine lack or very low level of land use in the prehistoric period.

It can be argued that, prior to cultivation and drainage in the late 19^{th} and 20^{th} century, this area might have been rough ground not dissimilar to the slightly higher ground to the S.

The large number of stone drains and more recent clay drains logged above illustrate the wet nature of the ground.
