1 QUARRYWOOD COTTAGES QUARRYWOOD SPYNIE MORAY

- Archaeological Watching Brief -

1. Background

- 1.1 A Planning Application to Moray Council (09/00546/FUL & 12/00251/APP) for the erection of a new dwelling in ground behind 1 Quarrywood Cottages, Quarrywood, Spynie, Moray was granted permission subject to a condition (Condition 6 in approval of the original application 09/00546/FUL) requiring an archaeological watching brief to be maintained during any groundbreaking work.
- 1.2 The Council's reason for imposing the condition was to observe and record any items of archaeological interest disturbed during the ground works. The Condition was applied in the context of PAN (Planning Advise Note) 2/2011, SPP and SHEP, which states that it is necessary for developers to arrange for archaeological work to take place prior to development, in appropriate circumstances.
- 1.3 Murray Archaeological Services Ltd was commissioned Kenneth J King, Architectural Drafting Service on behalf of his clients Mr VL Miele and Mrs L H Miele, to undertake the work, part of which was carried out on 5th December 2011 and the remainder on 7th August 2015.

2. The Site

2.1 The site is situated at the rear (N) of No 1 Quarrywood Cottages, Spynie, Moray on the W side of a minor road on the N of the A96 some 4km from the centre of Elgin..





2.2 The site lies to the E of the site of the former Quarrywood Castle and the existing Quarrywood doocot. Evaluation in 2001 of the building site around the area that was considered to be the site of the castle, near the doocot, revealed a substantial ditch and pottery of 14th-century date (Murray 2001). A recommendation for further monitoring of the soil strip was not followed up.




Illus 2 Detail of site in relation to doocot. Plan courtesy of Kenneth J King, Building Consultant

- 2.3 There is a documentary reference dated 1936 to the former existence of a stone circle or henge on or near the area to the W of the present site. The 2001 evaluations did not reveal any evidence of prehistoric activity.
- 2.4 During the 19th century there was a line of buildings, possibly cottages with gardens behind, along the W boundary of the present site. These can be seen on the 1st OS map of 1868 (Illus 3) and the 2nd OS map of 1904 (Illus 4). Rubble from these buildings had been spread over much of the present site.

3. The Watching Brief

- 3.1 The location of the new house is on open ground directly to the N of the existing house No 1 Quarrywood Cottages.
- 3.2 <u>Area 1.</u> In 2011 an area approx 30m x 4m was stripped alongside the W boundary (Illus 11: 1). The ground was reduced by 250mm. It comprised made-up ground

with gravel at the S end and some rubble from the former cottage or cottages at the N end.

3.3 Area A Area A, the main footprint of the building was not watched. On the site visit August 2015 the rubble of the former cottages had been cleared off the area (Illus 11: A). The ground was to be levelled up to the level of the ground at S end prior to the construction. No further watching brief was applicable.

3.4 <u>Area 2</u> Observed August 2015. A main soakaway 18 x 4m was to be dug to a depth of 2.75m. At the N end of the trench there was 300-400mm very disturbed ground above yellow natural boulder clay. The S ³/₄ of the trench (S of 318381, 864181) consisted of a large cut filled with field stone/ rubble and incorporating 19th/20th century glass and china (Illus 8 and grey on plan Illus 11). This extended over an area at least 13 x 4m and to a depth of 1.6m, at which point no further observation was undertaken.

3.5 Area 3 Observed August 2015. A trench 1.3m wide was dug from the E side of Area 2 extending N to cross the area where a septic tank was to be installed. Apart from a small pit (Diameter 1.5m, depth: 1.2m. GPS: 318134, 864187) filled with rubble and modern china, there was c. 400mm disturbed soil over natural yellow clay.




Illus 9 Area 3 looking S to Area 2

3.6 <u>Area</u> 4 Observed August 2015. A surface water soakaway 5 x 3m was to be dug to a depth of 2.75m. There was 300-400mm very disturbed ground above yellow natural boulder clay.

4. Results

4.1 There was no evidence of any archaeological features or finds. The large pit full of rubble and 19th-20th-century material in Area 2 would appear to relate to the former cottages or their demolition.
