
1. Background

1.1 In the light of a new cable trench requiring to be inserted between the SSE power line at Bandodle and a new substation on Bandodle Hill for the Auchorrie Windfarm (APP/2011/3257), it was decided that a desk top survey and walkover survey should be carried out to assess the survival and nature of any archaeological remains on the proposed site and in the surrounding area and to advise on the position of the cable line in relation to the known or visible archaeological remains.

This work was undertaken in the context of Scottish Planning Policy (PAN 2/2011, SPP, SHEP).

In a development context desk-based assessment will establish the impact of the proposed development on the significance of the historic environment (or will identify the need for further evaluation to do so), and will enable reasoned proposals and decisions to be made whether to mitigate, offset or accept without further intervention that impact. (IFA Standard 2011).

- 1.2 Murray Archaeological Services Ltd was commissioned by Aegis Wind Turbines Ltd to undertake the work.
- 2. The Site
- 2.1 The site (illus 1) lies on the N side of Bandodle Hill, N of the B9119 road.

3 Methodology

3.1 A search was carried out in the Sites and Monuments Record, Archaeology Service, Moray Council and in the Sites and Monuments Records of the Royal Commission for Ancient and Historic Monuments in Scotland (RCAHMS) through Canmore and Pastmap. All easily available maps have been consulted through www.nls.ac.uk. The results are summarised in the text.

3.2 A walkover survey was undertaken on 2^{nd} October 2015. In the course of the survey a meeting was arranged with the landowner, Mr Norman Brown, who indicated the proposed cable route and site of the sub-station. After consultation the line was slightly amended, and marked by Mr Brown with a number of electric fence posts (coordinates below).

4. The Map Evidence

The maps are summarised here.

4.1 Roy Roy's Military map 1747-55

On Roy's map the area between Hill of Fare and Corrennie Hill does not appear to have been of high military importance and as a result little detail and no settlement is shown or named S of Kebbaty which lies c 1.5km NE of the present site.

4.2 1st Ordnance Survey Map.25"/mile.


Aberdeen sheet lxxii.11 (midmar). 1865 (published 1869)

Hill of Bandodle farm (site 7) is shown as a rectangular building with garden and field system.

Site 10 is shown with two buildings and the mill, with garden and field system Site 9 is shown as garden enclosed by trees but no buildings.

4.3 2nd Edition Ordnance survey 25"/mile. Aberdeenshire 072.11 1899 (published 1900)

By 1899, Hill of Bandodle farm has been enlarged to an L-plan (site 7) and a sand pit (site 6) excavated nearby.

6 Analysis

The map evidence suggests this area had been fairly extensively settled, probably from at least the late medieval period, and site 3 may indicate late prehistoric settlement. The land-use to date of low stocked grazing and lack of modern cultivation has preserved an unusually rich record of this former settlement.

7 Impacts and Mitigations

<u>Impacts</u> None of the recorded sites are directly affected by the proposed line of the cable trench. As it was considered that there were some possible features up to 10m W of the W edge of the SM area of site 1, it was agreed that the cable trench line would be moved further W (to line shown on illus 4) to clear these possible features.

Mitigations

The line of cable track was viewed on site with the landowner Mr Norman Brown and electric fence posts were placed to indicate the line. W of Site 1, the line was moved some 5m to the W to avoid possible features noted to the immediate W of the W edge of the scheduled area.


