
1. Background


- 1.1 A standing building survey was required for the former Parish Church at Alvah, Banff, Aberdeenshire, prior to its conversion into a dwelling house.
- 1.2 The archaeological condition was applied in the context of planning legislation (PAN 2/2011, SPP, SHEP), which states that it is necessary for developers to arrange for archaeological work to take place prior to development, in appropriate circumstances. Planning Application Number: APP/2016/0988, 0989
- 1.3 A Level 1 Standing Building Survey was required which includes measured floor plans and a written account of the building's plan, form, function, age and development sequence, in addition to a photographic survey.
- 1.4 Murray Archaeological Services Ltd was commissioned to undertake the work by Mantell Ritchie, Architects, on behalf of their client Miss Deborah Cargill. The site element of the survey was completed on the 7th December 2016..

2. Desk-top survey

2.1 A search was carried out in the Sites and Monuments Record, Archaeology Service, Aberdeenshire Council, the Sites and Monuments Records of Historic Environment Scotland (HES), the Listed Buildings Register (HES) and the Buildings at Risk Register.

- 2.2 The 25"/mile 1st and later Ordnance Survey maps were consulted.
- 2.3 Site plans and elevations were kindly supplied by Mantell Ritchie, Architects and have been annotated and used as a basis for detailed plans of the observed areas.

- 3. The Site
- 3.1 The church stands on the NE slope of the prominent Hill of Alvah c4km S of Banff, with wide views S across the Deveron valley towards the sea. By road Alvah lies to the E of the A97 between Banff and Aberchirder.

3.2 The present church was built in 1792, replacing an earlier church on the site.

According to The Ordnance Survey Name Book of 1867 (OS1/4/2/21

www.scotlandsplaces.gov.uk)

This church formerly stood in front of the present building, and was pulled down at the time the new one was erected (1792).

It is not positively known when it was first erected, but an old stone which is now built into the grave yard wall was preserved from the ruins and bears the date 1529 and was evidently a stone which had been placed over the door or some other conspicuous place. The grave yard had evidently belonged to the old church.


In 1961 the date stone was not found (NRHE: NJ66SE7).

The 1st OS map of 1866 marks the old church site as S of the present church. This seems more likely than to the E where the ground falls away quite steeply. Within the graveyard S of the present church there is an area of quite markedly uneven ground which may represent the site of the former church.

3.3 St Colm's well, which may have an Early Christian association lies c. 1km NW on the lower slopes of the hill, near Tipperty.

Illus 2 Detail from Roy's Military Map of 1747-55. www.nls.ac.uk


- 4.6 The **first Statistical Account for Scotland of 1791-99** describes the earlier church as 'The church is very old and in bad repair' http://stat-acc-scot.edina.ac.uk/link/1791-99/Banff/Alvah/4/398/ [Oddly the present building is not mentioned although it must have been built around the time this account was written]
- 4.7 The **New Statistical Account of 1834-45** (written By Rev Andrew Todd in 1837 and revised in 1842) (Stat Acc 1834-45, Alvah, 175) describes the present building as 'The church, a plain, substantial ediface, at present in good repair and containing free sittings for 600 persons, was erected in 1792'. He also records that the glebe was 6-7 acres and that 'the Minister's stipend is 13 chalders, the one half meal, and the other half barley, payable in money'. At this point the Established Church was the only place of worship in Alvah parish and had c400 people who took communion annually.

The Rev Todd also mentions the charters relating to the earlier church (Stat Acc 1834-45, Alvah, 153). [These were said to be in Advocates Library but not traced.] In 1314 A Charter signed at Aberbrothwick by Marjory, widow of John Earl of Atholl, gave 'to the blessed Virgin Mary, to God, and to the abbot of Cupar, the right of patronage of the kirk of Alvah'

In 1593 A charter of the lands of Alvah from the Cistercians of Cupar to Sir William Ogilvie at Dunlugas.



4.8 **1866.** The **1**st **edition Ordnance Survey 25" to the mile map** (Banff sheet X.8. published 1871) shows the church , the site of the former church, and the Ogilvy burial enclosure.

4.9 By the 2nd edition 25"/mile Ordnance Survey of 1901 (published 1902.
 Banffshire Sheet 010.08) the 1792 church is shown with the addition of both the porch and the vestry both c. 1882.




Illus 4 2nd edition 25"/mile Ordnance Survey of 1902 (pub 1904) (<u>www.nls.ac.uk</u>)

- 4.11 The building has not been in regular use since 1950 and was closed in 1973.
- 5 Methodology
- 5.1 The ground plan and elevations (illus 5, 28) have been annotated to show details and to indicate differences in the building materials which may help in understanding the development and history of the building.
- 5.2 The areas recorded were photographed. The full set of photographs will be supplied to Aberdeenshire SMR and annotated plans in the present report (Illus 29-31) indicate the position of each.

6 The Building

THE CHURCH

The church was out of regular use since 1950 and closed in 1973. At the time of the survey in 2016, many of the internal fittings remained but there was some dereliction due to broken windows, damp and pigeons.

Description

The church is a plain, rectangular block set E/W with large windows along the S wall and originally symmetrical having central doors in the E and W gables, each with a window above. The N wall has a single, central window. A later porch was added to the centre of the W gable and a vestry/session room with boiler house below, added to the E end of the N wall.

A rectangular bellcote on the apex of the W gable dates to 1645 and was re-used from the earlier church. The bell itself, cast by Peter Jansen is dated to 1643 and has been re-hung in Banff and Alvah Church in Banff (information from HES LB 2891 and Walker & Woodworth (2015, 262).

Dimensions Main 1792 building: Width: 10m ext. Length: 18.9m ext.

Porch 3.8 x 2.7m ext.

Session Room/ Vestry Slightly asymmetric. 7.6 x 5.6 (N) to 6.3m (S).

Walls Concrete harling (buff) with sandstone ashlar at corners and openings. Where harling has broken off the stonework is visible as quite slatey rubble stone.

Roof Steeply pitched, slated. Bellcote at W gable apex. Plain ball finial at E gable apex. Ball finial at apex of W vestry gable.

Bellcote

The bellcote is rectangular, with arched openings to E and W, and solid sides to N and S pierced by roundels. The apex is a stepped pyramid with a ball finial. Although the bell has been removed, an iron strap, which would have retained the bell rope, remains below the bellcote on the W side.

E gable wall

The E gable has a central door with a window above at gallery level.

D3 W: 1.38m. H: 2.14m from lintel to ground. Plain squared doorway with sandstone margins. Double plank doors. Two granite steps.

W8 (as W3) W: 1.38m H: 1.7m (from elevation). Plain rectangular window with sandstone margins. Upper and lower sash windows each with 5 over 5 panes.

W gable wall

The W porch obscures the original W door (now replaced by internal door D5), the gallery window (W3) matches W8 in the E gable.

W3 (as W8) W: 1.38m H: 1.7m (from elevation). Plain rectangular window with sandstone margins. Upper and lower sash windows each with 5 over 5 panes.

Blue plaque with historical information.

Bench mark. OS bench mark on W face of SW corner. (BM 280. 1st OS map)

S wall

The S wall has two tall windows flanking the position of the pulpit on the inside, with smaller windows at either end below the gallery. In some of the panes, the glass is clearly original, with ripples clearly visible (illus 10) (Historic Scotland, 2008, 1)

W4 and W 7 W: 1.53m H: 1.83m. Plain rectangular window with sandstone margins. Upper and lower sash windows each with 5 over 5 panes.

W5 and W6 W: 1.53m H: 3.10m. Plain rectangular window with sandstone margins. Upper and lower sash windows each with 3 rows of 5 panes.

Some of the original iron pivot hinges for shutters survive on all windows.

F3 and F8 Red sandstone block with circular vent. Clearest with F8 where the harling has chipped showing the block is 400mm square, with circular raised block 360mm in diameter, pierced by aperture 150mm diameter with iron grid.

Memorials

The memorials recorded are those that are either set into the wall fabric or are so near the wall that there is a possibility of disturbance during construction.

M1 Set in the wall below W5. Polished black granite. Mary Jane Todd. 1855.

M2 Freestanding c. 140mm from wall face. Polished light grey granite. Alexander Fraser. d. 1960, wife Dilys Fraser d. 1983, daughter Katherine d. 1947. Anne Nelstropp (nee Fraser) d. 2012.

M3 Set in wall between W5 and W6, below M4. Polished grey granite. Rev Andrew Todd, minister of the parish for 27 years. D.1867. His wife Eliza Begrie, grand-daughter of Rev George Sangster minister of the parish from 1776 to 1805, d. 1895

M4 Set in wall between W5 and W6, above M3. Sandstone memorial (not possible to read, very worn although some letters survive). Flanked by columns and with cornice and shaped pediment with head over wings. Urn finial. Base of memorial skull flanked by crossed bones. HES LB2891 describe as 'early 18th century memorial to Ogilvy (?) family. According to Walker & Woodworth (2015, 262) this is memorial to Elizabeth Campbell d. 1728.

If the early 18th century date is correct it is perhaps possible that this had originally been in the earlier church.

N wall

The E end of the N wall is obscured by the session room/vestry. The W end is plain with a single window at ground floor level.

W10 W: 1.22m H: 1.66m. Plain rectangular window with sandstone margins. Upper and lower sash windows each with 3 over 3 panes.

- **F1** Cast iron tie plate (to balcony?)
- **F2** Red sandstone vent as F3, F8

PORCH

The porch has a pitched slate roof and harled stone walls. There is a single window in the W wall and the door in the S wall.

W wall

W2 W: 0.92m H: 1.53m. Red Turriff sandstone margins and hood moulding. Upper and lower sash windows each with 3 over 3 panes.

S wall

D2 W: 1.22m H: 2.19m Red Turriff sandstone margins. Vertical plank door with ornamental hinges and ring door handle (as D1).

VESTRY/ SESSION ROOM

The vestry/session house has a ridged slate roof at right angles to the roof of the church. There is a chimney at the N gable. Windows to E and W and external door to W. Internal door to church to S.

The boiler house runs below the vestry/session room. It is entered from the E with steps down to the door. On the W side, an iron covered hole below the W window was probably a coal hole.

<u>Chimney</u> Rectangular sandstone with flared table.

W wall

D1 W: 1.07m H: 2.58m. Door H: 1.97m with 2 pane fanlight above. Red Turriff sandstone margins. Vertical plank door with ornamental hinges and key hole (As D2).

W1 W:1.07m H: 1.83m. Red Turriff sandstone margins. Upper and lower sash windows each with 3 over 3 panes.

E wall

W9 W: 1.00m H: 1.35m. Red Turriff sandstone margins. Upper and lower sash windows each with 3 over 3 panes.

F5 Red sandstone vent as F2, F3, F8.

Memorial

M7 Set in wall. Sandstone memorial (not possible to read, very worn). Ogilvy (?) crest of lion rampant within escutcheon. According to Walker & Woodworth (2015, 262) this memorial is 16th century and originally had initials I.M G.M.

Cellar/boiler house

D4 W: 1.02m H: 1.78m Red sandstone margins. Plank door.

Interior

The interior of the building, although dilapidated, was relatively untouched since the church closed. The HES Listed Building record (LB2891) notes that the interior had been remodeled c 1880, so it is probable that the present layout is of that date.

The interior of the main church is symmetrical with the pulpit in the centre of the S wall, with five blocks of pews to the N, E and W. The four large windows in the S wall, which are arched on the inside, flood the interior with light. The vestry/session room can be entered either directly from the back of the church, or externally through a small separate lobby.

Inside the original E and W gable doors, narrow lobbies lead both into the ground floor and up stairs into the gallery. The W porch opens into an additional lobby with coat hooks.

The gallery, which is supported on six iron pillars, extends around the N, E and W walls, with five tiers of pews focused on the pulpit.

The ceiling is flat, plaster over lathe, now in places dilapidated. There are three decorative ceiling bosses, which probably also acted as air vents. All three bosses are painted yellow, red, pale blue and white, the central boss has additional applied decoration.

There is considerable natural daylight but additional lighting was supplied by hanging lights with white glass globes and brass chains over the S side. Simpler plainer lights on the underside of the gallery hang on ordinary flex and appear more recent.

Visible floors were wooden throughout, with coir carpet runners.

Ground floor

<u>W Porch</u> Pine panelled to 1.18m with pink plaster above. Iron coat hooks on wooden rail.

D5 Internal door. W: 1.22m H: 2.10m. Two leaves. Pine and glass. This would have replaced the original W gable door when the porch was added.

<u>W Vestibule:</u> The vestibule had pitch pine panelling to 1.24m. Stair to gallery on N side. Door to church on S side.

D6 W: 0.93m H: 2.26m Pine.

E Vestibule As W Vestibule but retains its original gable doorway.

<u>Main church</u>: Pine panelled to 1.30m with pink and green plaster above. The pillars supporting the gallery are painted cast iron, 130mm/5") in diameter and with slightly flared tops.


The pews are arranged in five blocks, one set of 8 rows either side of the pulpit, facing E and W and three blocks along the N wall facing S to the pulpit. The pew nearest the W side of the pulpit is enclosed by a door and had a built in table, this was presumably for elders/officers of the church. The pews are of pine, with plain round-topped ends.

The pulpit was set at the centre of the back of a low platform c 280mm high with two sets of two low steps; this is presumably where the communion table would have been placed. This platform is surrounded by a decorative wooden balustrade 1.28m high, with delicate arcading along the top. To the E of the platform are the stairs up to the pulpit.


The pulpit is set in a recessed, red-painted arch, framed by a wooden margin, matching the arch of the flanking windows. The pulpit itself is enclosed by five –sided wooden panels with a padded velvet top and a red velvet and tasselled bible rest.

Memorial

M8 White marble, set in wall between windows W6 and W7. In memory of Rev Hugh Fraser, minister from 1868 to 1917, and retired senior minister until his death in 1923.




Illus 24 Ground floor interior. Memorial M8.

First floor gallery

The gallery had pine paneling to 1.07m and plaster above. The flat ceiling partly obscured the tops of the gable windows which were recessed up into the loft space. Above the W window there was the hatch which would originally have held the bell ropes.

There were four sets of steps separating five tiers of pews, each containing 5 rows. The pews were of pine with plain flat-topped ends. The front pew in each tier was a closed 'box' with red plush cushioning and red velvet and tasseled front rail. The front face of the gallery had a decorative paneled board dado.


Vestry/Session Room

Vertical pine paneling with pink plaster above. There is a fireplace in the centre of the N wall, with a stone/concrete surround painted to look like green marble. Cast iron and tile fireplace. Iron fender. Large wooden cupboard to E of fireplace. Shelves along E and S walls.

An upright piano (J Marr Wood & Co Ltd. Aberdeen) stood against the N wall. There is a small outer lobby to the external door.






