This is the Second Progress Report of the HEEP-funded Visualisation in Archaeology project (HEEP Project No. 5172MAIN). The project's start date was 3 December 2007 and has funding allocated for a period of three years as set out in the project design (13/11/2007; 5172PD). The report will review the project's first year of operation across its main focus of core activities, as well as outline the underlying efforts to build crosssector support and endorsement of the VIA.

# Overview

This first year has seen marked progress in establishing a firm foundation from which to develop the project in line with its stated aims and objectives. Contact has been established with key organisations within the archaeological sector and support for the VIA has been kindly offered both in terms of promotion of the project and through direct involvement in its various working groups. English Heritage, in addition to their continued generous funding, have offered invaluable assistance in a number of important areas through the good offices of Trevor Pearson.

Awareness of VIA is particularly marked within the academic community through the organisation, promotion and delivery of the first VIA Workshop held at the University of Southampton. Researchers and practitioners from Europe, North America and Australia contributed to an eclectic series of papers mirroring the broad-ranging disciplinary response initiated both by the Workshop's vision and the undoubted quality of its session chairs. The aims of the VIA as a nucleus for attracting a community of researchers from different disciplines whose focus is centred on the visual is further enhanced by the posting on the VIA website of an online Searchable Bibliography and a Research Showcase.

Progress on those aspects of the project aimed directly at informing practice, have developed at a slower pace -- resulting in the project's relatively lower profile among public and private archaeological organisations. Whilst a smooth funding stream could have resolved some of these issues, it was also decided by the project managers that spending time to assemble strong working groups to inform future research would ultimately be reflected in the quality of the products associated with those groups. It is intended that those elements of the VIA which require to be fully actioned, notably the Strategic Report and the Best Practice Case Studies, will be pushed forward in the first quarter of 2009. Nevertheless, progress has been made. Following the first meeting of its working group, the Strategic Report's structure and content has been revised allowing research for its completion to proceed. To this aim, a questionnaire designed to inform the Report's first section is now in its final draft and will be piloted within English Heritage early 2009. Adjustments to the questionnaire will be made in light of the pilot and the survey rolled out across the sector by Spring/Summer 2009. Whilst the Best Practice Case Studies are intended to collectively form an online resource highlighting nontraditional models of publication and dissemination, they are also designed to inform sections of the Strategic Report. Since the Report's structure has now been reviewed. the collection of the Case Studies will progress.

# VIA Core Activities: Summary of current status and outline of intended action over the next six months

#### 1 **Project Website**

The VIA website has, in its initial phase, principally served to raise the project's profile and promote the project's various areas of interest. Over this first year, content has gradually been posted with particular emphasis on the Workshop and, naturally, the Searchable Bibliography and Research Showcase. The construction of the Bibliography database held a number of challenges that have now been largely overcome. Whilst contributions to the Research Showcase are not searchable, it is anticipated that as this resource grows this facility will develop. During the first half of the project's second year, an increase in content will see a structural review of the website (see www.viarch.org.uk).

#### 3 Strategic Report

Following an initial meeting of its working group, the Strategic Report has undergone a shift in focus and structure. Since that first meeting Peter Hinton (IFA), Dan Hull (CBA) and Robin Taylor (English Heritage) have agreed to join the existing working group. An early draft of the survey questionnaire was composed in light of the Report's restructuring. Further work was suspended as stage payments from the funding body were delayed; however, those funds were eventually released in full, and work on this element of the project has now resumed. The questionnaire is in its final draft form and a covering letter has been composed. English Heritage have kindly offered to pilot the survey. Further research is now underway investigating the nature of quality assurance of images produced for professional publications.

#### 4 **Best Practice Case Studies**

This element of the VIA programme is designed to identify the key themes of best practice and innovation in the planning, management and delivery of effective knowledge dissemination models as a result of, but not exclusively from, archaeological investigations. By turning our attention away from traditional models of dissemination (paper-based publication), VIA acknowledges the many opportunities and challenges offered by 'new' technologies in the dissemination of archaeological knowledge and understanding. The proposed research-based archive of case studies will pull together strands from a number of knowledge communities to provide a compendium of interrelated best practice resources from a 'total project' perspective based directly on experience. Case studies will be showcased on the project website.

Each case study will be relevant to the sector, provide concise and useable guidance, be directly linked to related professional issues, and kept up-to-date by inviting feedback from practising professionals and professional organisations.

### Comments

The Best Practice case studies, whilst providing a stand-alone online resource, will substantially impact on the Strategic Report. Indeed, as the Strategic Report content has been developed, it is now acknowledged that the Best Practice case studies might directly facilitate a picture of organisational (self-)transformation.

#### 5 Online Searchable Bibliography

The bibliographic component of the Academic Resource aims to provide users with access to a representative sample of citations of published works pertaining to the visualisation of data. The bibliography proposes to span the literature: from writings on the visual representation of archaeology, to visualisation in the wider fields of the sciences, social sciences and arts in order to offer archaeological practitioners (and the wider public) the opportunity to learn from and build upon a cross-disciplinary body of findings and experience. The VIA website will feature both a search and view component to interrogate the bibliography and a reference submission component, allowing users to submit publications for inclusion (see www.viarch.org.uk/content/researchbibliography.asp).

#### Action

Gather sources and post online 2008 -- systems for data collection and the construction of a searchable database have been developed and refined over the bibliography's first year of deployment. In excess of 300 references are now posted online featuring publications pertaining to visual representation in the sciences, social sciences, humanities and arts.

The bibliography seeks to connect users with the cross-disciplinary literature, enabling archaeologists and others to learn from and build upon the visualisation-oriented writings of practitioners from a variety of fields.

#### 6 Online Research Showcase

The research summaries component of the Academic Resource aims to offer users access to descriptions of innovative, contemporary research projects focused on the visualisation of data. The summaries will extend across disciplinary boundaries to consider current and proposed visual projects in archaeology and the wider fields of the arts and humanities (cultural studies, visual studies, museum studies, art history), social sciences (geography, geology, sociology, anthropology), and science and technology studies. Like the bibliography, these summaries aim to link practitioners across disciplines, highlight innovative visual projects, and offer a platform for future planning and discussion of best practices around archaeological visual method and theory (see www.viarch.org.uk/content/research-summaries.asp).

#### Action

Gather sources and post online 2008 - Research Summaries will continue to be compiled by communicating with researchers through project organised activities, by contacts established through the Project Team, through attendance at conferences and via social networks. All research summary pages will follow a similar layout, identifying the project's name, researcher name(s), researcher contact information (if supplied), researcher affiliation, project keywords, a short summary of the research (in paragraph form or point-form notes), representative project imagery (with the choice to include contextualising captions, as well as the option to identify one image as the 'cover illustration'), and citation details for directly-related publications (for inclusion in the Bibliographic listing).

Like the Bibliography, the Research Showcase is intended as a community-building tool whose components work together to foster conceptual reflection within archaeology, as well as to create a network of dialogue and information-sharing across disciplines.
