And the Abbess by her attorney came and said that she claimed the aforesaid liberties in her manor of Leyghton by the charter of the lord king John ancestor of the present king and it was confirmed by the now present king in free alms and then showed the said confirmation which witnessed the same. When asked if the whole vil was of her fee she said except for the part which pertained to the prebendal church of the same vil, and that he [she] had 24 pence there

Asked concerning the articles of enquiry etc she said that [?] the sheriff had made enquiry concerning the same points at his leet etc. Asked if she held a standard from the royal marschal etc she said that she did, and that she could check weights and measures and that she had gallows and other legal rights etc, and that she gave nothing for holding her view etc.

Asked if the tenths or fourths etc the reeve came to the sheriffs' leet to present etc and said not. And this same testimony is by Thomas de Brahy. And as regards the fair and free warren which they claim to have in the aforesaid manor they say that the lord king Henry father of the present king gave and confirmed in his charter to Mabil' the abbess of the aforesaid house and to the nuns serving god there etc. and that they have one fair every year for three days, that is to say on the vigil, the feast day and the morrow of the feast of St Dunstan and that they have for themselves warren in all their lands in the aforesaid manor of Legton. And for this they show the charter of the aforesaid lord King which testified the same and the date of this charter is the 20 day of January in the ... years of the reign of the aforesaid king. And that the said manor is ancient demesne land of the crown. And so as to the view of frank pledge, the fair and the warren and the other aforesaid liberties, except the chattels of felons and of their fugitives, are theirs at present and in future, always Saving to the lord king in his right when he has wished to pronounce on he matter on other occasions. And as to the chattels of felons and fugitives, let her have her day before the Treasury and the barons of the Exchequer at Westminster 15 days from Easter, afterwards from Michaelmas day in one month in the 15th year and on that day are to come the aforesaid abbess and prior by their attorney, and they are given a day 15 days from Easter etc. on which day the aforesaid abbess shall come by her attorney, and a day is given from the feast of St. Michael in 15 days And then a day is given from Easter day in 15 days. And then is given a day here in the octave of St Michael.'
