1.0 INTRODUCTION

1.1 Background

SLR Consulting Ltd was commissioned by Wm Morrison Supermarkets Plc in November 2012 to undertake a Heritage Statement for the proposed extension to an existing store at Lake, Isle of Wight; WM Morrison Supermarket, Newport Road, Sandown, Isle of Wight, PO36 9PA (the Site) (Drawing 1). This statement addresses the archaeological and built heritage implications of this proposal. The study area consists of a 1km radius from the boundary of the Site, centred on SZ579833.

This report will be presented with WM Morrison Supermarket's planning application and other technical documents.

1.2 Proposed Development

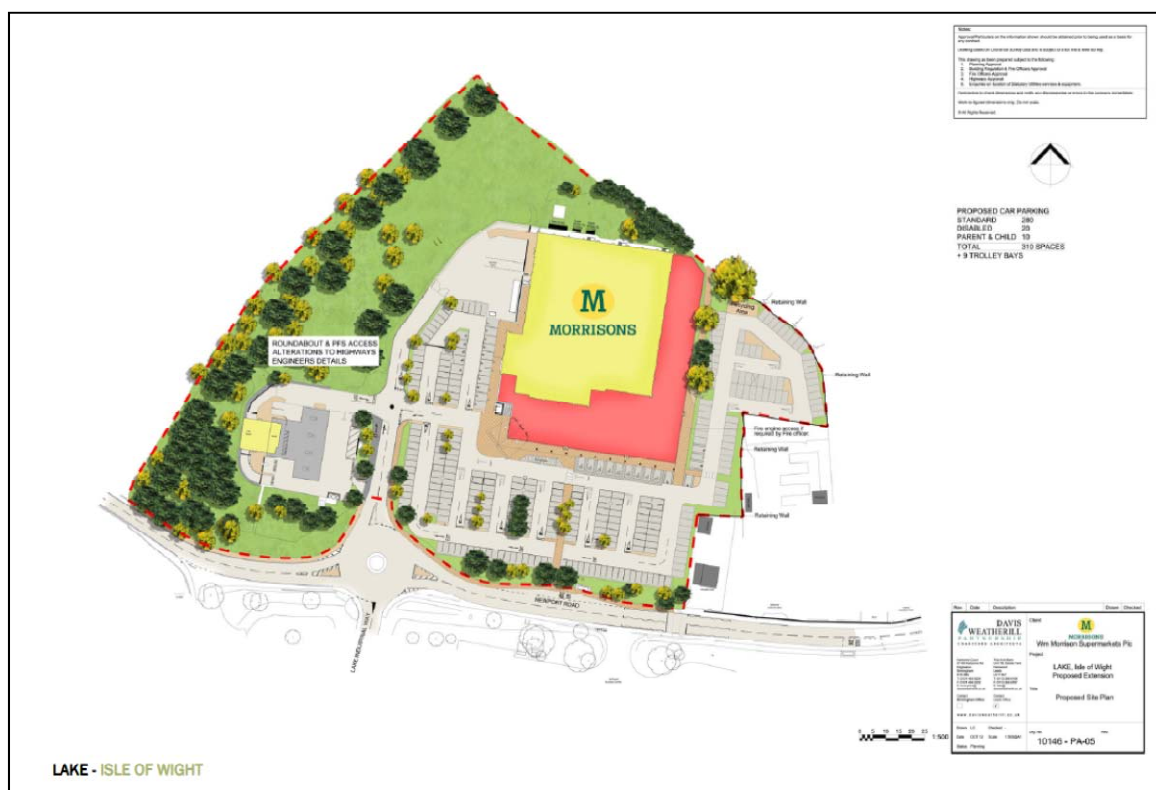


Figure 1 Plan of the Proposed Development

The proposed development layout is presented in Figure 1. The proposed development is for an extension of 2189m² gross external area, with additional car parking to the south and east. The proposed development includes additional sales floor accommodation with new front of house customer cafe/support facilities and a new staff canteen area. There will also be extensive alterations and internal reconfiguration to the existing layout within the new footprint.

1.3 The Site

The existing WM Morrison Supermarket on the Site is located approximately 2.3km southwest of the centre of Sandown, just off the Newport Road (A3056) on the western bounds of Lake, opposite the industrial units on Lake Industrial Way. The Site is centred at

National Grid Reference 457937.083348. The Site covers an area of approximately 2.92 hectares. The British Geological Survey sheet (1976) composite for the Isle of Wight records that the Site is underlain by Ferruginous Sands Formation of the Lower Greensand Group¹. The Site straddles the 13 metre contour and is generally flat in the central and eastern parts, with the western part of the Site sloping towards the Scotchells Brook².

2.0 HERITAGE ASSETS

2.1 Designated Heritage Assets

The location of the designated heritage assets within the study area is shown in Drawing 1.

2.1.1 Listed Buildings (*Building Preservation Notices and Certificates of Immunity*)

Five Listed buildings are located within 1km of the Site. All the listed buildings within the study area are Grade II listed. Merrie Gardens Farmhouse, a late 17th-early 18th century building, altered in the 19th century, is the nearest Listed building, 0.08km to the east of the Site. The remaining listed buildings are all over 0.6km from the Site. There are no Building Preservation Notices or Certificates of Immunity within 1km of the Site.

2.1.2 Scheduled Monuments

There are no scheduled monuments within 1km of the Site. The nearest is Sandown Barrack Battery, 1.35km to the northeast.

2.1.3 Conservation Areas, Registered Parks and Gardens, Registered Battlefields, Protected Wreck Sites and World Heritage Sites

There are no Conservation Areas, Registered Parks and Gardens, Registered Battlefields, Protected Wreck Sites and World Heritage Sites within 1km of the Site.

2.2 Non-Designated Heritage Assets

The location of non-designated heritage assets (IOWHER monuments Appendix A) within the study area is shown in Drawing 2.

2.2.1 Isle of Wight HER Monuments Prehistoric (500,000 BC-43AD)

Considerable prehistoric activity is evident within the study area.

Prehistoric (general)

The prehistoric IOWHER monument records comprise findspots (MIW842, MIW1294, MIW1308, MIW1318, MIW1360), flint scatters (MMIW1360, MIW4790 and MIW13446) and

lithic working, a findspot and pits at Lake Middle School (MIW2313). The nearest findspot or flint scatter is Sandown Bay 0.45km to the south of the Site.

Palaeolithic

Palaeolithic Axe(s) were found 1914 in a small pocket of gravel at Ninham 0.89km to the southwest of the Site (MIW838). An implement of Le Moustier type found at Black Pan Farm 0.70km to the northeast of the Site (MIW847).

Mesolithic

Blackpan Common (MIW860) 0.52 km to the southeast has produced implements of various cultures dating from the Early Mesolithic to Bronze Age. Mesolithic types include picks, microliths, flakes, cores and petit tranchet derivatives of Clark's types G and G2.

Blackpan Farm 0.65km west of the Site has generated a range of worked lithics dating from the Early Mesolithic to the Early Neolithic (MIW845).

Neolithic

Two Neolithic axes, scrapers and flakes have been discovered at Languard Farm 0.08km to the east of the Site (MIW835). A Neolithic polished stone axe of basalt found at Merry Gardens 0.85km east of the Site (MIW841). A Neolithic occupation/flint working site comprising a hearth with flakes, wasters and implements around it was found when a bank was levelled at Lea Farm (MIW848) 0.98km to the south of Site.

Blackpan Common (MIW860) 0.52 km to the southeast has produced implements of various cultures dating from the Early Mesolithic to Bronze Age. Neolithic Age implements were found at Blackpan Farm (MIW846) 0.66km west of Site.

Flint implements including scrapers and arrowheads dating from the Neolithic and Bronze Age were discovered at Lake (MIW854) 0.84km east of the Site.

Bronze Age.

Three Bronze Age findspots have been found within 1km of the Site (MIV839, MIW843 and MIV851), the nearest of which is a barbed and tanged arrowhead found 0.27km to the northeast. One possible Bronze Age pit was recorded during a watching brief at Ninham Farm (MIW1623) 0.91km to the southeast of the Site.

Blackpan Common (MIW860) 0.52 km to the southeast has produced implements of various cultures dating from the Early Mesolithic to Bronze Age. Bronze Age implements were found at Blackpan Farm (MIW846) 0.66km west of Site. Flint implements including scrapers and arrowheads dating from the Neolithic and Bronze Age were discovered at Lake (MIW854) 0.84km east of the Site.

Linear features of uncertain date are visible as cropmarks likely to be field boundaries are visible on aerial photographs and are dated from the Early Bronze Age to the 20th century 0.28km west of the Site (MIW2238).

Iron Age

A potsherd was found during the construction of Lake Middle School 0.60km to the southeast in 1970 (MIW1664). A bead rim urn cremation was unearthed in October 1931 by workmen making a new road between Newport Road and Lake Cemetery 0.86km northwest

of the Site (MIW850). Five Iron Age pits were recorded during a watching brief at Ninham farm (MIW1623) 0.91km to the southeast of the Site.

2.2.2 Isle of Wight HER Monuments Romano-British (43AD-410AD)

All of the Isle of Wight HER monuments dated to the Roman period are findspots (MIW836, MIW852, MIW959 and MIW1354). The nearest is a Roman coin of Constantius II found in 1939 at Shanklin (MIW836) 0.06km to the east of the Site. Roman pottery was also found at Sandown Cliff (MIS1676) 0.83km east of the Site.

2.2.3 Isle of Wight HER Monuments Medieval (410AD-1540AD)

Blackpan is recorded in Domesday as *Bochepone* and is located 0.48km to the northeast of Site (MIW6653). Lea farm is entitled with the Domesday placename *Alalei* 0.25km northeast of Site (MIW6678). Scotchells is noted to possess the Domesday placename *Scaldeford* 0.91km to the southwest of the Site.

2.2.4 Isle of Wight HER Monuments Post-medieval-Modern Period (1540AD-20th century)

The 19th century barn at Bigbury Farm, Alveston Road is located adjacent to the Site (MIW13748). The post-medieval boundary stone Little Stairs Point is located 0.03km south and a mid 17th to mid 18th century barn on Cheverton Farm (MIW9532) is located 0.13km to the west of the Site. The late 19th century Church of the Good Shepherd is located 0.14km east of the Site (MIW12168).

Post-medieval postholes, pits and ditches were recorded during a watching brief at Ninham Farm (MIW1623) 0.91km to the southeast of the Site. Post medieval pottery was found at Sandown Cliff (MIS1676) 0.83km east of the Site. Linear features of uncertain date which are likely to be field boundaries, are visible on aerial photographs and are dated from the Early Bronze Age to the 20th century (MIW2238).

The remaining 39 (save the undated IOWHER monument below) Isle of Wight HER monuments are classed as post-medieval to modern in date.

2.2.5 Isle of Wight HER Monuments Undated

The Farmhouse at Bigbury Farm (MIW13749) located 0.94km to the east of the Site is undated.

2.3 Isle of Wight HER Events

Seven Isle of Wight HER events are located within 1km of the Site.

The SeaClean pipeline (EIW193) runs through the Site aligned northeast-southwest. In 2000, a programme of archaeological works associated with the construction of the SeaClean Wight Pipelines was undertaken. The archaeological monitoring along the route from Yarmouth to Sandown identified 55 sites ranging from find scatters to features and deposits, ranging in date from the prehistoric to post-medieval periods.'

The Isle of Wight Aggregate Areas National Mapping Programme (EIW464) covers the western majority of the Site.

At Merrie Gardens (EIW747) 0.08km to the southeast, an archaeological watching brief was carried out during the groundworks associated with the construction of a new pub and car

park. Late post-medieval or modern activity relating to the former farm was discovered. A channel or depression, cobbled surfaces and a well or cistern were recorded.

At Lake Middle School (EIW185 and EIW3), 0.28km and 0.33km to the east, a watching brief (EIW185) was undertaken in advance of the construction of a classroom extension. The watching brief identified evidence for prehistoric and later activity comprising a gully, possibly delineating a settlement boundary and rubbish pits. Domestic Late Neolithic and Early Bronze Age occupation was apparent, with evidence for flint knapping. Early Romano-British features and artefacts predominated, with less post-Roman and later material, possibly reflecting a change in settlement focus. Notable finds include a flint arrowhead, worked flint tools and late Iron Age and Romano-British ceramics. Archaeological evaluation (EIW3) prior to the construction of a classroom extension at Lake Middle School, provided evidence of prehistoric settlement during the Neolithic/Early Bronze Age and Iron Age.

A survey at Sandown Cemetery (EIW517), 0.55km to the northeast of the Site, was completed by the Isle of Wight Gardens Trust in 1999.

At Lake Allotments (EIW11) 0.71km to the northeast, a trial trench was excavated following the discovery of complete Roman poppy head beaker. One flint blade was found but the pot may have been redeposited when soil was moved from a nearby sand pit.

2.4 Isle of Wight Historic Landscape Characterisation

The majority of the Site is recorded as Safeway Supermarket, Lake and recorded with the Broad HLC Type of Settlement (2726). The Safeway supermarket was built around 1990 within a former field to the west of Merrie Gardens Farm. This field had the appearance of being enclosed from former waste or common land.

The very northern tip of the Site is recorded as Scotchells Brook Valley (South) and recorded with the Broad HLC Type of Valley Floor (3341). The Tithe schedule lists a mixture of pasture, meadow, valley floor woodland and some rough land within this area.

2.5 Historic Mapping³

The historic mapping is provided in Appendix B. The Ordnance Survey County Series mapping of 1862 (scale 1:2,500) and 1861-1863 (scale 1:10,560) shows the Site located to the northeast of Scotchells Bridge as two enclosures, with the boundary between the two aligned northeast-southwest. The western enclosure is depicted with marshy area extending along the eastern side. 'Merry Gardens' are situated to the southeast and a Sand Pit is marked to the south of the Site. A stream (Scotchells Brook, marked on current Ordnance Survey mapping) represents the western boundary, which flows northwards, with a small tributary which issues from 'Merry Gardens' and feeds the Scotchells Brook to the north of the Site.

The Ordnance Survey County Series mapping of 1896 (scale 1:10,560) and 1898 (scale 1:2,500) marks the Enumeration District Boundary ('E.D. By') (later shown as the 'ED and Ward By' on the Ordnance Survey 1987; scale 1:2,500 mapping) as the western boundary of the Site. A Lodge is marked to the south of the Site.

The Ordnance Survey County Series mapping of 1908 (scale 1:2,500) shows a small rectangular building aligned north-south immediately southeast of the Site but this is no longer depicted in subsequent historic mapping. The Ordnance Survey County Series mapping of 1907-1909 (scale 1:10,560) shows no changes within the bounds of the Site but the western boundary is now represented by the Urban District boundary; 'U.D. By'. Sandown and Shanklin Isolation Hospital is depicted to the west of the Site. 'Scotchells Withybed' is now marked to the southwest. The Ordnance Survey County Series mapping of 1938-1942 (scale 1:10,560) shows no change within the bounds of the Site.

The Provisional mapping of 1957 (scale 1:10,560) shows no alteration to the Site. The Ordnance Survey mapping of 1960 and 1969 (scale 1:2,500) only depicts the far eastern part of the Site and the Air Conditioning and Refrigeration Works are shown to the south. The Ordnance Survey mapping of 1975 (scale 1:2,500) shows the western part of the Site, with no changes depicted, but a track now runs along the northern boundary. Airport Lodge, Sandlin and a Builder's Yard are now shown on the site of the former Sandown and Shanklin Isolation Hospital. A nursery is shown to the west of the Site. The Ordnance Survey mapping of 1980 (scale 1:10,560) shows no changes to the Site.

The Ordnance Survey mapping of 1987 (scale 1:2,500) shows the western part of the Site, with no changes within its bounds but an electricity Sub Station and Lake Industrial Way is now indicated to the south of the Site. The Ordnance Survey mapping of 1988 (scale 1:2,500) only depicts the eastern part of the Site and does show an excavated area flanking the Site to the north. The Raster map of 2002 (scale 1:10,000) shows the Site much as it is currently save the western boundary represented by the civil parish boundary and it appears that the building to the west of the supermarket has subsequently had its footprint revised. The Ordnance Survey 2011 (scale 1:10,000) and MasterMap 2011 (scale 1:2,500) depict the existing supermarket, building and parking.

2.6 Assessment of Significance and Sensitivity to Development

2.6.1 Predicted Direct impact

The proposed development is the extension to an existing store and therefore much of the Site has already been subject to ground disturbance as shown in the current aerial photograph (Figure 2). There are no designated or non-designated heritage assets within the bounds of the Site. Scotchells Bridge, immediately to the southwest will not be impacted upon. The small rectangular building shown on the Ordnance Survey County Series mapping of 1908 (scale 1:2,500) immediately southeast of the Site is not depicted in subsequent historic mapping, in an area that has been subject to ground disturbance and currently used for parking (Figure 2).

2.6.2 Predicted Indirect impact

The setting of the Grade II listed Merrie Gardens Farmhouse and the Merrie Gardens Farm complex may be slightly impacted upon by the proposed development e.g. possible increased levels of intervisibility. However, given the precedent set by the existing supermarket and surrounding developments, particularly to the southwest around Lake Industrial Way, the impact of the development is considered to be negligible.

3.0 RECOMMENDATIONS

Given the levels of disturbance associated with the construction of the existing store and parking as indicated on the current aerial photograph of the Site, the proposed development is highly unlikely to result in any level of direct impact.

Pre-application consultation should be undertaken with the Isle of Wight Conservation and Design Team to ensure agreement about the negligible degree of impact of the proposed development upon the setting of the Grade II listed Merrie Gardens Farmhouse.

4.0 CONCLUSIONS

- The proposed development is an extension to an existing store.
- There are no designated or non-designated heritage assets within the bounds of the Site.
- Given the high levels of ground disturbance on the Site, no direct impacts are anticipated on any potential surviving unknown archaeological remains.
- Due to the existing development around the Listed Merrie Gardens Farmhouse, it is considered that the proposed extension will result in a negligible impact on the setting of this designated heritage asset.
