


Figure 24. Location 21.

Much of this material exposed in this field comprised a mixed deposit of bricks, tile, cobbles, broken glass and other assorted detritus in-filling a large hole in the ground. This material had apparently been used to backfill a clay extraction pit which had been used in association with a brick works which was demolished during the 1970's. The site has now been partially landscaped an two further pits have been flooded and are used by recreational anglers.




Figure 25. Location 22.

Pit, diameter approximately 1.70 metres, depth 0.56 metres containing charcoal rich deposits, and with some burning to the edges. Also an irregular narrow linear feature, approximately 0.20 metres wide and 0.05-0.10 metres deep running parallel with the current field boundary. Possibly the remains of a grubbed out hedge?




Figure 26. Location 23.

2.27.1 Site Description: linear Ditch

Ditch, on approximately the same alignment as the current southern field boundary hedge. Extended across the width of the easement, fill contained tarmac. Also a shallow linear feature running north - south, 0.50 metres wide and 0.16 metres deep with a flattened 'U' shaped profile. No dating evidence and length not determined due to plough scars & land drains.


