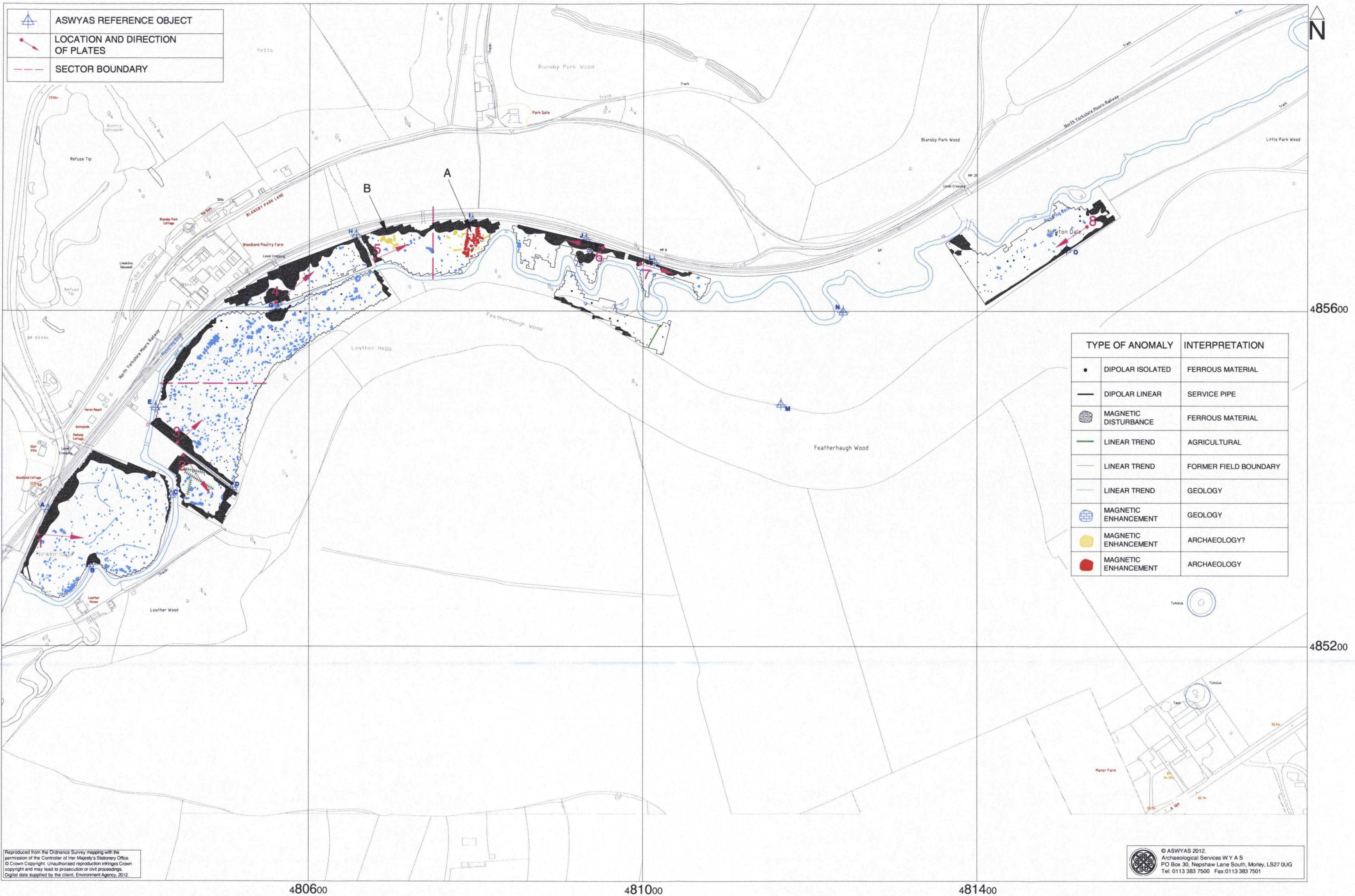

Fig. 3. Overall interpretation showing magnetometer data (1:4000 @ A3)

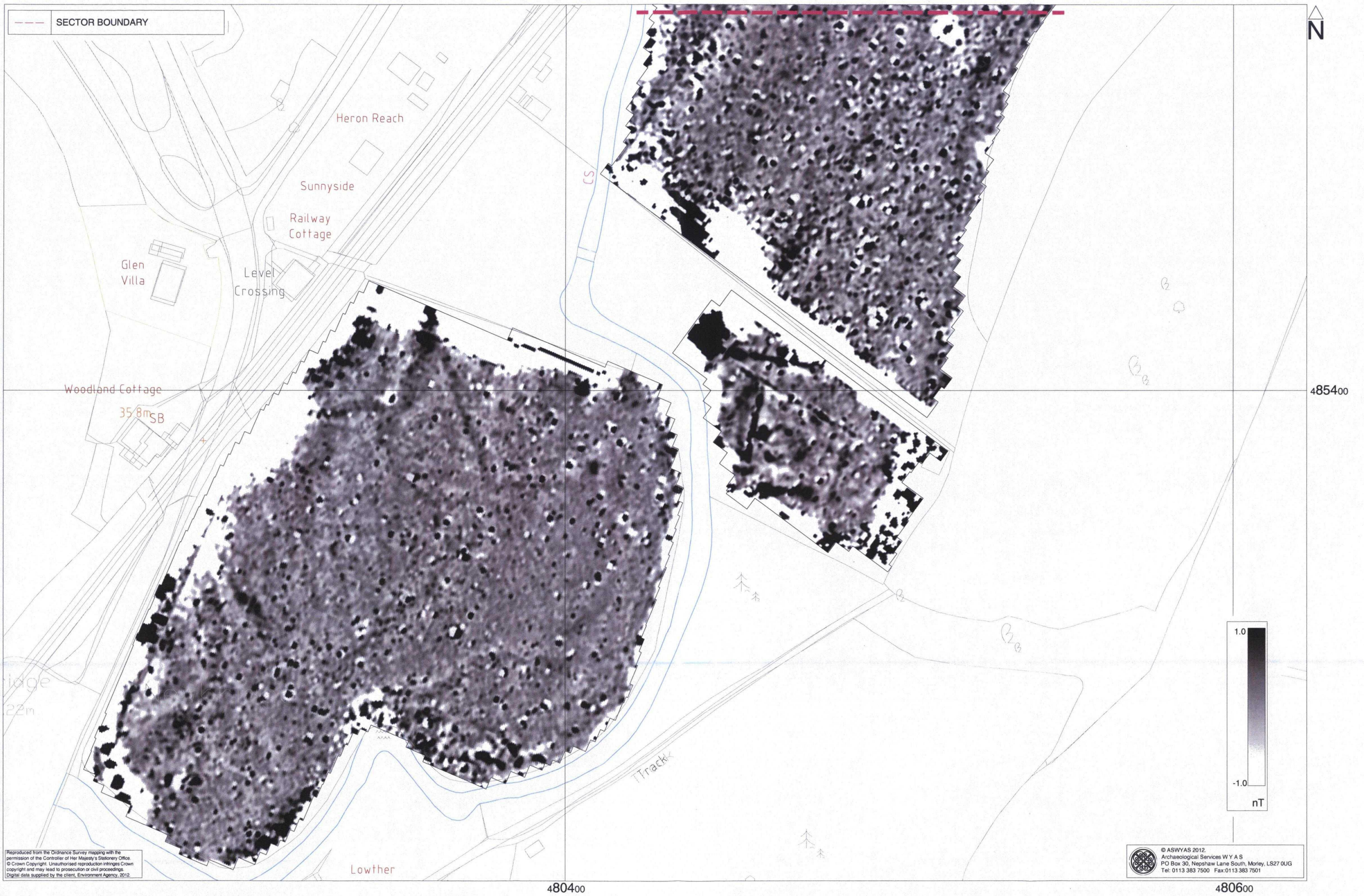


Fig. 4. Processed greyscale magnetometer data; Area 1, Area 2 and southern sector of Area 3 (1:1000 @ A3)

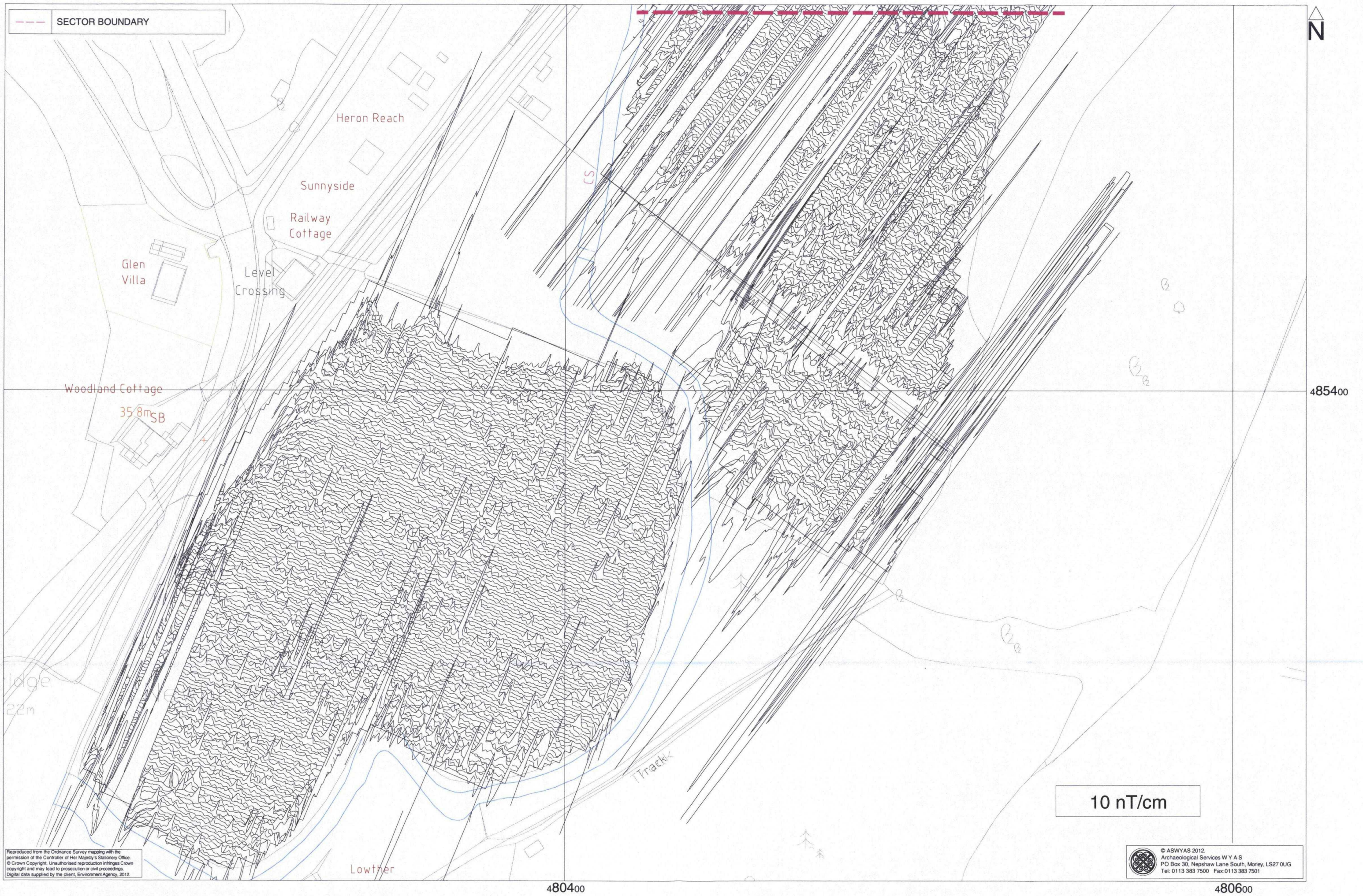


Fig. 5. XY trace plot of minimally processed magnetometer data; Area 1, Area 2 and southern sector of Area 3 (1:1000 @ A3)

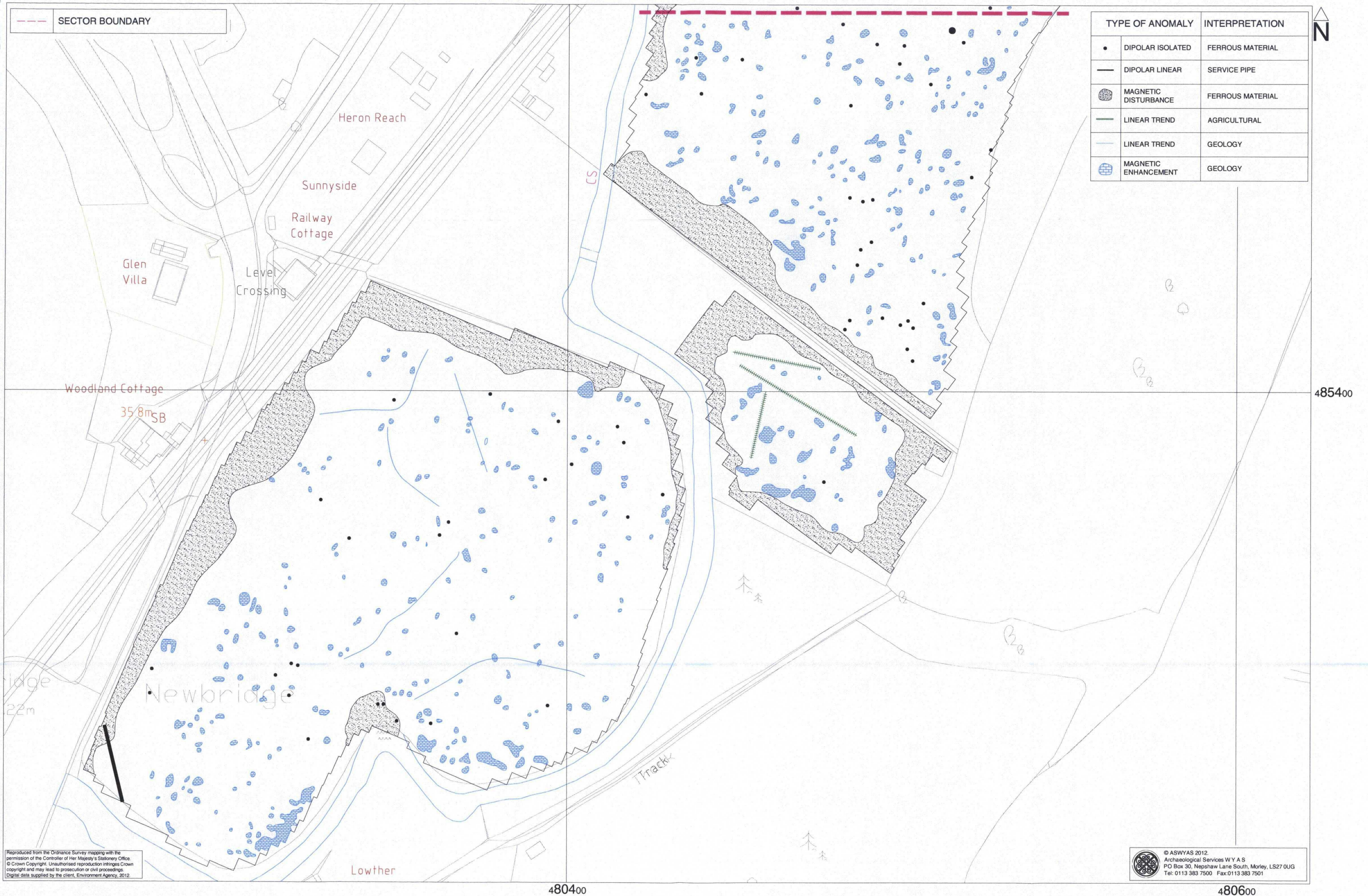


Fig. 6. Interpretation of magnetometer data; Area 1, Area 2 and southern sector of Area 3 (1:1000 @ A3)

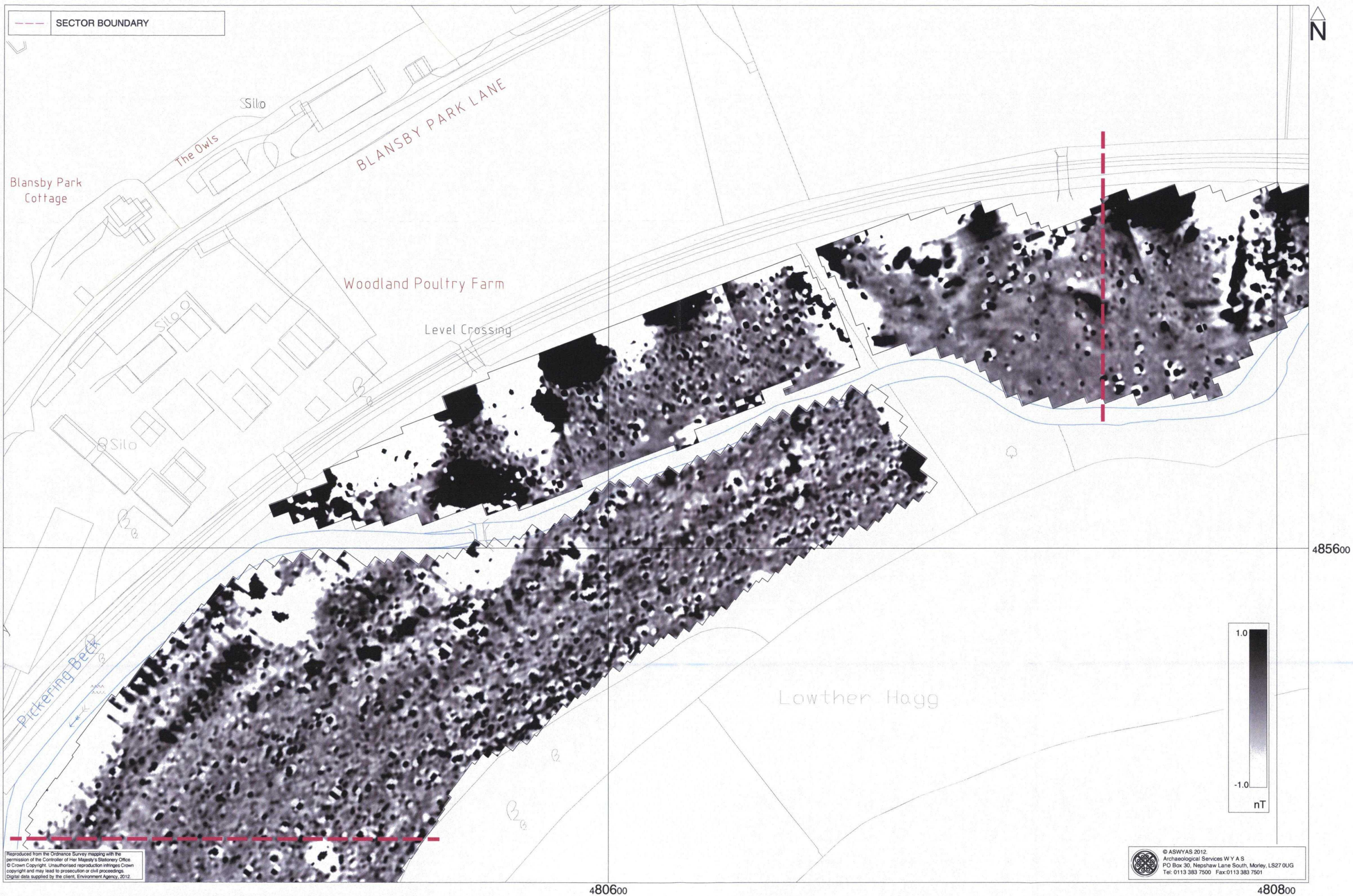


Fig. 7. Processed greyscale magnetometer data; Northern sector of Area 3, Area 4 and western sector of Area 5 (1:1000 @ A3)

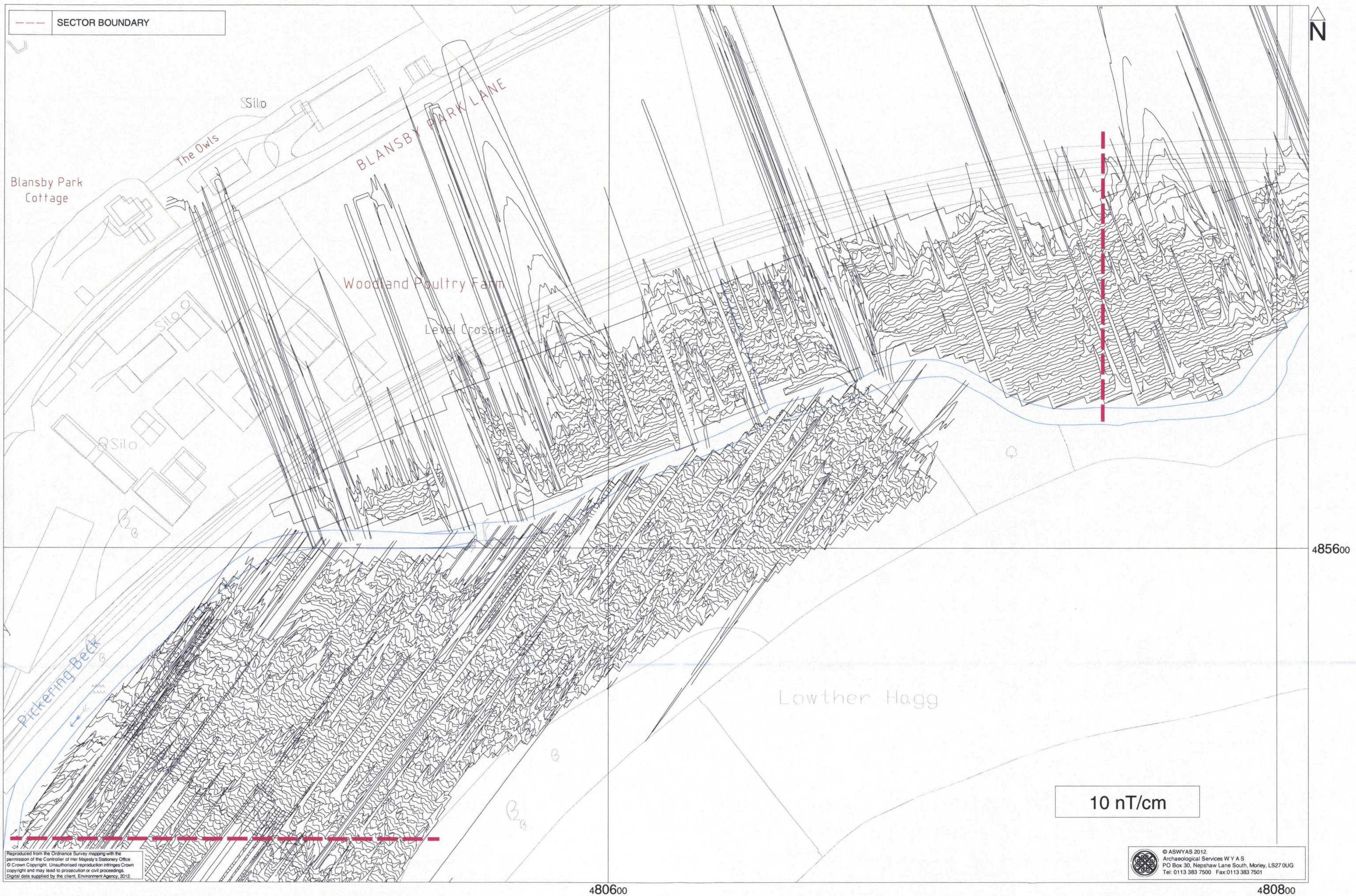
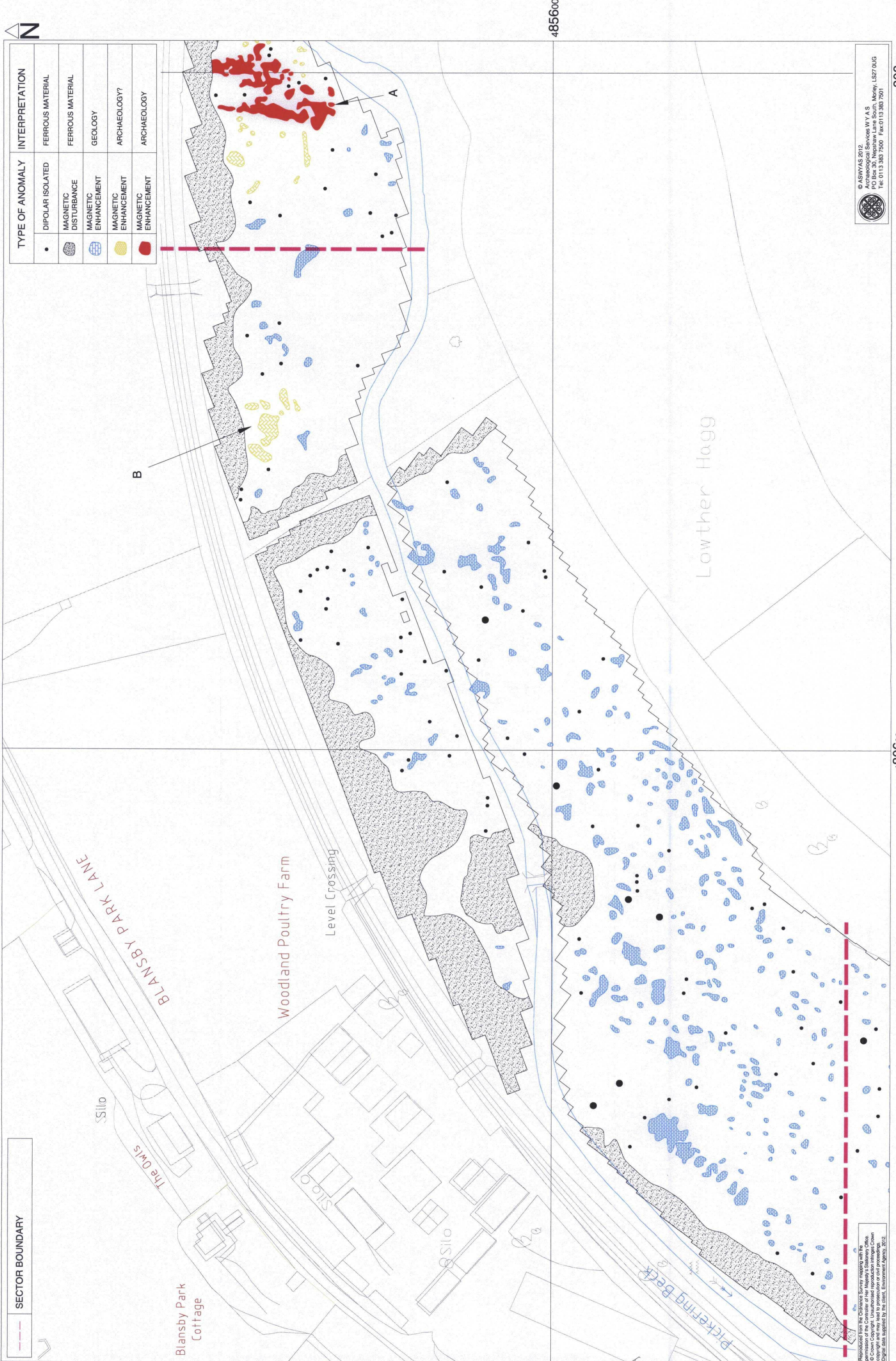


Fig. 8. XY trace plot of minimally processed magnetometer data; Northern sector of Area 3, Area 4 and western sector of Area 5 (1:1000 @ A3)

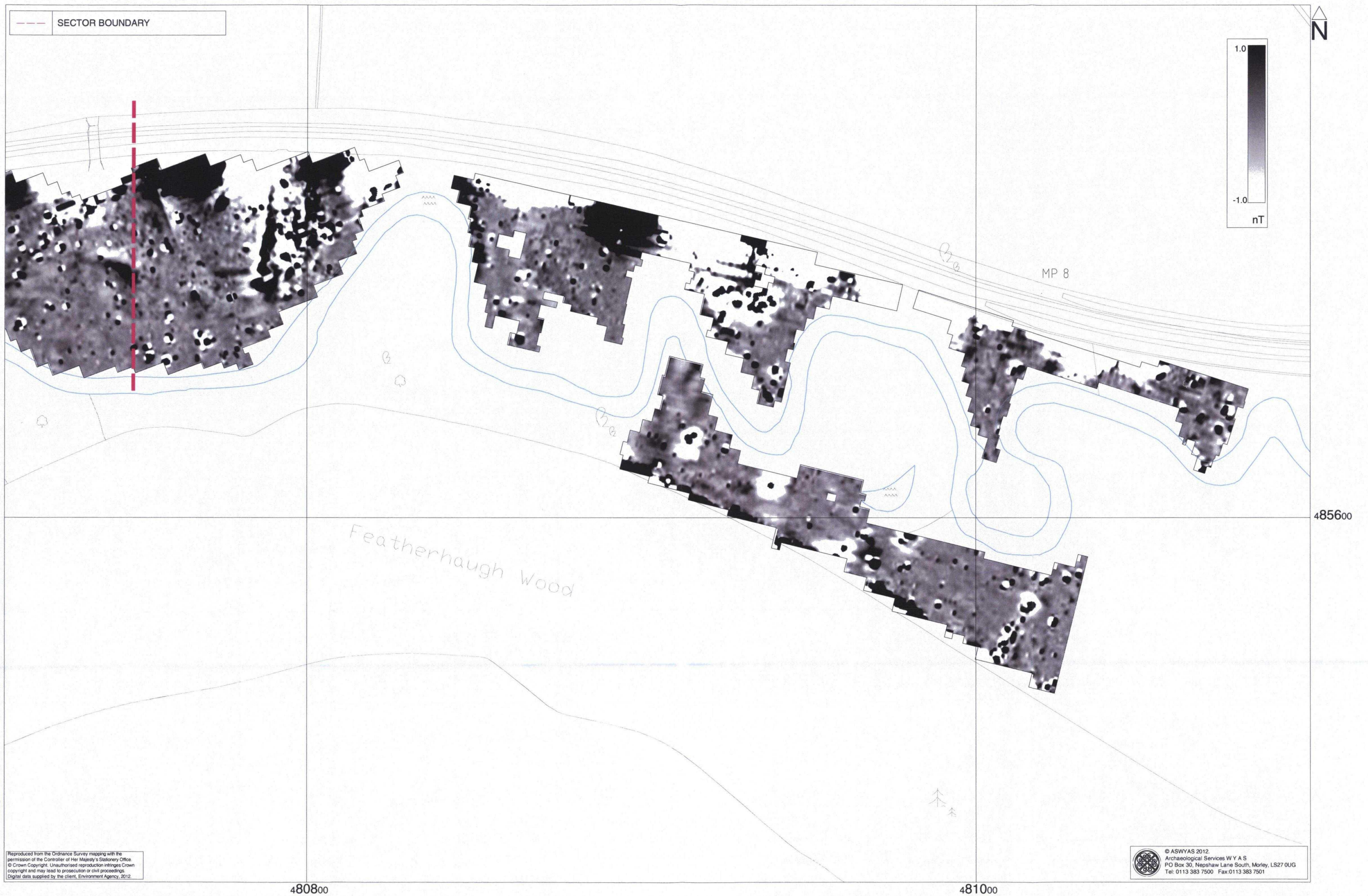


Fig. 10. Processed greyscale magnetometer data; Eastern sector of Area 5, Area 6 and Area 7 (1:1000 @ A3)

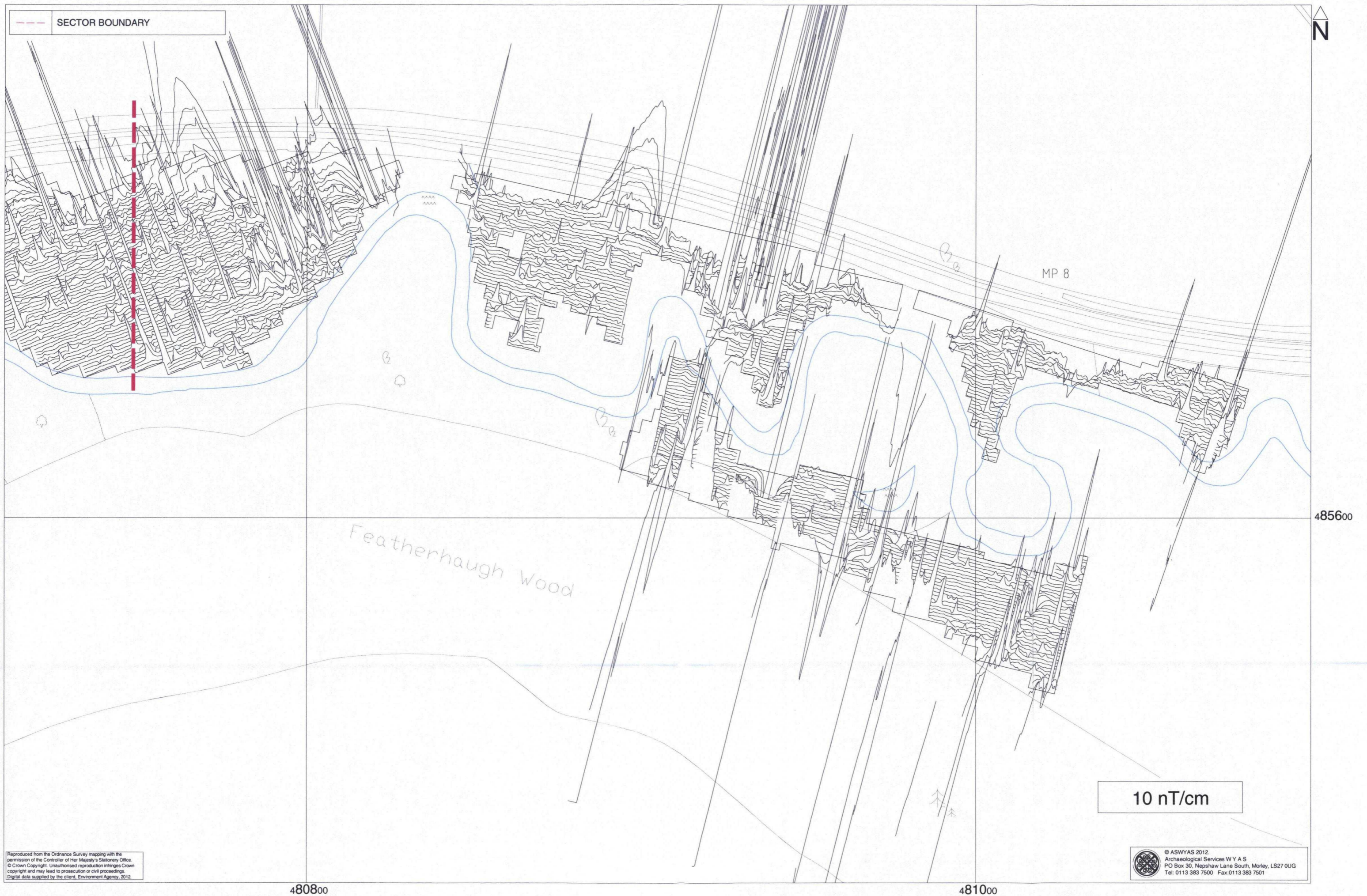
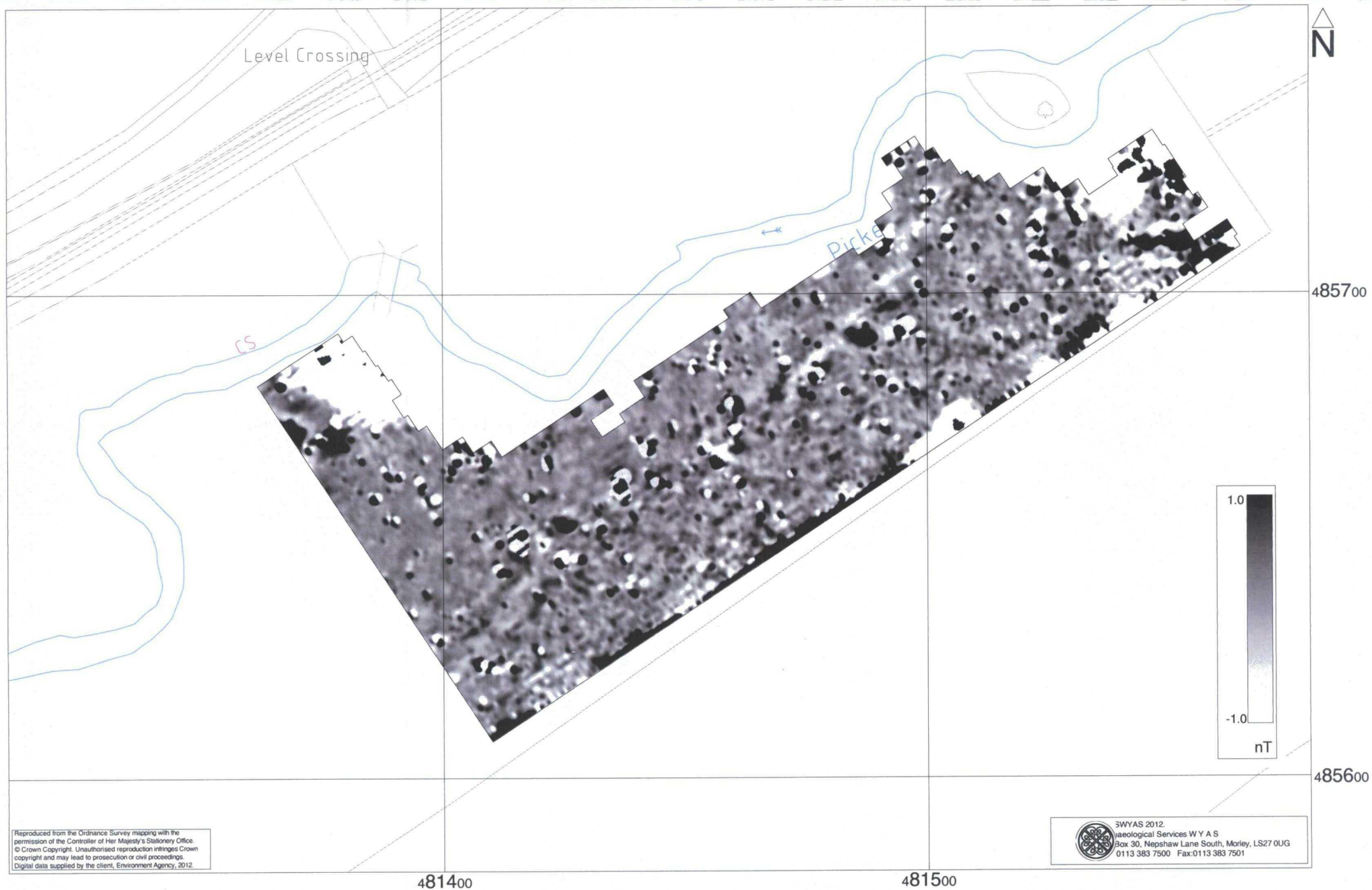


Fig. 11. XY trace plot of minimally processed magnetometer data; Eastern sector of Area 5, Area 6 and Area 7 (1:1000 @ A3)

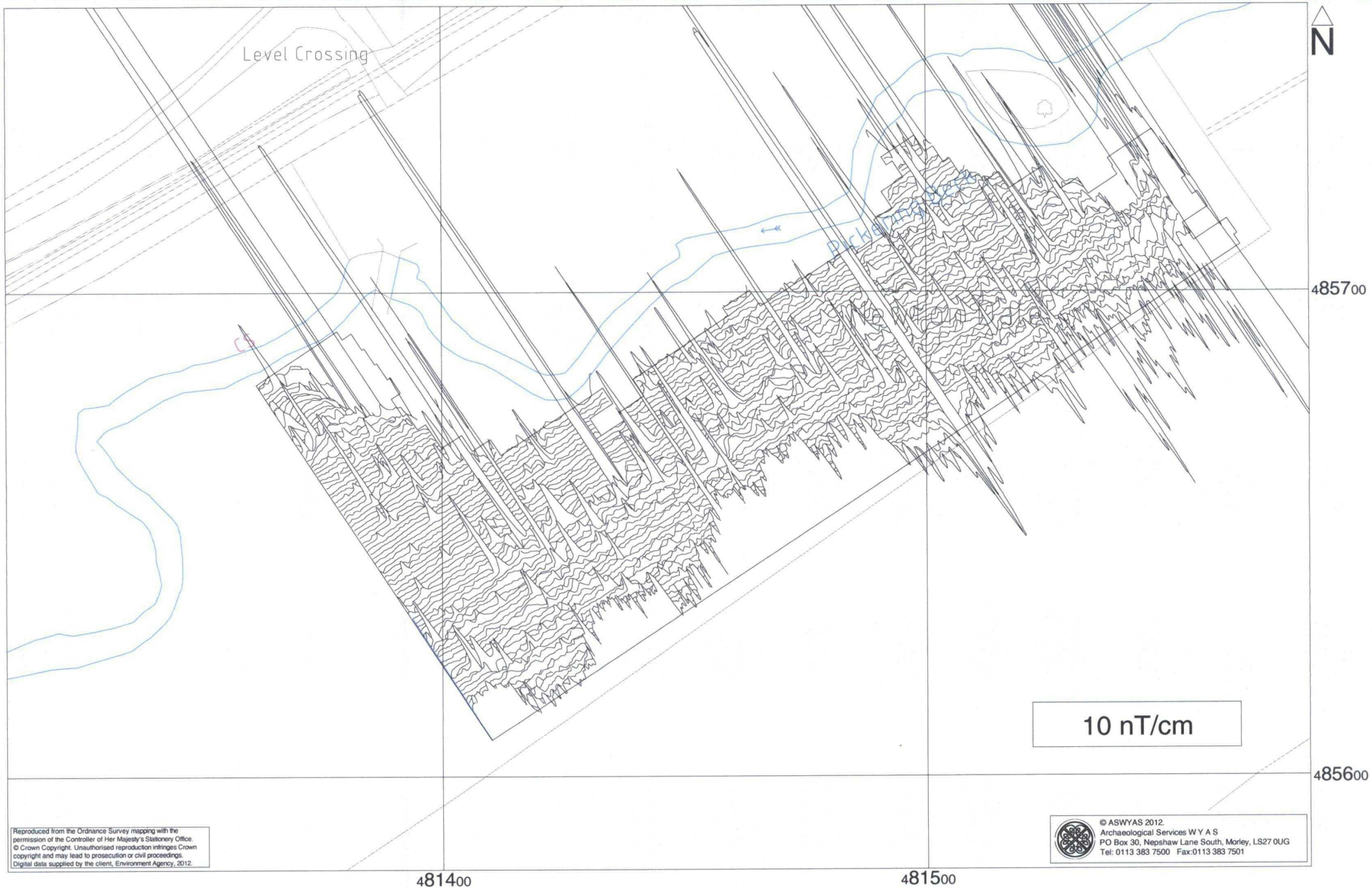


Fig. 14. XY trace plot of minimally processed magnetometer data; Area 8 (1:1000 @ A4)

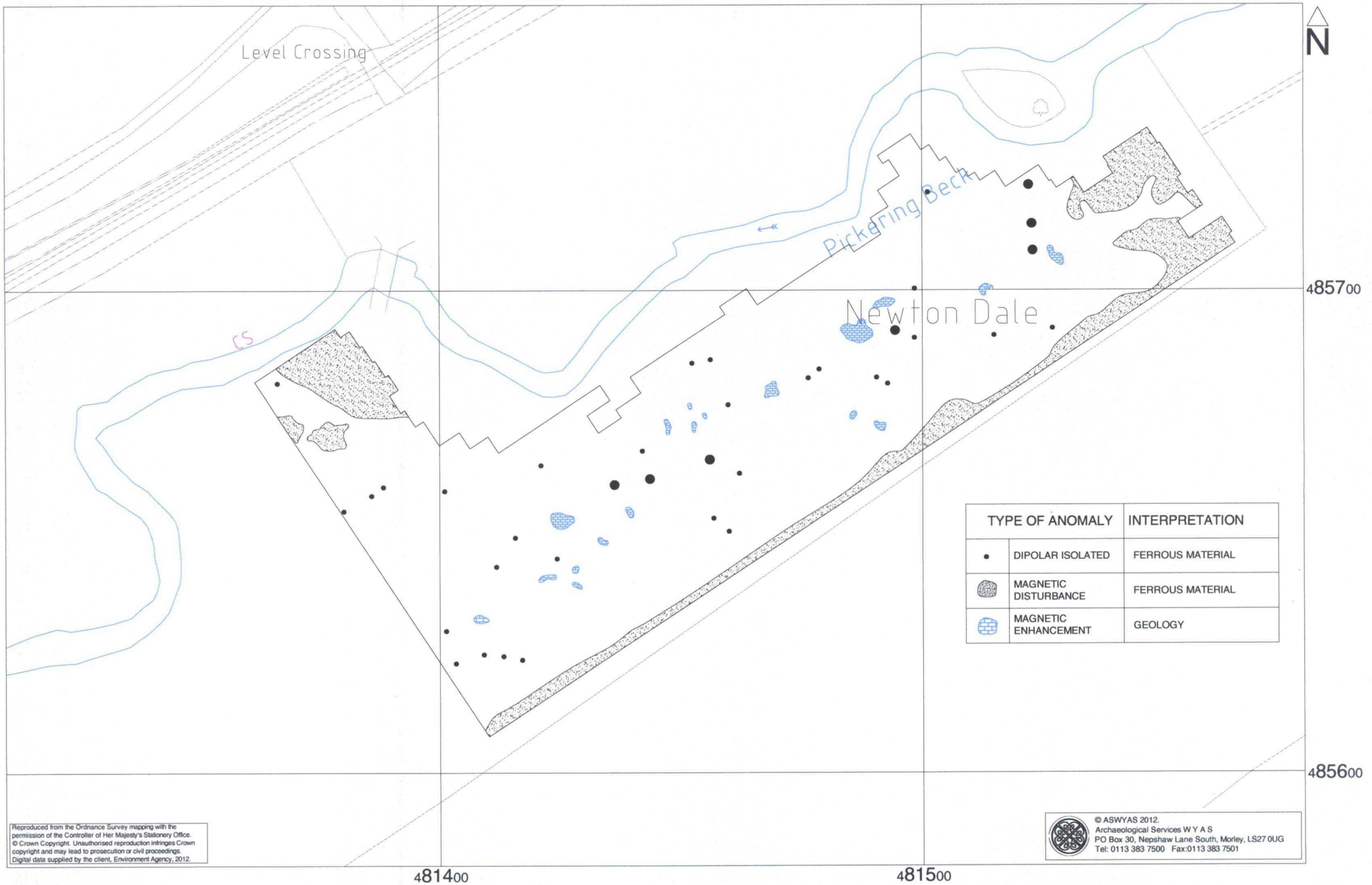


Fig. 15. Interpretation of magnetometer data; Area 8 (1:1000 @ A4)

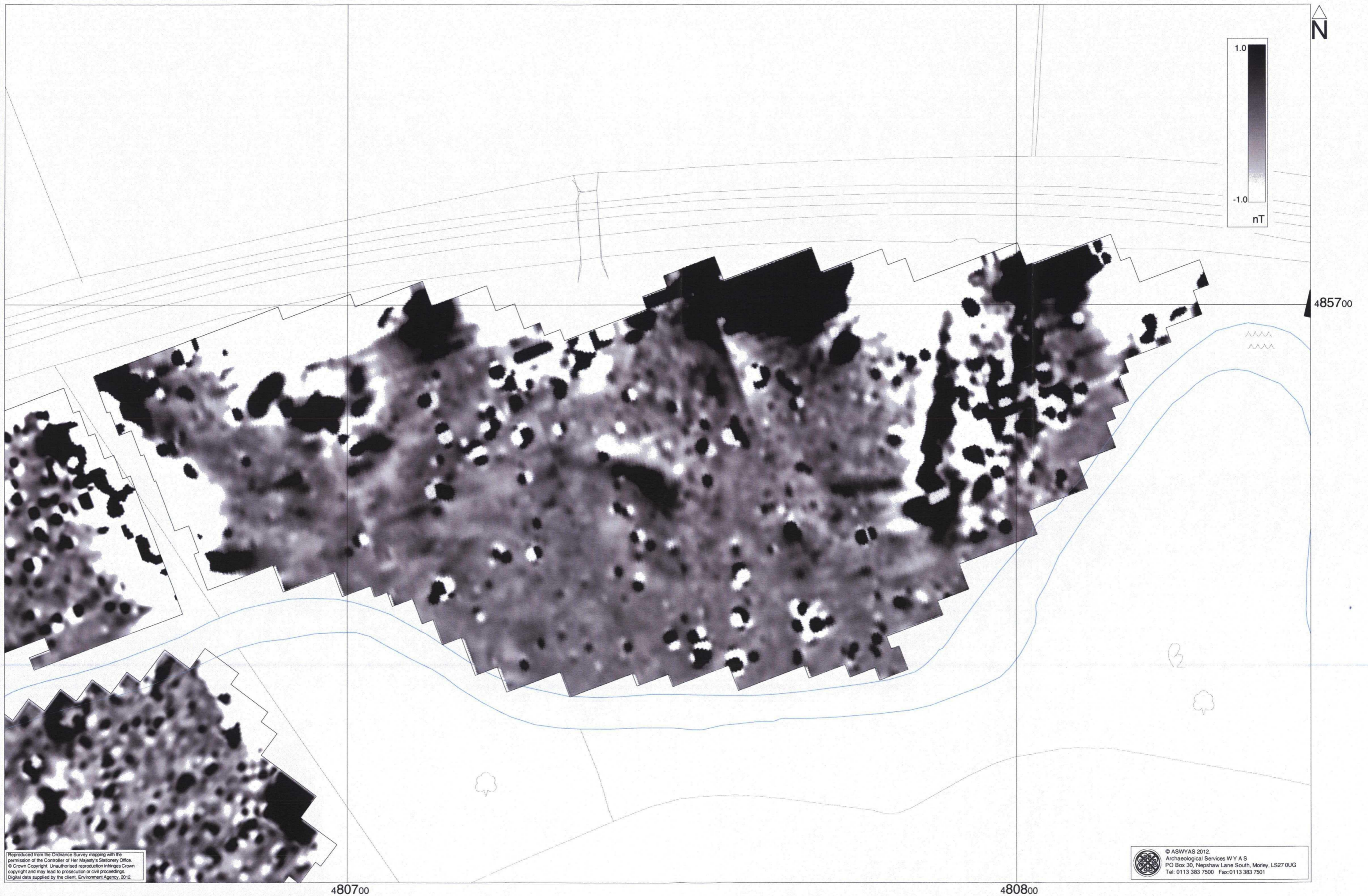
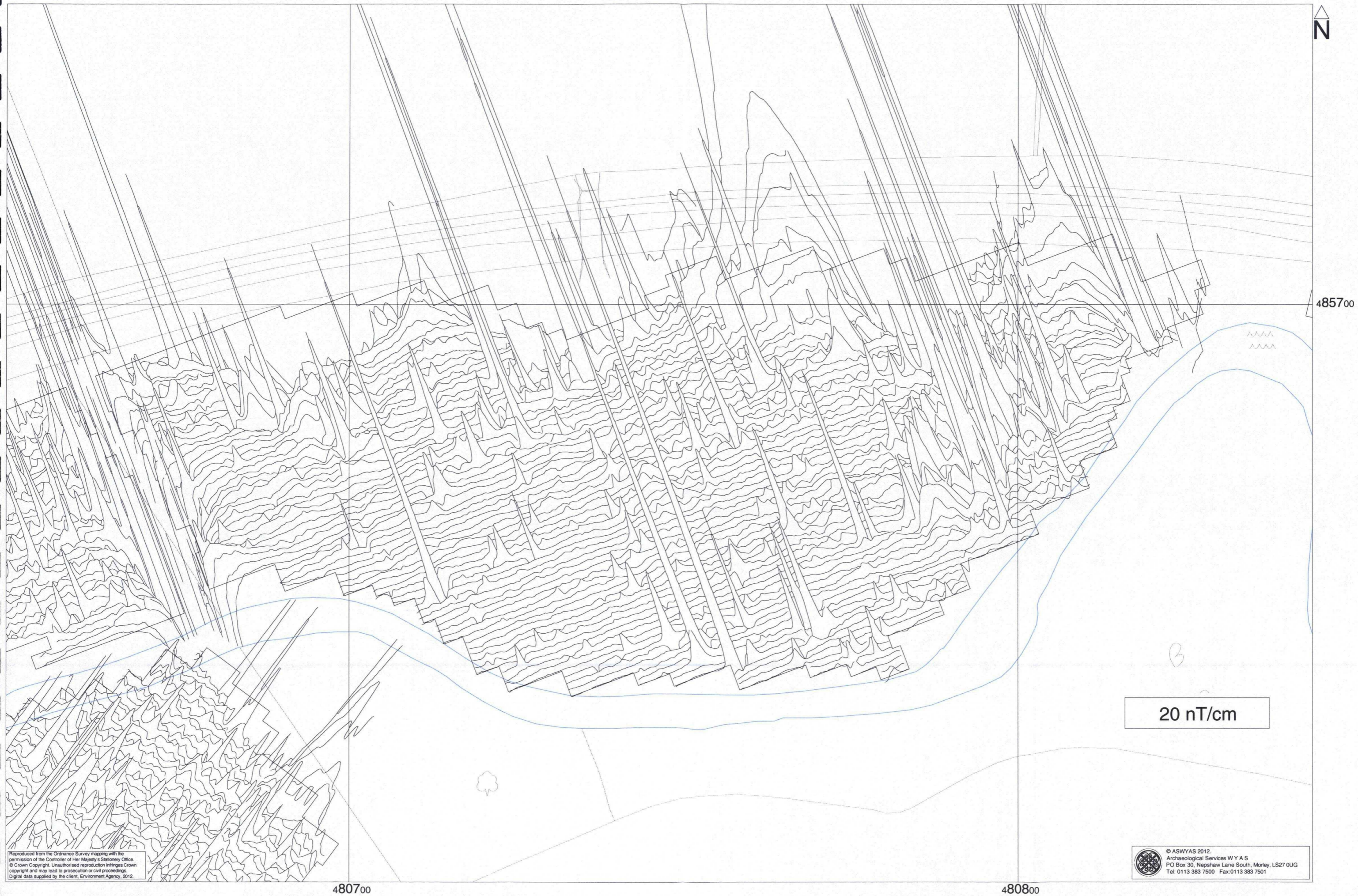


Fig. 16. Processed greyscale magnetometer data; Area 5 (1:500 @ A3)

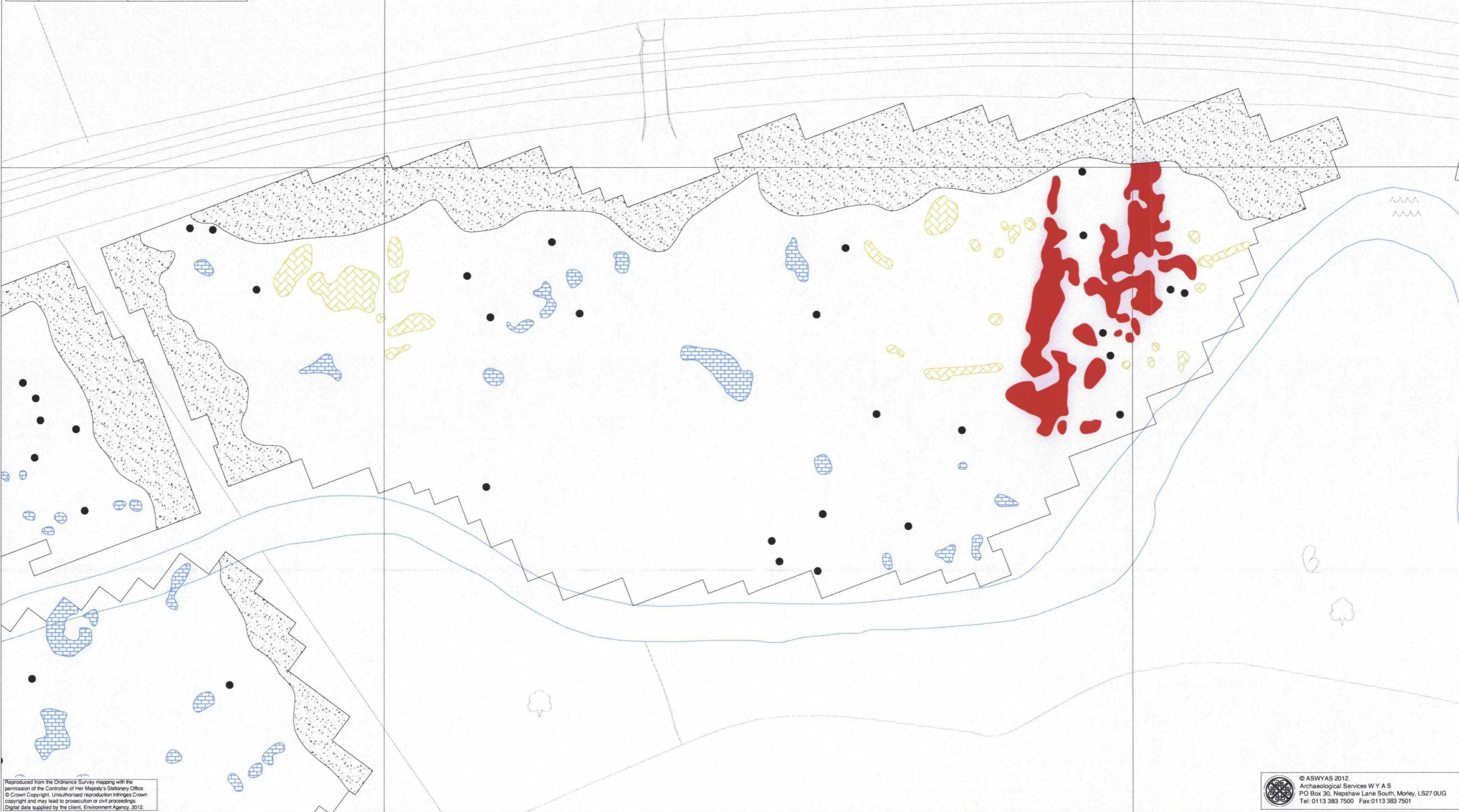
