Archaeological Desk Based Assessment

Non-Technical Summary

This report has been undertaken, by MAP Archaeological Practice Ltd under instruction from Richard Dykes at The Planning & Design Partnership acting on behalf of Thomas Crown Associates Ltd., to assess the Historical and Archaeological background and the impact of the redevelopment of the land at The Old Council Depot, Manor Vale Lane. Kirkbymoorside, North Yorkshire.

The site was formerly the Old Council Depot and is located along Manor Vale Lane, Kirkbymoorside.

The assessment has revealed the five Non-Designated Heritage Assets within the Proposed Development Area, four caves which could be geological in origin within Manor Vale and the area described as Ancient semi-natural woodland on the Historic Landscape Characterisation.

The Proposed redevelopment of the area would have no impact on the Designated Heritage Assets to the north-east and south, the Neville Castle Scheduled Monument to the north-east and Kirkbymoorside Conservation Area to the south.

The site is to the north of the historic core of Kirkbymoorside and Prehistoric, Roman, Anglo-Saxon, Medieval sites and artefacts have been found within a 1km radius of the site.

The results of the Desk Based Assessment has shown there are no Cultural Heritage or Archaeological reasons to prevent development.

1. Introduction

- 1.1 The Archaeological Desk Based Assessment has been undertaken by MAP Archaeological Practice Ltd under instruction from Richard Dykes at The Planning & Design Partnership acting on behalf of Thomas Crown Associates Ltd. to evaluate the Historical and Archaeological background, and assess the impact of the redevelopment of the land at The Old Council Depot, Kirkbymoorside, North Yorkshire. (SE 69442 86861: Figs. 1 & 2).
- 1.2 Archaeological, Historical and Architectural remains are protected by means of Statutory Instruments (including World Heritage Statue, Scheduled Ancient Monument Legislation and the National Planning Policy Framework: Chapter 12 (March 2012).
- 1.3 The site is located outside the Conservation area. There are no Scheduled Ancient Monuments, Listed Buildings, Registered Battlefields or Historic Gardens within the proposed Development Area.
- 1.4 The Archaeological Desk Based Assessment was funded by Thomas Crown Associates Ltd.
- 1.5 All Maps within this report have been reproduced from the Ordnance Survey with the permission of the Controller of Her Majesty's Stationery Office, Crown Copyright, Licence No. AL50453A.

2. Site Description

- 2.1 Kirkbymoorside is a market town in the District of Ryedale, in the county of North Yorkshire and located on the southern edge of the North York Moors on land rising from the Vale of Pickering to the Tabular Hills. The historic core of Market Place, Piercy End, Howe End, Tinley Garth, West End, Church Street, Crown Square, Dale End and Castlegate are a designated Conservation Area.
- 2.2 The site is located in secluded area known as Manor Vale and was formerly used as a NYCC Depot. The site is accessed via Manor Vale Lane, north of

Dale End. The Proposed Development Area is a levelled yard with various buildings and walls (Pls. 1-12). There are caves on the western side of Manor Vale (Pls. 6-7)

- 2.3 The Proposed Development Area is an area of c. 0.75 Ha and of heights between 46 and 53m AOD.
- 2.4 Soils of the Denchworth Soil Association (712b), described as 'slowly permeable seasonally waterlogged clayey soils with similar fine loamy over clayey soils. Some fine loamy over clayey soils with only slight seasonal water logging and some slowly permeable calcareous clayey soils. Landslips and irregular terrain locally', over solid geology of 'Jurassic and Cretaceous Clay' (Mackney et al 1983).

3. Aims and Objectives

- 3.1 The Desk Based Assessment has been prepared in accordance with best practice guidelines issued by the Institute of Field Archaeologists Standard and Guidance for archaeological desk-based assessment (IFA 2012).
- 3.2 An assessment is required that will consider the likely survival of buried archaeological deposits on the site, the likely significance of such deposits and the impact on them of the proposal and assess the historic interest of the standing buildings and their contribution to the area's historic character and will consider the impact of the development proposal.
- 3.3 The aim of the Desk Based Assessment is to:
 - Identify recorded features of historical and archaeological significance within the study area
 - Establish the potential for hitherto unrecorded and unknown sites
 - Assess the relative importance of the sites
 - Assess the likely impact of the proposed development on the sites
 - Make recommendations to mitigate any impact of the development on the sites

4. Methodology

- 4.1 The assessment comprised the evaluation of historical information derived from cartographic and pictorial documents, Tithe awards, parish registers, the Ordnance Survey and the Historic Environment Records, and secondly by consideration of previous Archaeological Excavations, Evaluations and Watching Briefs and covered an area of one kilometre from the centre of the Proposed Development Area.
 - National Archives
 - National Monument Register
 - North Yorkshire County Council Archives
 - North Yorkshire County Council Historic Environment Record
- 4.2 The following data sources were utilised for assessment:
 - North Yorkshire County Council Historic Environment Record (HER) entries for 1km around the site;
 - II. North Yorkshire County Council Archives (NYCRO)
 - III. National Monuments Record;
 - IV. Listed Building/Conservation records;
 - V. Aerial Photographs;
 - VI. Scheduled Monuments List;
 - VII. English Heritage Register of Historic Parks and Gardens and Register of Battlefields;
 - VIII. Visual inspection of the site;
 - IX. Plans and maps of the site and its environs, including historical pictorial and surveyed maps and including pre- and post war Ordnance Surveys up to the present day;
 - X. Place and street name evidence;
 - XI. Trade and Business Directories;
 - XII. Historical documents and photographs; and appropriate archaeological and historical journals and books.

5. Policy Context

5.1 Archaeological, Historical and Architectural remains are protected by means of Statutory Instruments (including Scheduled Ancient Monument Legislation, National Planning Policy Framework (March 2012) Chapter 12.

5.2 National Planning Policy Framework – 12. Conserving and enhancing the historic environment

NPPF -12 sets out the Government's objectives for the historic environment and rationale for its conservation. It recognises the unique place the historic environment holds in England's cultural heritage and the multiple ways it supports and contributes to the economy, society and daily life. The NPPF also identifies the historic environment as a non-renewable resource. Its fragile and finite nature is a particularly important consideration in planning. Conserving this resource for future generations accords with the principles of sustainable development. Government places a priority on its conservation and has set out tests to ensure that any damage or loss is permitted only where it is properly justified.

6. Significant Criteria

- 6.1 The principal aims of the Heritage Assessment are:-
 - I. To identify known cultural heritage and archaeological sites within or in the vicinity of the proposed development;
 - II. To identify areas within the application boundary with the potential to contain any previously unrecorded archaeological remains;
 - III. To assess the physical and visual effects of the proposed development upon historic buildings or archaeological sites and their settings;
 - IV. To propose appropriate mitigation measures which could be built into the development proposals to avoid, reduce or remedy any potential adverse effects identified; and,
 - V. To assess the acceptability of the development proposals with respect to cultural heritage and archaeology in relation to local plan policies and national planning guidance.

6.2 Criteria of Sensitivity

6.2.1 The criteria of sensitivity has been assessed in accordance with the following principles:

7. Results

- 7.1 The site is located on the north side of the town of Kirkbymoorside, which is located in the parish of Kirkbymoorside in Ryedale Wapentake in the North Riding of Yorkshire. Kirkbymoorside lies on the north side of the Vale of Pickering, south of the North York Moors National Park, approximately 6 miles from Helmsley and 8 miles from Pickering.
- 7.2 There are forty-seven Designated Heritage Assets within one kilometre of the Proposed Development Area including the Kirkbymoorside Conservation Area, two Scheduled Monuments and forty-four Listed Buildings (one Grade I and forty-three Grade II Listed Buildings: Table 4; Figs 3, 4 & 5). The Development Area lies immediately to the south-east of the Neville Castle Scheduled Monument (DNY503; SM 30135 Fig. 3) and north of The historic core of Kirkbymoorside is a Designated Conservation Area (DNY1040; Fig. 3).

7.3 There a five Non-designated Heritage Assets, described as four undated, possibly geological caves and the Historic Landscape Characterisation entry for Ancient Semi-natural woodland, noted within the Proposed Development Area (Table 5, Figs. 4 and 6).

7.5 **Undated and Prehistoric**

7.5.1 There are four Non-Designated Heritage Assets, listed as undated, possibly

geological caves within the Proposed Development Area (MNY1241-

MNY1244).

7.5.2 Prehistoric Activity has been noted south of the Proposed Development Area

by two tumuli (Bronze Age Round Barrows), a cairn, and eight findspots (Fig.

5). A Round Barrow was noted, now covered by the Tontine Inn, with 12

inhumations, traces of burning and three urns (Howe End at SE 6974 8650:

MNY 1224). Another barrow and Cairn were earthworks at Low Park Farm

(MNY 1252 & MNY1253). Stray finds included Neolithic finds (polished stone

axes, a stone adze and flint scraper: MNY1245, MNY1248, MNY1249 and

MNY1271) and Bronze Age finds (a Palstave, a Mace, a Spear and a

Socketed Axehead: MNY1221, MNY1226, MNY1250 and MNY1251).

7.5.3 There are two undated aerial photographic cropmarks within one kilometre of

the Proposed Development Area described as enclosure (MNY1292 and

MNY1293).

Potential: Low

Significance: Local to Regional

7.6 Roman

7.6.1 No Roman finds or features have been found within the Proposed

Development Area.

7.6.2 A Roman cooking pot has with one kilometre of the Proposed Development

Area (MNY1254).

Potential: Low

Significance: Local to Regional

7.7 Anglian/Pre-conquest

7.7.1 No Anglian/Pre-Conquest finds or sites are known from within the Proposed

Development Area.

7.7.2 Kirkbymoorside has a Pre-Conquest foundation and is mentioned in the Domesday Book (MNY 1227). Fragments of Anglian Carved Stone Crosses have been found at All Saints Church and the Vicarage on Church Street (MNY 1230 & 1231). Saxon inhumations (burials) were also associated with the tumulus (Bronze Age Round Barrow) at Howe End (MNY1224).

Potential: Low

.

Significance: Local to Regional

7.8 Medieval

7.8.1 Kirkbymoorside lies in the parish of that name in the Wapentake of Ryedale in the North Riding of Yorkshire; now in the District of Ryedale in the county of North Yorkshire. The place name of Kirkbymoorside means farm by a church at the head of the moor, and derives from the Old Norse for church "kirkja", farm "by", moor "mor" and head "heafod".

7.8.2 Kirkbymoorside is noted in the Domesday Book of 1086, when it was known as 'Chirchebi' and is noted in three entries:-

'In Kirkbymoorside, Orm had 5 carucates of land to the geld. There is land for 2 ploughs. Hugh fitzBaldric has 2 ploughs there; and 10 villans with 3 ploughs. There is a priest and a church, and 1 mill [rendering] 4s.' (Faull & Stinson 1986, 23N19).

These belong to Kirkbymoorside: "Waletun"[in Kirkdale], Hutton-le-Hole, Gillamoor, 'Hoveton' [in Kirkdale]. In these are 24 carucates of land to the geld with 5 ploughs, and [he has] 29 acres of meadow. [It is] 12 leagues long and 2 leagues broad (ibid, 23N20).

This belong to Kirkbymoorside: Welburn [in Kirkdale], "Middleham" [in Muscoates], Harome, Nawton, Great Barugh, Normanby [near Salton], Kirby Misperton, Ryton, Marton [in Sinnington], Little Barugh. In these are $27^{1}/_{2}$ carucates to the geld. There is land there for 12 ploughs. Now there are 21 villans having 7 ploughs. There are 40 acres of meadow. The whole manor with appurtenances was worth in the Reign of Edward £12, now 100s (ibid, 23N21).

- 7.8.3 The Manor of Kirkbymoorside was granted to Robert de Stutevill, and formed part of the barony of Mowbray. The manor was held by the heirs of the Stutevills, the Wakes then Thomas Earl of Kent and his wife Alice, when the earldom of Kent fell into abayance in 1408, passing to Elizabeth Nevill, then her son Ralph, the second Earl of Westmorland in 1473. In 1254, Henry III granted to the lord of the manor, Hugh le Bigod and his wife Joan de Stutevill, a weekly market in the town on a Wednesday and a yearly fair on the eve, day and morrow of the Nativity of St. Mary (8th September).
- 7.8.4 In 1276, the manor was valued at £98. 5s. 8d. By 1281-2 the value had risen to £154. 4s. 1d. Sixteen tenants are named including a smith, a hayward and a huntsman. There are five watermills in the manor worth £23. 8s. 8d., with the oven of the vill giving 20s. In 1301, a lat subsidy notes 28 taxpayers including bakers, a miller, a forester and a noghtwatchman. In 1327, 43 taxpayers are listed.
- 7.8.5 There are no Medieval Designated or Non-designated Heritage Assets within the Proposed Development Area. Directly north-east of the Proposed Development Area is the Designated Heritage Asset of Neville Castle (Scheduled Monument 30315, DNY503, SM 30135 and MNY1218). Neville Castle is located on the north side of the town, at the end of Castlegate. The building was a hunting lodge for the Neville's when they held the manor in the fifteenth and sixteenth centuries.
- 7.8.6 There are another two Designated Heritage Assets within one kilometre of the Proposed Development Area; a moated site, known as Viver's Hill (DNY484; Scheduled Monument 30103, MNY1222) and the Parish Chirch of All Saints (a Grade I Listed Building DNY10952, MNY1229 and ENY113). Vivers Hill, was located to the east of the town. The moat formerly the manor of the Studvill's which was modified in the nineteenth century with fishponds (Le Patourel 1973, 119-120). Medieval Moated Site and Manor House known as Viver's Hill was excavated in 1960 (MNY 1222). All Saints' Church in Kirkbymoorside has a pre-Conquest foundation, and the present building

dates from the Norman, thirteenth, eighteenth and nineteenth centuries (MNY 1229).

7.8.7 There are eight Medieval Non-Designated Heritage Assets within one kilometre of the Proposed Development Area. There is a possible Medieval Deer Park with documentary evidence from 1570 and place-name evidence (MNY1220). A fishpond was part of the Viver's Hill site (MNY 1223). Medieval

pottery sherds were found in a pit excavated on Little Applegarth in 1965

(MNY 1232). Remains of medieval ridge and furrow ploughing were noted as

earthworks (MNY 24214). A tile scatter probably dates from the Medieval

period (MNY23660). A watermill was noted at Kirby Mills (MNY23795). A coin dating to the reign of Edward I was found in Kirkbymoorside (MNY35396). A

short length of wall possibly dating to the Medieval period was found 150 m

north of All Saints Church (MNY36103 and ENY6118).

7.8.8 The four caves (Non-Designated Heritage Assets, listed as undated, possibly geological on the North Yorkshire HER; MNY1241-MNY1244) within the Proposed Development Area and are locally known as tunnels linking the

castle to Kirkdale and could be Medieval in date.

Potential: Low

Significance: Local to Regional

7.9 Post-medieval and Modern

7.9.1 Kirkbymoorside contined as a market town into the eighteenth century, when

the toll booth was built out of the ruins of the Neville's hunting lodge. The

manor passed through the Nevill's until 1569 when Kirkbymoorside was

forfeited to the Crown, but the manor was held by Lady Gascoigne. In 1606 was granted to Charles, Duke of York, and then George Villiers in 1616. In

1687, the manor was sold in payment of debts after the death of George,

Duke of Buckingham. In 1695, the manor was bought by Lord Duncombe,

whose descentant Lord Feversham is lord of the manor (Page 1968, 511-

517).

- 7.9.2 The population of Kirkbymoorside rose to 2000 in the 1841, but declined in the later nineteenth century. The population in 1999 was 2770. In 1875, the Thirsk to Pickering Railway passed south of the town, which was dismanted in the 1960's. The northern part of the site was clipped by the railway line.
- 7.9.3 There is a Non-Designated Heritage Asset within the Proposed Development Area, which is described as Semi-Natural Ancient Woodland on the Historic Landscape Characterisation (HNY24364: Fig. 6), which is attributed to the 1600AD.
- 7.9.4 The Proposed Development Area lies just to the north of the Kirkbymoorside Conservation Area (Fig. 3), which is centered on the historic core of the Medieval and Post-medieval Town.
- 7.9.5 Within one kilometre of the Proposed Development Area, there are forty-four There are Designated Heritage Assets and eight Non-designated Heritage Assets. There are eight Listed Building dating to the seventeenth century including the Black Swan Public House dated on the porch to 1632 (MNY 1233), a former inn, known as Buckingham House (MNY 1234) and a longhouse at 42-44 West End (MNY30987; ENY4923). A windmill, a pond, remains of a post-medieval building, a well and a Pos-medieval button are noted in the vicinity of Kirkbymoorside (MNY1236, MNY23860, MNY25397, MNY32500, MNY36102 & ENY6118).
- 7.9.6 Three maps of Kirkbymoorside pre-date the Ordnance Survey (Figs. 7, 8 and 9). The 1790 map of Kirkbymoorside Township (NYCRO: ZEW M15) shows the Proposed Development area as part of plot 314. The 1827 map of Kirkbymoorside (NYCRO: ZEW M51) shows the development area as part of gorge. The 1849 edition map of Kirkbymoorside (NYCRO: ZEW M68) shows the Proposed Development Area as part of woodland gorge, No. 95 (Fig. 7).

7.9.7 The First Edition (1856), the 1910 and the 1914 Edition of the Ordnance Survey show the area as a wooded gorge (Fig. 8,9 &10). The 1985 Edition Ordnance Survey Map shows the site as a Depot and part of the woodland.

Potential: Low

Significance: Local to Regional

7.10 Previous Archaeological Work

7.10.1 Limited excavations have taken place in the 1960's and 1970's at Neville Castle, uncovering remains of stonewalls relating to various buildings (ENY5441; ENY5465; Dornier 1967 and Williams 1977, p. 87-96). In 1995, MAP undertook an excavation at No 13-15 High Market Place, but no archaeological features or deposits were uncovered. In 1999, A.L. Pacitto in advance of a graveyard extension undertook a geophysical survey; which revealed anomalies interpreted as ridge and furrow and a trackway (ENY125). In 2000, Colin Briden undertook at Watching Brief at all Saints' Church and uncovered a sherd of medieval pottery and disarticulated human bone (ENY113). In 2001, a recording brief was undertaken by MAP at land adjacent to the Meadowcroft, Castlegate were no archaeological features or finds were found (ENY506). In 2004, Northern Archaeological Associates carried out a desk based assessment for a Sportsfield CSO, where no further work was recommended (ENY2458), and MAP undertook a watching brief at Land between Feversham Drive and Piercy End where no archaeological features or finds were observed (ENY2859).

7.11 Listed Buildings

7.11.1 There are forty-four Listed Buildings are known in the town of Kirkbymoorside; one Grade 1 Listed Building (All Saints' Church, Church Street), dating to the Medieval period. All other buildings and structures are Grade II listed: on Parks Road, Castlegate, Church Street, Crown Square, Dale End, Tinley Garth, Market Place, High Market Place, Piercy End, Howe End and West End and dated from the seventeenth to twentieth centuries.

7.11.2 There are no Listed Buildings within or bordering the Proposed Development Area.

7.12 Site Walkover

7.12.1 The site walkover was undertaken on the 2nd April 2013. The site had previously been a North Yorkshire County Council Depot and had bases for loading bays, and various buildings on the site (Pls. 1-12). The caves were noted on the western side of Manor Vale (Pls. 6 & 7). The Depot area has the appearance of being leveled.

7.13 Potential for Unrecorded Sites

7.13.1 The possibility that the Depot Site has been Leveled in the past means the potential for archaeological deposits within the Proposed Development Area is low..

8. Setting of the Heritage Assets

- The English Heritage Guidance on the Setting of Historical Assets states that "The heritage significance of places derives not only from their physical presence, but also from ... their relationship with their surroundings, particularly their setting" (English Heritage 2010, 5) and "its associations with other places, events, people or artistic representations" (ibid, 6).
- 8.2 There are no World Heritage Sites, Scheduled Monuments, Conservation Areas, Listed Buildings, Registered Battlefields or Registered Parks and Gardens within the Proposed Development Area.
- 8.3 The Proposed Development is to the north of the Tadcaster Conservation Area and the proposed development should have negligible impact on this Designated Heritage Asset. Any setting concerns could be mitigated by appropriate design. The Proposed Development will be a positive contribution to the Conservation Area in that rationalises a negative space to a more aesthetically appropriate land usage.

- 8.4 The Proposed Development does not affect the setting or significance of Scheduled Monument located on the north east of Proposed Development Area as the Designated Heritage Asset is screened by mature woodland on the side of Manor Vale (Pl. 12).
- 8.5 The Proposed Development does not affect the significance or setting of any Listed Buildings in Tadcaster.
- 8.6 The proposed Development will not affect the overall Historic Landscape Characterisation as noted on the North Yorkshire HER as the Proposed Development Area has been used as a depot.
- 8.7 The proposed Development will not affect the setting and significance of the Non-Designated Heritage Assets within the Development area as the caves are in the bank of Manor Vale.

9. Assessment of Potential Affects

- 9.1 The Proposed Development area consists of a former NYCC Depot. The depot had been levelled in the past.
- 9.2 The Proposed development has the potential to the caves, four Non-designated Heritage Assets, within the Proposed Development Area. These caves should be unaffected by the Proposed Development as they are located in the western side of Manor Vale.
- 9.3 The potential for damage to archaeological remains is assessed as low as the depot area had been levelled in the past.

10. Conclusions

10.1 The Desk Based Assessment has shown that the area is outside of the Kirkbymoorside Conservation Area, a Designated Heritage Assets and has shown that the Proposed Development does not impact on the setting and significance of the Schedule Ancient Monument to the north-east of the site.

- 10.2 The Desk Based Assessment has shown that the Proposed Development will have a negligible affects on the Non-designated Heritage Assets within the Proposed Development Area.
- 10.3 Based on the results of this Desk Based Assessment, no further archaeological work is required and there are no Cultural Heritage or Archaeological reasons to prevent development.








































Plate 1. View of Site. Facing North.




Plate 3. View of Site. Facing South.


