1.0 Introduction

- 1.1 This report sets out the results of a watching brief carried out by Scarborough Archaeological and Historical Society (SAHS) at a development site at 35 Castlegate, Scarborough. The watching brief was carried out in response to a planning condition imposed on planning decision 03/1828/FL (condition 6).
- 1.2 The site is located on the eastern side of Castlegate, in the core of the medieval Old Town. It is flanked on the south by 35 Castlegate, a mid 18th century house on stone foundations (and therefore possibly earlier).
- 1.3 The development the subject of the archaeological condition on the planning permission was the erection of a single storey garage. There was a previous approval in 1989 for the erection of a two storey extension (reference 4/10/3348/PA) which was the subject of an archaeological condition. That condition was fulfilled by an archaeological excavation which was published in 1992 (Pearson, 1992).

2.0 Aims and Objectives

2.1 The aim of the watching brief was to record any archaeological remains affected by the development and to provide an historical understanding of the site before foundation works for the new development commenced.

3.0 Methodology

- 3.1 In view of the fact that the site had previously been excavated, and the current proposals involved the re-excavation of the backfill, the watching brief took the form of machine monitoring. It was envisaged that the foundations of the new garage would be no lower than, and therefore not impinge upon, the earlier archaeological discoveries.
- 3.3 Photographic record. The photographic record comprises colour prints to record all archaeological features encountered.
- 3.4 Finds and site archive. All artefacts and the site record will be deposited with the Scarborough Museums Service in accordance with SAHS practice.

4.0 Background

- 4.1 The site lies within Scarborough's medieval town in an area defined by the County Archaeologist for planning purposes as of archaeological importance
- 4.2 The 1990-91 excavation confirmed an overall picture first glimpsed in a trial excavation of 1989 (SAHS 1989), that the site has been open ground since the middle ages. It appears that the north of the town became increasingly deserted throughout the late medieval period. Even in the middle ages, there is no firm evidence that a building stood on this site, except that a drain may have been a wall or foundation drain. A building may have stood to the east of the site, evidence being that the drains flow from this direction and the presence of tile debris across the site.

5.0 Results

- 5.1 The excavation was carried out by machine positioned on the street initially using a toothed bucket for the demolition and removal of the frontage wall, but in the critical lower stages using a toothless ditching bucket. Material was dragged towards the street from the east. The excavation was monitored from above from the top of the west facing section left from the previous excavation and a complete photographic record made of the works.
- 5.2 The material removed was found to consist of overburden re-deposited at the site following the previous excavation. At the eastern side of the site natural clay was encountered. This had previously been encountered and exposed during the 1990-91 excavation.
- 5.3 At the western (street) end of the site the backfilled trench of the previous excavation was encountered but not penetrated and the modern fill remained in place.

- 5.4 Partial collapse of the south facing section of the present excavation revealed deposits previously exposed in the 1990-91 excavation. These were interpreted as being the same as the ashy yard layers 122/129/131/133 encountered in the previous excavation. No new archaeological evidence was revealed as a result of this partial collapse.
- 5.4 The only exception to this was along the street frontage where the removal of the boundary wall revealed a 300mm wide strip of archaeology not exposed in the 1990-91 excavation. This contained 18 sherds of medieval pottery and was identified as the same as Context 126 in the 1990-91 excavation, ie no new archaeology was revealed
- 5.5 It is confirmed that the recent excavation works have not damaged insitu archaeology nor have they revealed new archaeological evidence about the site

6.0 Interpretation

6.1 The work recently carried out does not add to or change the interpretation in Interim Report 18.

7.0 Conclusion

7.1 The watching brief indicated that the foundation works did not adversely impact upon important archaeological deposits and the Planning condition my be discharged.
