Short Archaeological Report

10th February 2011 Kirkdale Archaeology

INTRODUCTION

Under the terms of its PIC call-off contract with Historic Scotland, Kirkdale Archaeology was asked to oversee the clearance of rocks from the W face of Salisbury Crags, between the two quarry sites. The loose rocks were to be removed by a three person rope team. Prior to any rocks being displaced, the area they would land in was inspected - as was the top of the hill, where anchor points for the ropes were to be hammered into the ground.

The work was carried out between 8th - 11th November 2010.




Figure 1: Location map of the works.

DESCRIPTION

During the initial walkover survey, some stones arranged in (roughly) straight lines were noted. The most prominent of these was an E/W arrangement, located to the E

of the track (003) that formed the E limit of the work area. While these were probably natural features, they were avoided when the anchor points were fixed in place.

In all, thirty-four holes were hammered into the ground, though not all were used as fixing points. The depths of the holes were recorded, and these measurements revealed the depth of the bedrock beneath the present ground surface (001) and (002).

Three sherds of white earthenware, with blue transfer printed decoration, were recovered from among the stones at the bottom of the slope. All the pottery was thought likely to date to the end of the 19th or start of the 20th century. These finds must have originated in the topsoil at the cliff edge, as they and were not present at the bottom of the slope before commencement of the work.

Sketches at a scale of 1:100 were made of the locations of the holes, and photographs were taken of the crag face, the top of the hill, and loosened rocks.

CONCLUSIONS

Whilst it is possible that there are archaeological features on the top of this part of the hill, none were positively identified, and the most promising areas were avoided when the anchors were being driven into the ground. It is therefore unlikely that this work had a significant impact on any archaeology that may survive in this area.
