

SUMMARY: A watching brief was maintained during the excavation of a trench to locate and repair a burst water main in Holyrood Park, near the tennis courts and bowling green just east of the enclosed grounds of the Palace of Holyroodhouse. 1.0 INTRODUCTION


Under the terms of its call-off contract with Historic Scotland, Kirkdale Archaeology was asked to undertake a short period of archaeological monitoring during the excavation of a trench to locate and repair a burst water main in Holyrood Park, near the tennis courts and bowling green just east of the enclosed grounds of the Palace of Holyroodhouse.


The work was undertaken on 9& 10 January 2007.

2.0 DESCRIPTION

Work had commenced late on the afternoon of the 9 January 2007 with no archaeological supervision resulting in a hole c 1.5 m by 1.5 m by 0.6 m deep. Excavation had stopped when the pipe was not found at the anticipated depth of 2′ 6″ (c 0.75 m). Work continued the following morning under archaeological supervision. Excavation was carried out using a mechanical digger. The ground condition was extremely wet; the trench was full of water with the sides of the trench continually collapsing. All observations and measurements were made from above, as it was not possible to enter the trench due to health and safety constraints.

Beneath 200 mm-250 mm of turf and topsoil (101) was a 1.00 m - 1.20 m thick deposit of mottled, grey/orange brown, silt (102), containing chunks of sandstone and bricks. Beneath this was a mid-brown/grey, silty clay (107), not fully excavated. The top of a 250 mm diameter cast iron pipe (105) was located at a depth of approximately 1.65 m. This sat within a cut (104) which was not clearly defined and never fully exposed to its base but which appeared to be a 'U'-shaped cut through silty clay (107). This








Fig. 1: Plan (1:800) showing location of excavation

cut had two fills other than the pipe; the first was a brown silt (103) similar to (102) but due to the leak this context was removed as sludge. The second fill was a brick plinth (106) beneath the pipe, one course deep by one course wide, formed from bricks 300 mm long at least (brick may be broken) by 200 mm x 200 mm.

At this point the trench was 1.90 m deep by 2.50 m E-W by 3.60 m N-S. The contractors located a split in the pipe and fitted a collar around the split. However, water continued to leak in to the trench. The trench was then extended to the E in order to locate the second break, 2.00 m deep by 3.30 m E-W by 5.20 m N-S. Once the second break had been located, the contractors decided to remove the section of pipe containing both the first and second leak and replace it with a new plastic section. The removed section of cast iron pipe was left in the trench beside the new pipe.

3.0 INTERPRETATION AND OBSERVATIONS

The pipe was found at a depth of 1.65 m - about twice the anticipated depth. There was no evidence to suggest that the general ground surface has been raised since the pipe was laid (most likely early 20th century or late 18th century) and it can be assumed that the previously recorded depth was incorrect.

There were no finds or features of archaeological significance.
