INTRODUCTION




Figure 1: Plan showing the location of Newark Castle, and the area of works. Inset No. 2 © Crown copyright. All rights reserved 2012. Licence number 100036933.

Under the terms of its PIC Call-Off contract with Historic Scotland, Kirkdale Archaeology was asked to undertake an archaeological watching brief at Newark Castle during the excavation of a trench to house a new information board. The trench was located on the E side of the path running N from the modern gated entrance (Fig.1).

A pre-existing sign had to be removed in order to insert the replacement one; as such the footprint of the new sign was already disturbed - but there was some concern that the barmkin wall would be revealed or disturbed by the current works. In the event, the location

of the trench laid outwith the N/S stretch of the barmkin, which originally bonded directly to the SW corner of the gatehouse. The layers exposed within the trench were shown to be the product of modern levelling and landscaping.

The excavation was carried out manually by Historic Scotland staff under archaeological supervision, and took place on 16th August 2012.

DESCRIPTION

Trench 1

Trench 1 sat on the grass 2.67 m N of the stone perimeter wall bounding the S side of the current lawn to the S of the castle. The trench measured 0.6 m N/S x 0.6 m E/W x 0.5 m deep. The turf and light-brown silty clay topsoil **101** was clearly a landscaping layer, 0.3 m deep, and lay over a layer of gritty black ashy industrial debris **102**, mixed with pieces of modern glazed tiles, only partially exposed to a depth of 0.2 m. Nothing of archaeological interest was noted during the works.

CONCLUSIONS

Although nothing of archaeological interest was uncovered during this particular period of work, the sensitive nature of the site and its high archaeological potential suggests that any further ground-breaking works should be similarly accompanied by an archaeological watching brief.
